<ul style="list-style-type: none"> <li>▪ Remove the magazine</li> <li>▪ Lock slide back</li> <li>▪ Visually/physically inspect chamber</li> <li>▪ Load dummy round into magazine</li> <li>▪ Insert magazine into magazine well</li> <li>▪ Manipulate slide/charge firearm</li> <li>▪ Remove magazine</li> <li>▪ Visually inspect chamber to reveal round</li> <li>▪ Eject round/lock slide back</li> <li>▪ Apply safety/if applicable</li> </ul>	<ul style="list-style-type: none"> <li>▪ Open the cylinder</li> <li>▪ Visually inspect each chamber</li> <li>▪ Load one dummy round into chamber</li> <li>▪ Rotate cylinder so round is next to fire</li> <li>▪ Close cylinder</li> <li>▪ Open cylinder and eject round</li> <li>▪ Visually inspect each chamber</li> </ul>

*This demonstration should be conducted with a dummy round or expended cartridge*

### III. Qualification Course of Fire:

▪ 1	3	Double Taps	3 sec.	3 rep.	6

*A passing score is all rounds within the 7 ring on a B-27 target or equivalent*

*The applicant must demonstrate the ability to safely handle, reload, and draw the weapon from the carried position.*
