	Further, I hereby specifically agree to indemnify and hold harmless the City of Montclair and the Montclair Police Department and/or its officers and employees from any and all liability resulting from my carrying and/or use of any weapon allowed under the Law Enforcement Officers Safety Act.								
	I specifically authorize the City of Montclair Administrative Services Division and the Montclair Police Department to release any and all protected information including medical information they may possess, as it may relate to my application under 18 USC 926C as a qualified retired law enforcement officer. 	6C DEFINES A "QUALIFIED RETIRED LAW ENFORCEMENT OFFICER" AS AN INDIVIDUAL WHO:
(INITIAL)	
	Separated from service in good standing with a public agency as a law enforcement officer, other than for reason of mental disability.
	Before such separation from service, was authorized by law to engage in or supervise the prevention, detention, investigation, or prosecution of; or the incarceration of any person for any violation of law; and had statutory powers of arrest.
	Before such separation was regularly employed as a law enforcement officer for an aggregate of 10 years or more, or separated from service with such agency after completing any applicable probationary period of such service due to a service-connected disability, as determined by such agency.
	Has not been officially found by a qualified medical professional employed by the agency to be unqualified for reasons relating to mental health.
	Has not entered into an agreement with the agency from which the individual is separating from service in which that individual acknowledges he or she is not qualified under this section for reasons relating to mental health.
	Will not be under the influence of alcohol or another intoxicating or hallucinatory drug or substance at any time while carrying a firearm and is not a habitual user of same.

MONTCLA	IR POLICE DEPARTMENT QUALIFICATION STANDARDS:
	The <i>Montclair Police Department Retiree Handgun Qualification Form</i> outlines the Department's standards for qualification in firearms training. Applicants may complete the qualification process at the Montclair Police Department at no charge. The Montclair Police Department will only issue the certification of firearms qualification for examinations conducted by a <i>Department Approved Firearms Instructor</i> . The certification sticker issued by the Department is valid for 12-months from the date of firearms qualification.

DEPARTMENT APPROVED FIREARMS INSTRUCTOR DEFINED:

A "Department Approved Firearms Instructor" must meet at least one of the following criteria:

- 1. A person currently employed by a California law enforcement agency as a Firearms Instructor or Rangemaster who has completed a Firearms Instructor Course certified by the State of California Commission on Peace Officer Standards and Training (POST).
- 2. A person currently employed by a law enforcement agency as a Firearms Instructor or Rangemaster for a law enforcement agency within the state in which the qualified retiree resides, who has completed a Firearms Instructor Course certified by the entity responsible for the regulation of peace officer training in that state.
- 3. A person certified by the National Rifle Association (NRA) as a Law Enforcement Instructor, Rangemaster, or Training Counselor who is currently employed in that capacity.

OBTAINING REQUIRED FORMS:

In addition to this form, the following forms may be obtained by contacting the Administrative Secretary at (909)448-3601.

- 1. *Montclair Police Department Retiree Handgun Qualification Form:* For qualified retired officers applying for a CCW endorsement or LEOSA certification (includes MPD course-of-fire).
- 2. **Retired Officer Petition for CCW Endorsement-California:** For qualified retired peace officers required to petition the Department for renewal of a CCW endorsement under California law (PC 26300).

Applicants qualifying at the Montclair Police Department must bring a supply of ammunition for each firearm used.
