I understand I will be required to show proficiency in the safe handling and firing of my weapon under the direct supervision of a <i>Department Approved Firearms Instructor</i> as defined on the following page.								
I understand in order to maintain a "CCW Approved" endorsement on my retired identification card, I must:								
Qualify every five years with the authorized firearm at a course approved by the Department.								
Remain subject to all applicable department rules and policies, as well as all federal, state, and local laws.								
☐ Carry only a concealed firearm inspected and approved by a <i>Department Approved Firearms Instructor</i> .								
I understand when carrying a concealed firearm, I must be in possession of a "CCW Approved" photographic identification card, issued by the Montclair Police Department that states I am a retired law enforcement officer.								
I AM NOT PROHIBITED BY ANY STATE OR FEDERAL LAW FROM RECEIVING OR POSSESSING A FIREARM.								
I will not be under the influence of alcohol or another intoxicating or hallucinatory drug or substance at any time while carrying a firearm, and I am not a habitual user of same.								
I agree to indemnify and hold harmless the City of Montclair and the Montclair Police Department, or its agents and employees, for any injury suffered by me or caused by my participation in this qualification process.

Retired Officer CCW Endorsement Qualification Procedure (§220.3.1)

In order to fulfill the requirements of the qualification process for a "CCW Approved" endorsement, the requesting retiree shall submit to the Chief of Police:

- a. A completed and signed Montclair Police Department "Retired Officer Petition for CCW Endorsement-California" form; and
- b. A completed "Montclair Police Department Retiree Handgun Qualification Form," signed by a Department Approved Firearms Instructor, attesting to the following:
 - 1. The firearm to be carried concealed is of good quality, is in good condition, and can be carried safely by the retiree.
 - 2. The retiree has demonstrated proficiency in the safe handling of the firearm.
 - 3. The retiree has passed the Qualification Course of Fire as required on the form.

OBTAINING REQUIRED FORMS:

In addition to this form, the following forms may be obtained by contacting the Administrative Secretary at (909)448-3601.

- 1. *Montclair Police Department Retiree Handgun Qualification Form:* For qualified retired officers applying for a CCW endorsement or LEOSA certification. This form must be completed by a "*Department Approved Firearms Instructor*".
- Law Enforcement Officers Safety Act-Retired Officers Application and Certification to Carry a Concealed Firearm
 Under Federal Law: Required for active or retired peace officers intending to carry a concealed firearm outside of
 California.

Applicants qualifying at the Montclair Police Department must bring a supply of ammunition for each firearm used

Department Approved Firearms Instructor Defined

As used in this section, a "Department Approved Firearms Instructor" must meet at least one of the following criteria:

- 1. A person currently employed by a California law enforcement agency as a Firearms Instructor or Rangemaster who has completed a Firearms Instructor Course certified by the State of California Commission on Peace Officer Standards and Training (POST).
- 2. A person currently employed by a law enforcement agency as a Firearms Instructor or Rangemaster for a law enforcement agency within the state in which the qualified retiree resides, who has completed a Firearms Instructor Course certified by the entity responsible for the regulation of peace officer training in that state.
- 3. A person certified by the National Rifle Association (NRA) as a Law Enforcement Instructor, Rangemaster, or Training Counselor who is currently employed in that capacity.
