VI. PUBLIC COMMENT

A. Mr. Jordan Rinker, 5195 Evart Street, Montclair, expressed his opposition to the City's recognition of June as Pride Month and celebrating the LGBTQ+ community, arguing their lifestyles go against science and his religion.

Mayor Dutrey stated Montclair is a diverse community and the City Council represents and supports all its members regardless of age, sex, gender, religion, national origin, and race.

B. Ms. Bobbie Butts introduced herself as the new Community Liaison for I-10 Towing & Recovery, which services the local community, including Montclair. She advised the company's previous owner passed away three months ago.

Mayor Dutrey wished his condolences on the former owner's passing and welcomed **Ms. Butts**. He received confirmation that **I-10 Towing** & Recovery is contracted by **Caltrans** and the **San Bernardino County Transportation Authority** for towing on the freeways.

Council Member Johnson thanked **Ms. Butts** for coming and invited her to join the **Montclair Chamber of Commerce** for additional opportunities to get involved and partner with the business community.

Mayor Pro Tem Ruh asked if **Ontario-Montclair School District (OMSD)** assists with the cost of crossing guards.

City Manager Starr advised **OMSD** and the City of Ontario split the cost with the City for one crossing guard on Benson Avenue, which is on the boundary of Montclair and Ontario and serves students of two nearby **OMSD** schools.

Mayor Pro Tem Ruh stated **OMSD** needs to be more proactive with educating its students' parents about how to safely drop their children off including not letting them get out of the car street-side, following traffic laws, and not speeding. Council Member Lopez asked if crossing guards can be stationed at all middle schools to prevent more tragedies like the one that happened at **Vernon Middle School.**

Mayor Pro Tem Ruh emphasized the need for the City to transition to demand lights, which are timed based on current traffic conditions and improve traffic flow. He suggested the City's traffic signal operations provider consider implementing such a method.

Council Member Johnson asked what differentiates commercial cannabis sales from normal retail sales for taxing purposes.

City Manager Starr advised that taxing the sale of cannabis in California is authorized under a separate law as an excise tax, whereas retail sales are taxed as a Bradley-Burns sales tax.

Mayor Dutrey advised this item would return for City Council consideration on July 18th, following a Council Workshop presenting the results of a community survey regarding commercial cannabis.

XI. COMMUNICATIONS

A. Department Reports

1. Police Department — Planned Response to Fireworks

Executive Director of Public Safety/Police Chief Avels stated the Department has taken several steps in preparation for this year's illegal firework enforcement detail, including sending advisory letters to prior and suspected offenders, advertising on social media, deploying the Department's mobile electronic message sign, using inserts in City bill mailers, and placing yard signs throughout medians in the City. He noted Lieutenant Michel has also added a QR code to the flyer that, when scanned, leads to the online firework reporting website. He advised that so far there have only been 13 fireworks reported compared to the 47 reports received around this time last year. He added patrols of the City will be increased the week leading up to July 4th, with four additional units patrolling on the holiday itself.

Council Member Johnson asked what the phone number is shown on the yard signs.

Chief Avels advised it is the Police Department's nonemergency dispatch number.

City Attorney Robbins requested the City Council meet in closed session concerning the following:

C. City Manager/Executive Director

City Manager/Executive Director Starr advised that on the week of June 27th, a black ranger helicopter will be flying over the city testing for methane gas on behalf of **Southern California Gas Company**. He added the City will put out social media posts to notify residents.

D. Mayor/Chair

1. Consider Making Appointments to Four (4) Scheduled Vacancies on the Community Activities Commission (CAC) for Full Four-Year Terms Ending June 30, 2026

Mayor Dutrey stated six applications were received for the four vacancies on the Community Activities Commission, four of which from current Commissioners seeking reappointment. One applicant withdrew and the remaining five applicants were interviewed by the CAC Panel, consisting of Mayor Pro Tem Ruh, Council Member Martinez, and CAC Chair Wells on June 9th, and has recommended the four incumbents for reappointment.

Mayor Dutrey nominated the applicants recommended by the CAC Panel for reappointment to the four scheduled vacancies on the CAC.

Moved by Mayor Pro Tem Ruh, seconded by Council Member Johnson, and carried unanimously 5-0, the City Council reappointed **Richard Escalante**, **Darlene Ferraro**, **Laurie Milhiser**, and **Rosa Rangel** to full four-year terms on the CAC ending June 30, 2026.

2. Notice of Special Meeting of the City Council and Montclair Housing Corporation Board on Tuesday, June 28, 2022, at 6:30 p.m. in the City Council Chambers to Consider Adoption of the Fiscal Year 2022-23 City and MHC Budgets

Mayor/Chair Dutrey announced the City Council and Montclair Housing Corporation will hold a special joint meeting to adopt their respective annual budgets and take other related actions.

3. Notice of Cancellation of July 5, 2022 Regular Joint Meeting

Mayor/Chair Dutrey announced the July 5th regular joint meeting is cancelled and the next regular meeting will be on Monday, July 18, 2022.

- 4. Mayor Dutrey made the following comments:
 - (a) He requested tonight's meeting be adjourned in memory of his father, who passed away at the age of 97. He stated his father worked in dairy, landscaping, and hotel management. He added his father instilled in him pride in his family's Basque heritage, and inspired him to go into politics.

- (b) He expressed his sadness about the recent shooting deaths of two El Monte police officers.
- (c) He announced a new COVID-19 testing site has opened at the **Christian Development Center** on Mondays, Wednesdays, and Fridays.
- (d) He noted yesterday was notable for celebrating two things—Father's Day and the newly recognized national holiday, Juneteenth, which commemorates the day an Army officer informed slaves in Texas about the signing of the Emancipation Proclamation.
- (e) He stated since the July 5th meeting would be cancelled, he would like to recognize the following upcoming holidays and days of celebration in July: Canada Day on July 1st, Independence Day on July 4th, Bastille Day celebrated in France on July 14th, and National Parents Day observed on July 24th.
- (f) He congratulated **Metro Auto Group** on its new digital freeway sign.

E. Council Members/Directors

- 1. Council Member/Director Johnson commented as follows:
 - (a) She attended the reveal event for the new San Bernardino County (SBC) memorial to the victims of the terrorist attack that occurred on December 2, 2015. She described how touching it was that each victim was dedicated an alcove with a bench inscribed with a quote chosen by their family.
 - (b) She stated her concern with maintaining Montclair's housing stock now that the Redevelopment Agency is no longer here to help fund efforts like the Neighborhood Partnership. She indicated Fourth District SBC Supervisor Curt Hagman has agreed to help to fund renewed efforts as long as the City can provide volunteers, and the City's Code Enforcement Team has agreed to help. She emphasized the importance of maintaining the housing stock to keep property values up and attract new businesses.
 - (c) She attended a Juneteenth celebration in Ganesha Park in Pomona, which emphasized "Liberty and Justice for <u>All</u>".
 - (d) She wished a Happy Birthday to City Attorney Robbins and Finance Manager Kulbeck.
- 2. Council Member/Director Lopez made the following comments:
 - (a) He stated last month the **Montclair Little League** finished its season and the AAA All Star games have begun.
 - (b) He expressed that Juneteenth is not just about Black independence, but independence for all. He noted it took 2.5 years for the last slave to be freed after the Emancipation Proclamation was signed. He stated slavery is one of the United States' greatest sins because all are equal.
 - (c) He noted there have been five deaths in five weeks from traffic accidents and urged everyone to slow down. He asked what residents can do to get speed bumps on their streets, noting one street residents have asked about is the sharp corner where eastbound Palo Verde Street becomes southbound Helena Avenue, which already has a flashing sign and reflective signs that aren't preventing excessive speeds and accidents.

City Manager Starr advised speed bumps are only allowed in parking lots according to the Department of Transportation Manual on Uniform Traffic Control Devices, and speed humps are only allowed on streets with speed limits lower than 25 miles per hour. He advised there is a petition process for home owners that would trigger a study to determine whether a speed hump is appropriate for the street.

(d) He asked for a report on the I-10 Freeway accident in Montclair that occurred on June 13 because he has seen a lot of misinformation online about the incident.

Chief Avels advised the California Highway Patrol is in charge of that investigation, and Montclair officers only assisted at the scene because the debris field ended up on the car dealership property in the City's jurisdiction.

(e) He asked if the alleyway behind his home on San Bernardino Street would be repaved or repaired this year.

City Manager Starr indicated it was not on this year's list.

(f) He asked if the City was hosting alleyway cleanup events.

City Manager Starr advised Code Enforcement used to host those events but has not due to staffing shortages. He noted that program may start up again soon.

- (g) He stated he prays the shooting incident that occurred in El Monte costing the lives of two law enforcement officers would never happen in Montclair.
- 3. Mayor Pro Tem/Vice Chair Ruh made the following comments:
 - (a) He condemned the person who posted photos of the I-10 Freeway accident on social media, stating it is disrespectful to the victims' families.
 - (b) He stated on June 19, 1865, Union Army General Gordon Granger arrived in Galveston, Texas to announce the signing of the Emancipation Proclamation, which was signed on January 1, 1863 and only initially applied in Union territories. He noted the Thirteenth Amendment was ratified on December 6, 1865.
 - (c) On Friday he attended the Gold Line's "halfway celebration," having completed half of the line's construction work from Azusa to Pomona. The event was well-attended by elected representatives who spoke in support of continuing the Gold Line to Montclair.
 - (d) He emphasized the seriousness of the drought, noting reservoirs are at less than 30 percent capacity.
 - (e) He stated the El Monte police officers were residents of Upland, so their deaths hit close to home. He commended **Senator Susan Rubio**, who attended the memorial service.
 - (f) He stated on Saturday he attended an event honoring Senator Rubio and Assembly Member Freddie Rodriguez, noting they show that elected officials can work together across the County line.
 - (g) He warned there is a rise in COVID-19 cases and urged everyone to be careful, noting thousands have died in San Bernardino County from the disease.
 - (h) He noted that while many complain of people driving too fast, another issue is when people drive too slow and impede the flow of traffic.
