**CALIFORNIA VEHICLE
CODE §22507(a)**

Local authorities may, by ordinance or resolution, prohibit or restrict the stopping, parking, or standing of vehicles...on certain streets or highways, or portions thereof, during all or certain hours of the day.

What Constitutes an Oversized Vehicle

“Oversized vehicles” are generally designated based upon the length, width, and/or height of a vehicle (which distinguishes it from “overweight vehicles” or “commercial vehicles”).

Typical standards:

- ▶ **Length: Exceeding between 19' to 25'**
- ▶ **Width: Exceeding between 6' to 8'**
- ▶ **Height: Exceeding between 6' to 8'**

- ▶ **Specific dimensions are based upon**
- ▶ **jurisdictional factors**

Reduced on-street parking



Decreased drivable roadway space

Options for Regulation of Oversized Vehicle Parking

- ▶ Complete ban
 - ❖ With limited exceptions
- ▶ Restricted hours
 - ❖ Eliminate overnight parking
- ▶ Restricted areas
 - ❖ Allow oversized vehicle parking in commercial or industrial areas of City
- ▶ Parking permit
 - ❖ For recreational vehicles and/or all oversized vehicles

Regulations Enacted by Neighboring Jurisdictions

FONTANA	NO OVERSIZE VEHICLE OR RV PARKING IN EXCESS OF 4 HOURS IN RESIDENTIAL ZONES	ALL RVs OVERSIZE: - 22'L or 94"W or 92"H - Height exemption for some pick-ups and SUVs	- 6/month - 72 hours
LA VERNE	NO VEHICLE PARKING IN EXCESS OF 1 HOUR BETWEEN 2AM AND 5AM	ALL VEHICLES	- RVs – 6 nights/month
POMONA	NO OVERSIZE VEHICLE OR RV PARKING BETWEEN 8PM AND 7AM 4 HOUR PARKING 7AM TO 8PM	ALL RVs OVERSIZE: 19'L x 80"W x 72"H	- 4/month or 12/year - 48 hours
RANCHO CUCAMONGA	NO OVERSIZE VEHICLE OR RV PARKING IN EXCESS OF 1 HOUR BETWEEN 2AM AND 6AM	ALL RVs OVERSIZE: 25'L x 7'W x 7'H	NO PERMITS

Regulations Enacted by Other Jurisdictions

CITY	RESTRICTION	RECREATIONAL VEHICLE PERMIT PROGRAM
Anaheim	Prohibited in entire city with limited exceptions	No Permit Program
Long Beach	Prohibited parking at all times in residential and between 2 am and 5 am in non-residential areas	<ul style="list-style-type: none"> • 20 permits/year • No more than 72 hours
Los Angeles	Prohibited parking between 2 am and 6 am	<ul style="list-style-type: none"> • No more than 3 consecutive days
San Diego	Prohibited parking between 2 am and 6 am	<ul style="list-style-type: none"> • 72 permits/year • No more than 24 hours
Santa Monica	Prohibited parking between 9 pm and 6 am	<ul style="list-style-type: none"> • 1 permit per 30-day period
Santa Barbara	Prohibited in entire City where signs posted with limited exceptions	<ul style="list-style-type: none"> • 5 consecutive days • No more than 10 consecutive days in 90 calendar days • Different permit program for contractors oversized vehicles

Ordinance

- ▶ **Complete ban of all oversized vehicles and unattached trailers at all times**
 - ❖ **All RVs**
 - Camp trailers, 5th Wheel Trailers, Motorhomes, boats, ATVs, vehicles designed and used for residential purpose
 - ❖ **Vehicles – 22'L or 8'H or 8'W**
 - Except Pick-Up Trucks (as defined by CVC)

- ▶ **Limited Exceptions**
 - ❖ **Active Loading/Unloading**
 - ❖ **Performance of a Service**
 - ❖ **Government/Public Utility Vehicle**
 - ❖ **School Bus**
 - ❖ **Emergency/Breakdown (24 Hours)**
 - ❖ **With City Temporary RV Parking Permit**

- ▶ **Parking permit for RVs**
 - ❖ **Resident's only (Can be used by resident's guests)**
 - ❖ **12 per calendar year per address/residential unit**
 - ❖ **72 hours each (with 24-hour break in between permits)**

DRAFT **Ordinance** **(Cont.)**

- ▶ **Prohibited Parking (whether exempt or with permit)**
 - ▶ **Within 100' of intersection**
 - ▶ **Within 5' of curb cut of driveway**
 - ▶ **Manner that blocks traffic lane**
 - ▶ **Manner that interferes with critical sight lines for driveway, alleys, and streets**
 - ▶ **Manner that blocks or hinders visibility of traffic control devices**
