Ms. Gray explained that as of the December 10 review of appropriations, there are appropriation changes requested to align appropriations with estimated year end expenditures. She stated there are no transfers of cash needed to balance the 2024 Budget. She added that the total reduction in all funds appropriation is \$369,763.10 and that there is an adequate fund balance in each fund to support the appropriations.

Ms. Gray explained the financial impact of the following funds:

- General Fund- Adjustments to the personnel object lines are primarily due to overtime and staffing. The decreases suggested for the non-personal object lines are due to anticipated costs in general operating projects being lower than anticipated. Some operating expenditures were reallocated in the 2025 budget.
- Special Revenue Funds- Due to the new 2024 Final Rule for ARPA funds, all funds previously set aside as a result of the 2022 Final Rule are required to be obligated by 12/31/2024. Applicable expenses from the Capital Project Fund have been reclassified to the Pandemic Relief Fund to comply with the newest Final Rule.
- Debt Service Funds-Increased Montgomery Quarter TIF taxes received necessitated the school compensation to increase as well. In addition, the issuance legal costs on our Bond Anticipation Notes were lower than expected.
- Capital Project Funds- Capital Project funds expended are lower than expected due to the reclassification of some project funds to the Pandemic relief fund to comply with the newest Final Rule for ARPA funds.
- Fiduciary Funds- Compensated Absence funds expended were slightly lower than the amounts budgeted.

All funds total appropriation budget for 2024 is reduced to \$33,855,878.90.

Mr. Suer moved passage of the Ordinance. Vice Mayor seconded.

#### PENDING LEGISLATION

## An Ordinance Establishing Compensation For Elected Officials

Mr. Dobrozsi explained that this would be the third reading of this Ordinance on this legislation that, if approved, would initiate the process to increase compensation for Council Members and the Mayor commencing January 1, 2026. He explained the Charter allows Council to set compensation for Council Members, but the compensation

cannot be increased during a Council Member's term. As a result, those Council Members elected in November 2025 will see an increase in compensation January 1, 2026, whereas those Council Members who are elected for a full term of office in November 2027 will see the increase effective January 1, 2028. Since the Mayor is appointed by Council and the Mayor's term does not commence until after the organizational meeting, the additional stipend for the Office of the Mayor will commence January 1, 2026.

Mr. Dobrozsi asked if there were updates to this legislation.

Mr. Donnellon replied there were none.

## **NEW LEGISLATION**

A Resolution of the City of Montgomery, of Ohio, Supporting the Ohio Commission for the United States Semi-Quincentennial (America250-OH)

Mayor Messer assigned the legislation to Mrs. Bissmeyer.

Ms. Henao explained that on July 4, 2026, our nation will commemorate and celebrate the 250<sup>th</sup> anniversary of the signing of the Declaration of Independence. To commemorate and celebrate the country's 250<sup>th</sup> anniversary, America 250 was created. She added that America 250 – Ohio is a commission charged with preparing the state to participate in the United States of America's 250<sup>th</sup> anniversary. It is a multi-year commemoration where Ohioans from all 88 counties will be in the spotlight of the impact Ohio's unique role in our nation's story. The effort will tell the story of Ohio, from the Native Americans to people who call Ohio home today. America 250 – Ohio is requesting assistance from communities throughout Ohio to become official America 250–OH (AM 250-OH) communities and help create exciting and engaging opportunities to celebrate and commemorate the 250th anniversary. AM 250-OH communities will receive special recognition and a designation including signage, website recognition, event promotion, resources, and connections to other AM 250-OH communities. Additionally, there is an opportunity for grant funding to assist with local activations that are supplemental to the programs that America 250 – Ohio is producing statewide.

 Ms. Henao stated that it is requested that City Council pass a Resolution supporting the initiative and Montgomery's participation in the program. Given the City's history and dedication to historic preservation and education, Staff believes that becoming an official AM 250-OH community is a natural fit and will aid in drawing more attention and visitors to the City's cherished Heritage District.

Mrs. Mills-Reynolds asked how we expect to intertwine this with our normal events and what other ways do we plan to celebrate.

Ms. Henao explained that we do anticipate conducting the same July events but on a larger scale. She added that staff are already at work brainstorming ideas and that a public art project such as a mural on a downtown business was one example.

Vice Mayor Naiman stated she thought the public art was a good idea. She added that AM250-OH would also create an opportunity to work with other jurisdictions to piggyback on each other's events.

 $\ensuremath{\mathsf{Ms}}.$  Henao confirmed that AM250-OH is a yearlong program.

Mr. Suer stated that he thought the grant was worth pursuing.

Mr. Margolis stated he thought it was a great opportunity to offer good programming.

Mayor Messer explained that this Resolution will be added to the January 8, 2025 Business Session agenda with adoption of the Resolution requested at that meeting.

A Resolution Requesting The County Auditor To Make Tax Advances During The Year 2025 Pursuant To Ohio Revised Code § 321.34

Mayor Messer assigned the legislation to Mr. Suer.

Ms. Gray explained that, if passed, this Resolution will allow the advance payment of taxes to be drawn on the undivided real estate tax fund of Hamilton County. She reminded City Council that legislation was passed to advance taxes for collection year 2024 on September 4, 2024; however, the passage of the legislation was too late to receive an advance in 2024. She explained that Hamilton County requires passage of this legislation for each collection year so this Resolution would allow for monthly payments to begin in 2025.

Mayor Messer explained that this Resolution will be added to the January 8, 2025 Business Session agenda with adoption of the Resolution requested at that meeting.

A Resolution Delegating Authority To Make Declarations Of Official Intent And Allocations With Respect To Reimbursements Of Temporary Advances During Fiscal Years 2025 And 2026 Made For Capital Improvements To Be Made From Subsequent Borrowings For The Montgomery Quarter Redevelopment Project (Formerly Known As The Gateway Redevelopment Project)

Mayor Messer assigned the legislation to Mr. Suer.

Mr. Donnellon explained that this Resolution is required by U.S. Treasury regulations to allow the City to advance certain monies for Stage II of the Montgomery Quarter Redevelopment Project. Under the terms of the current Development Agreement between the City and the Developer, it is anticipated that \$16,000,000 of new bonds will be issued for Stage II. From this bond issue the City is authorized to draw \$1,500,000 to cover the cost for Stage II construction of Public Improvements.

 Mr. Donnellon explained that some of the costs for these Public Improvements in Stage II may be advanced in 2025 and 2026 before the bonds are issued. Some of these costs may include engineering and survey work as well as construction of the streetscape. This Resolution, consistent with Treasury regulations, will authorize the City to advance funds today and to be reimbursed later for those expenditures from the Stage II bond issue. This Resolution will extend the City's right to claim reimbursement during calendar years 2025 and 2026.

Mayor Messer explained that this Resolution will be added to the January 8, 2025 Business Session agenda with adoption of the Resolution requested at that meeting.
