The meeting of the Government Affairs Committee of City Council convened in Council Chambers at 4:15 p.m., with Mr. Dobrozsi presiding.

Public Works Surplus

Mr. Riblet explained to the Committee the attached list of equipment from the Public Works department is no longer of value and staff requests that the Committee declare the list as surplus to be sold on Govdeals.com.

Mrs. Naiman made a motion to declare the list of equipment as surplus. Mrs. Mills-Reynolds seconded. The Committee unanimously agreed.

2026 Calendar Theme Discussion

Mr. Vanderhorst explained that during the 2021 City Calendar process, it was decided that the Government Affairs Committee should approve the annual calendar theme. Arts Commission Member and Sycamore High School Art Teacher, Elise Williams, asked if the theme could be chosen early in the school year to allow time for the students to complete the project. He stated that Mrs. Williams has requested that her students submit pictures of their favorite seasons or events in Montgomery. He added that Mrs. Williams believes students who submit their own photos will be more invested in the art project. The students will be able to choose the scenes, the backgrounds or objects that they best excel at painting. Therefore, the proposed theme for 2026 is 'The City of Montgomery through our Young Artists' eyes'. Mr. Vanderhorst added the Calendar Team will review all the photos and approve or substitute new ones before the artwork begins.

Mrs. Naiman stated the importance of having diversity in the pictures.

Mrs. Mills-Reynolds suggested that each student submit two pictures to ensure there are enough to choose from.

Mr. Riblet stated that he would like to see the selections displayed somewhere at the Montgomery Quarter.

Mr. Mills-Reynolds made a motion to accept staff's proposed recommendation of the theme for the 2026 calendar. Mrs. Naiman seconded. The Committee unanimously agreed.

Neighborhood Sycamore Bridges Service to the Community Grant Award Update

Mr. Vanderhorst explained that the Committee previously approved the award of a Service to the Community Grant to Neighborhood Sycamore Bridges in the amount of \$1,500 to be used towards the supplies for a Calming Room at Sycamore High School.
