- 2. Three copies of detailed site plan, drawn to scale. Site plans should include the following information:
 - a. All lot lines with dimensions.
 - b. Designation of all right-of-ways.
 - c. Designation of any and all easements pertaining to the property or directly abutting the property.
 - d. North arrow and scale.
 - e. Any other pertinent data as may be required by the Public Works Director to determine and provide for the enforcement of standards of the City of Montgomery.
- 3. Application fee.
- 4. A pre-construction meeting, when requested by the Public Works Director, to discuss and/or clarify plans submitted for review.

If applicable, upon approval of the right-of-way permit, the City will notify the applicant of the amount of any right of way maintenance and repair bond for the value of public improvements in the right of way that may be damaged during construction and a cash bond for street and sidewalk cleaning. All bonds shall be paid prior to the issuance of permit.
