

ORDINANCE NO. 16, 2019

AN ORDINANCE ACCEPTING A BID AND AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH JOHN R. JURGENSEN COMPANY FOR THE MONTGOMERY ROAD AND RONALD REAGAN CROSS COUNTY HIGHWAY MULTI-LANE ROUNDABOUT PROJECT, AND DECLARING AN EMERGENCY

WHEREAS, the City has advertised for bids for the HAM- SR126/US 22- 20.00/13.19, the Montgomery Road and Ronald Reagan Cross County Highway Multi-Lane Roundabout Project, PID #104936; and

WHEREAS, the City has received a bid from the John R. Jurgensen Company which the Administration has determined to be the lowest and best bid, and which the Administration recommends Council accept; and

WHEREAS, this project has been approved for funding by the Ohio-Kentucky-Indiana Regional Council of Governments in cooperation with the Ohio Department of Transportation and Hamilton County Transportation Improvement District; and

WHEREAS, to formally approve such contract, consistent with the requirements for this public improvement project, it is necessary to approve this contract as an Ordinance, and as an emergency to be able to meet the timing requirements of the bid and the federal and state budgetary requirements to commence this significant roadway improvement project.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Montgomery, Hamilton County, Ohio, that:

SECTION 1. The bid received from the John R. Jurgensen Company for the HAM- SR126/US 22- 20.00/13.19, the Montgomery Road and Ronald Reagan Cross

County Highway Multi-Lane Roundabout Project, PID #104936, submitted in the amount of \$7,344,556.65, with Alternates 1 and 2 in the amount of \$28,600.00, is hereby determined to be the lowest and best bid received in response to an advertisement for the same.

SECTION 2. The bid is hereby accepted and the City Manager is authorized and directed to enter into a contract in accordance with the terms described in the specifications up to the total amount of \$7,750,000.00 which would include the proposed Alternates and an appropriate contingency approved for any unexpected additional construction costs. Further, the City Manager is authorized to execute any additional documents necessary to accept and process grant funding for this project and to support construction for the proposed roadway improvement project.

SECTION 3. To be able to timely accept this bid consistent with the requirements of the bid response and the budgetary requirements of the state and federal government, this Ordinance is hereby determined to be an emergency measure necessary for the public health, safety and welfare to implement these public roadway improvements, and therefore this Ordinance is determined to be an emergency measure and shall take effect immediately upon passage.
