ORDINANCE NO. 5 . 2019

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO DEDICATE CERTAIN PORTIONS OF CITY OWNED PROPERTY AS RIGHT-OF-WAY FOR THE RONALD REAGAN HIGHWAY/MONTGOMERY ROAD INTERCHANGE MODIFICATION

WHEREAS, the City is undertaking a project in cooperation with the Ohio Department of Transportation to modify the Ronald Reagan Highway/Montgomery Road interchange by constructing a round-a-bout at the interchange; and

WHEREAS, as a part of this project, the City has updated its survey of right-of-way and requires additional right-of-way to be dedicated along Montgomery Road upon property owned by the City across multiple Auditor's parcels in a total area encompassing approximately 0.3661 acres as depicted and more fully described upon Exhibit A-1 and Exhibit A-2 attached hereto; and

WHEREAS, it is the intent of this Ordinance to authorize the City Manager to execute documentation necessary to dedicate such additional land as will be necessary for the roadway project; and

WHEREAS, it is the further intent of this Ordinance to accept this dedicated right-of-way for the purposes of these proposed and any future public improvements.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Montgomery, Hamilton County, Ohio, that:

SECTION 1. The City Manager is hereby authorized to execute a Dedication Plat and any other documentation necessary to dedicate right-of-way along Montgomery Road, as more particularly described in Exhibits A-1 and A-2 attached hereto.

SECTION 2. The expanded right-of-way as depicted on the attached Exhibits A-1 and A-2 is hereby accepted by the City and shall continue to be dedicated for public use consistent with the terms of all right-of-way dedication.

SECTION 3. This Ordinance shall take effect the earliest opportunity as allowable by law.
