15 City Council convened its Special Session for February 15, 2021 at 3:00 p.m. as a hybrid meeting at City Hall and  
16 also by teleconference with Mayor Dobrozsi presiding. This remote access meeting was allowed by emergency  
17 legislation adopted by the Ohio General Assembly and approved by the Governor. The emergency legislation added  
18 language to RC Section 121.22 allowing public meetings by telephone conference during the current pandemic and  
19 declared State of Emergency. As required by the statute, notice of the telephonic meeting was publicized more than  
20 24 hours in advance to allow public access through the same conference call in service. The public was also given a  
21 backup number to call in the event there were technical difficulties. This Notice was posted on the City's website and  
22 a similar Notice was sent to The Cincinnati Enquirer.

24 Mayor Dobrozsi asked for a roll call.

35 is anticipated there will be no further discussion once City Council came back into Public Session at the conclusion  
36 of the Executive Session.

41 Mr. Cappel moved to adjourn into Executive Session for matters related to the appointment of an elected official.
