(Question 1) “All things considered, how satisfied are you with the quality of life in the City of Montgomery?”

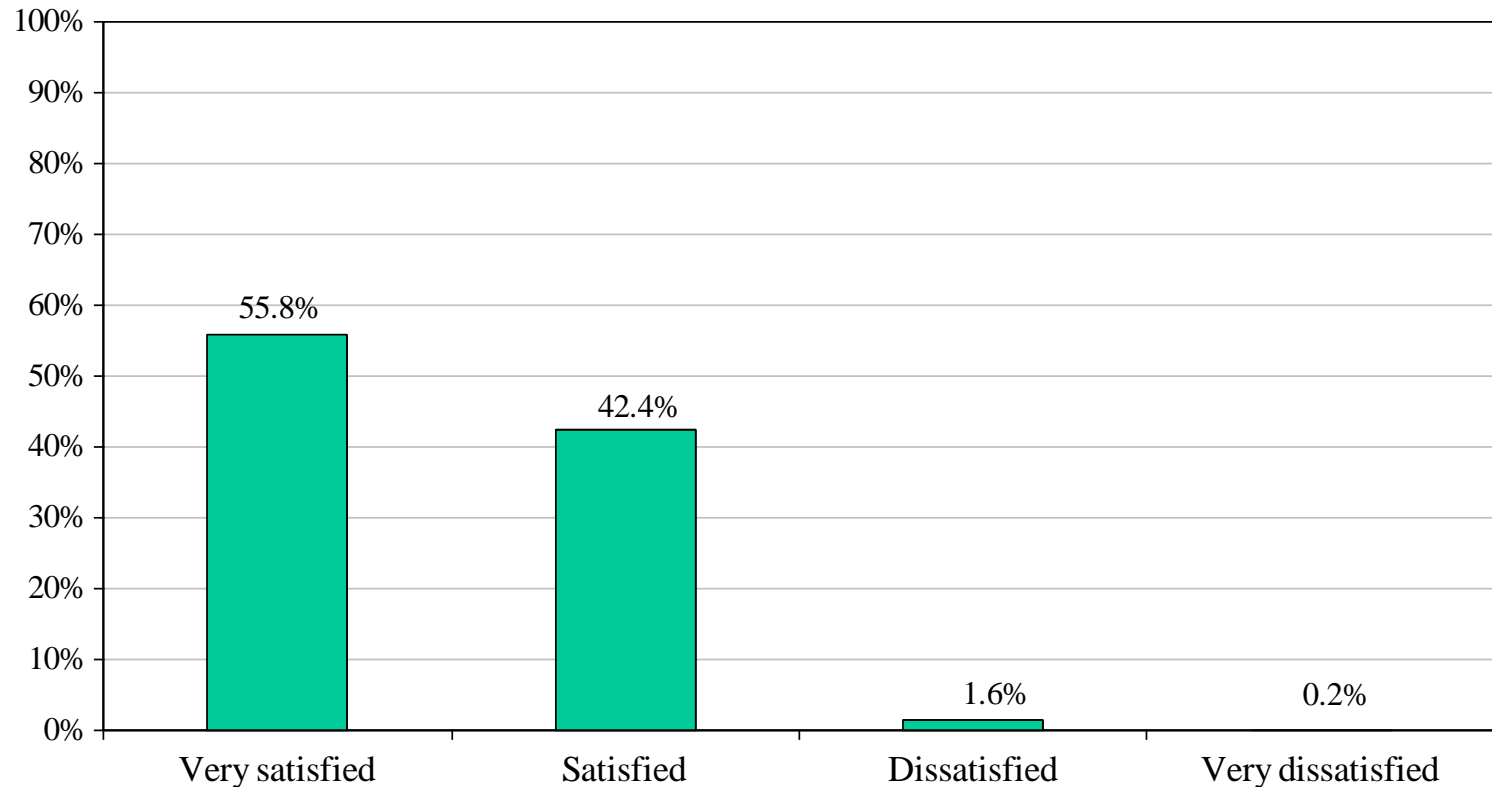

(Question 1) “All things considered, how satisfied are you with the quality of life in the City of Montgomery?”

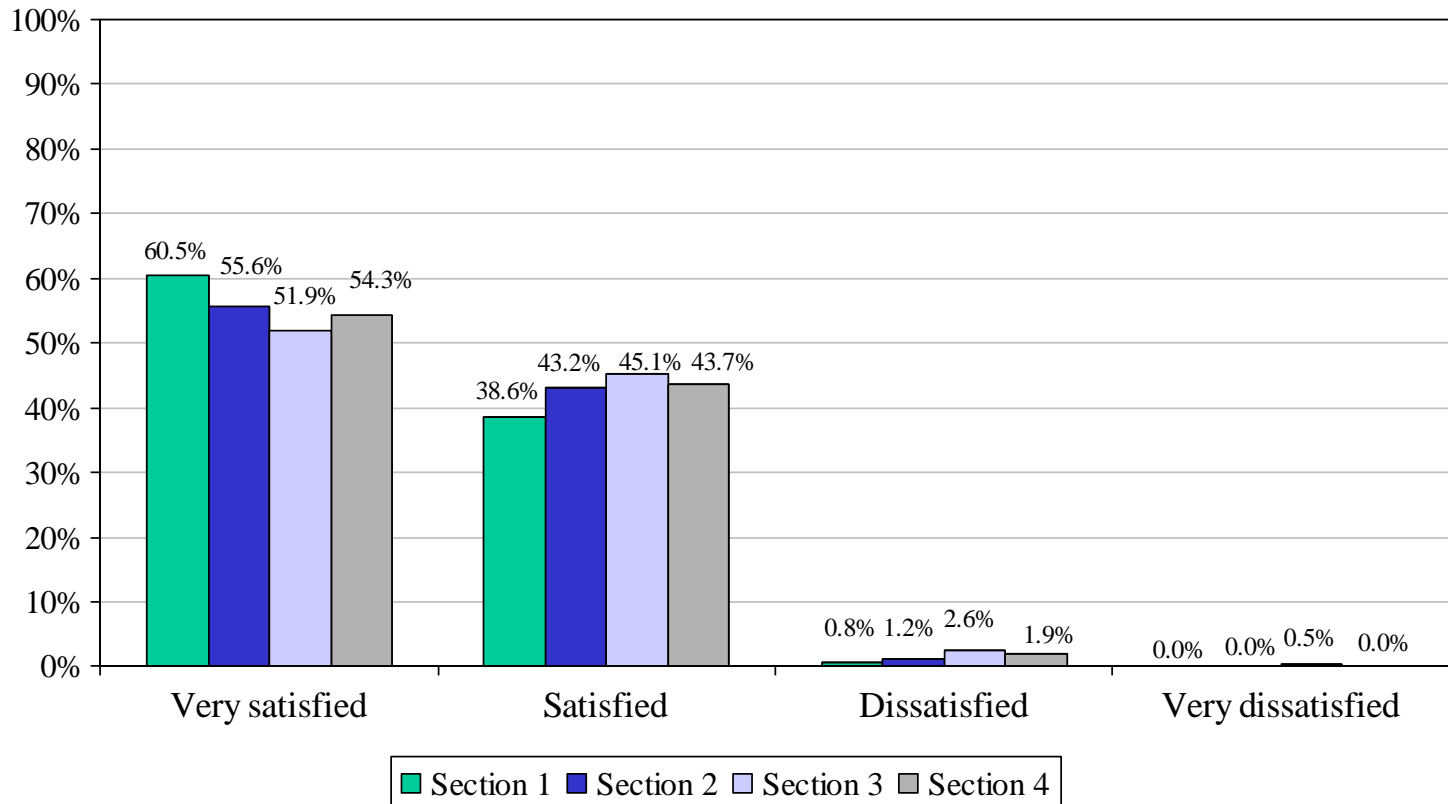

(Question 1) “All things considered, how satisfied are you with the quality of life in the City of Montgomery?”

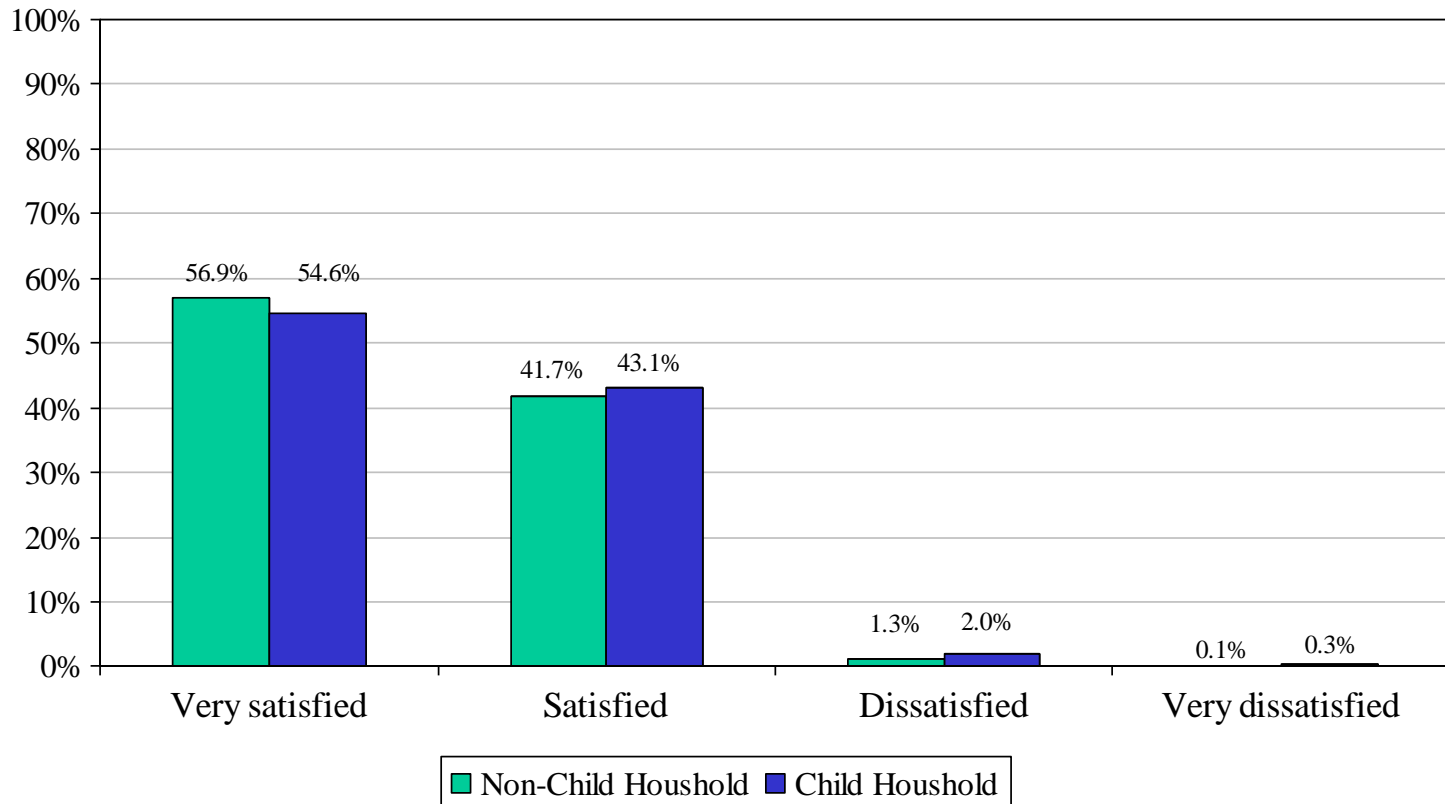

(Questions 5a-5j) Importance of City Services (Percent “Extremely Important”)

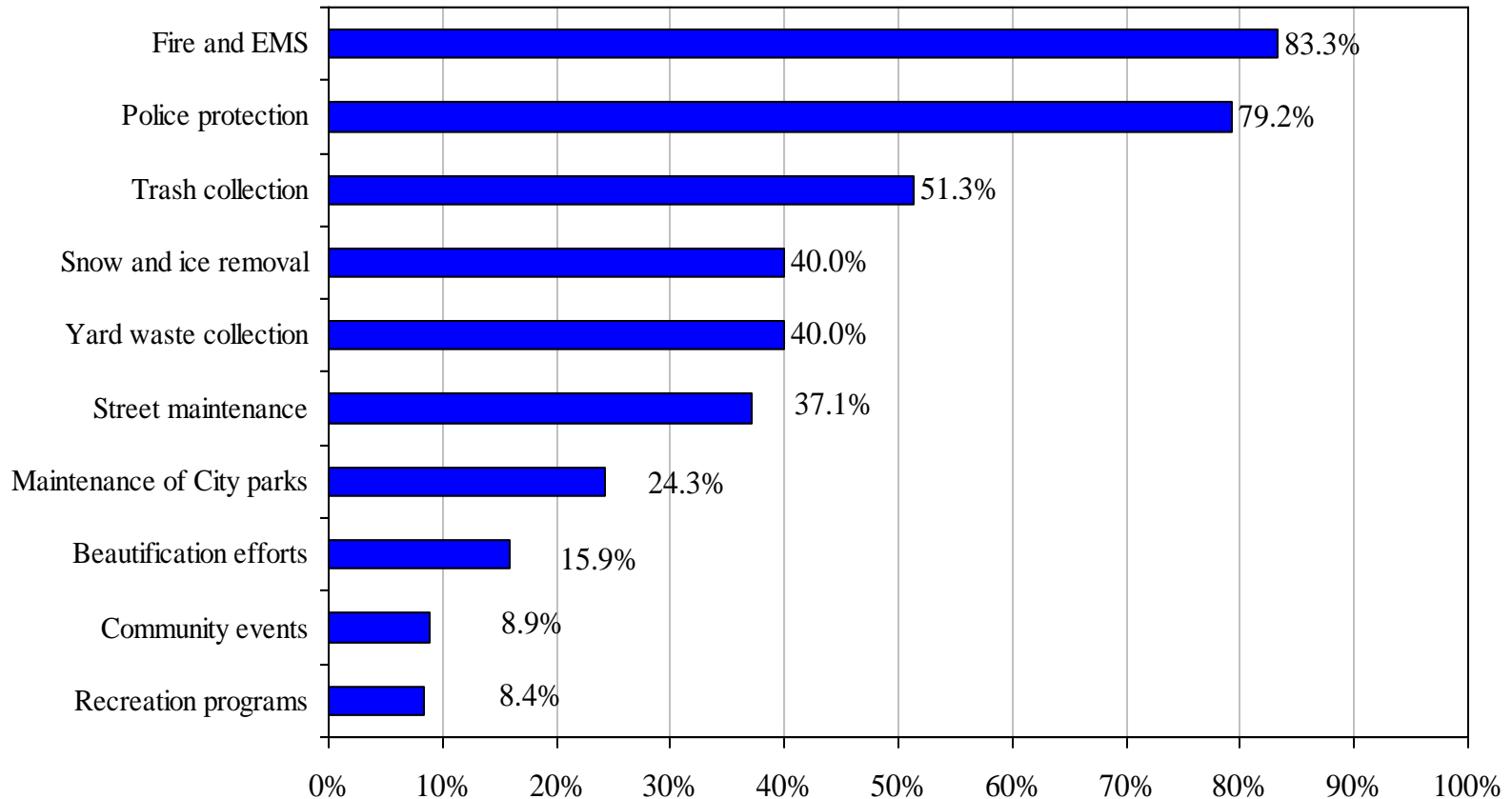

(Questions 6a-6j) Satisfaction with City Services (Percent “Very Satisfied”)

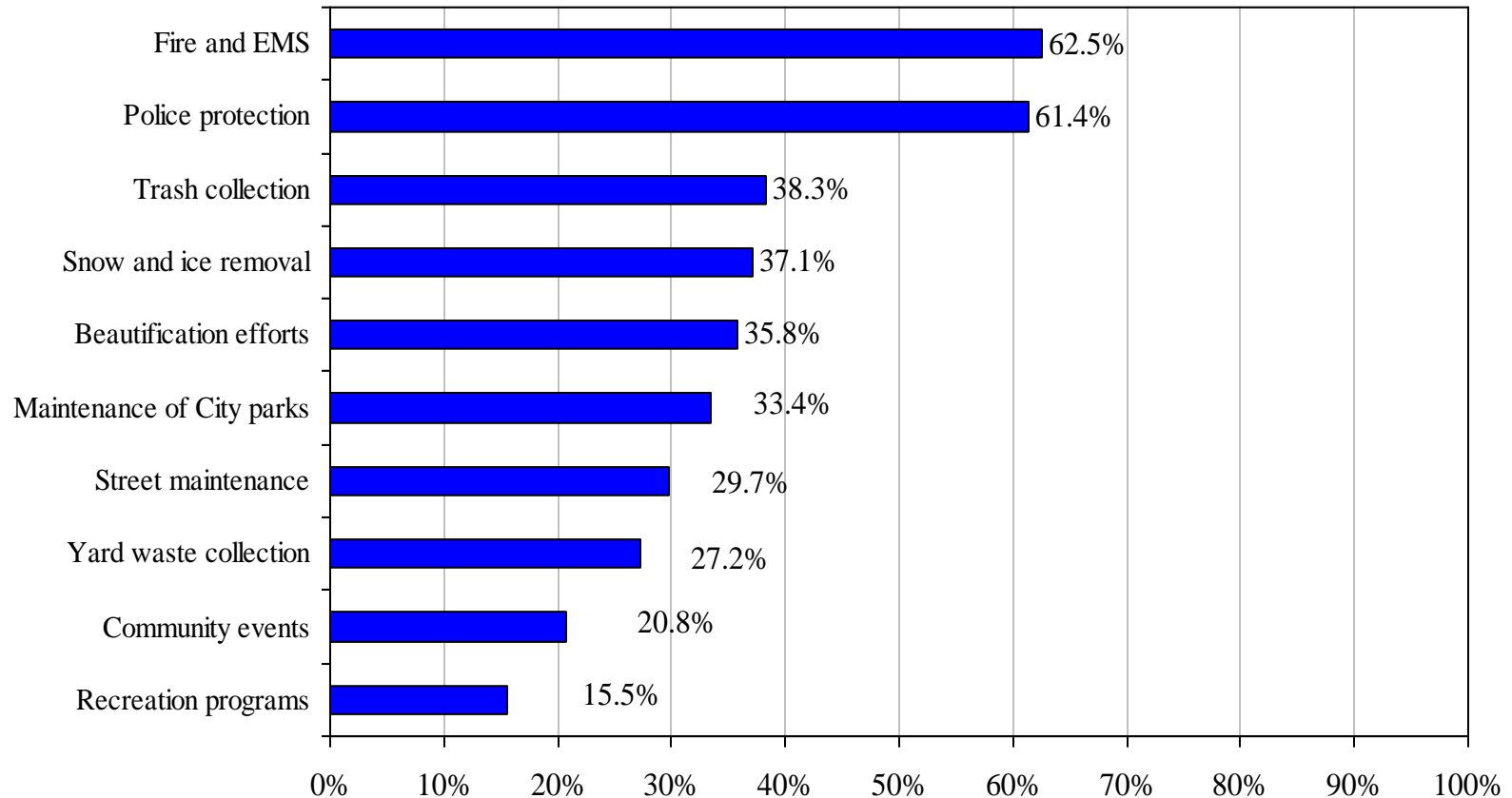

(Questions 6a-6j) Satisfaction with City Services (Percent “Very Satisfied” or “Satisfied”)

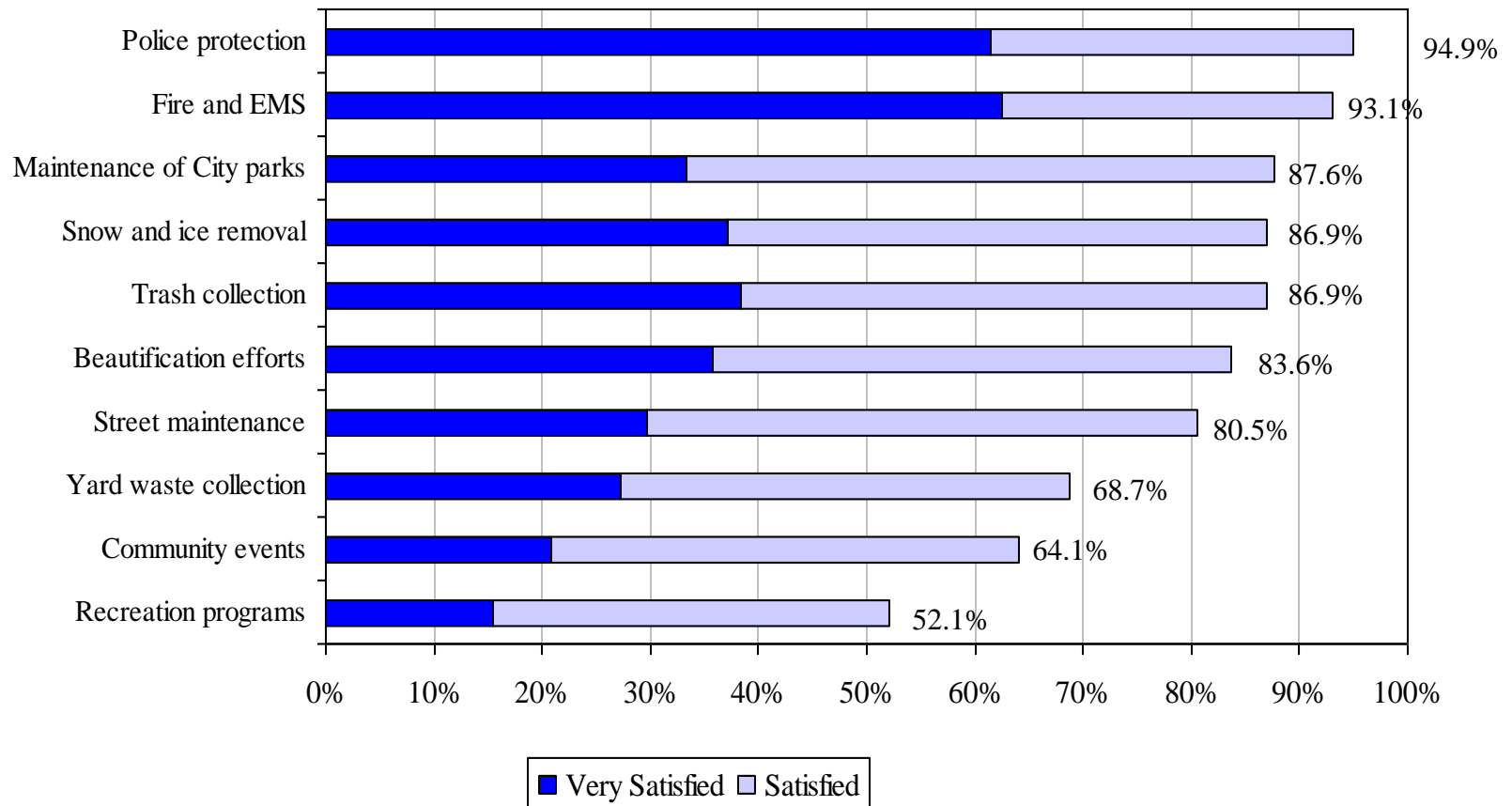

(Question 6a) Satisfaction with Police Protection in Neighborhood

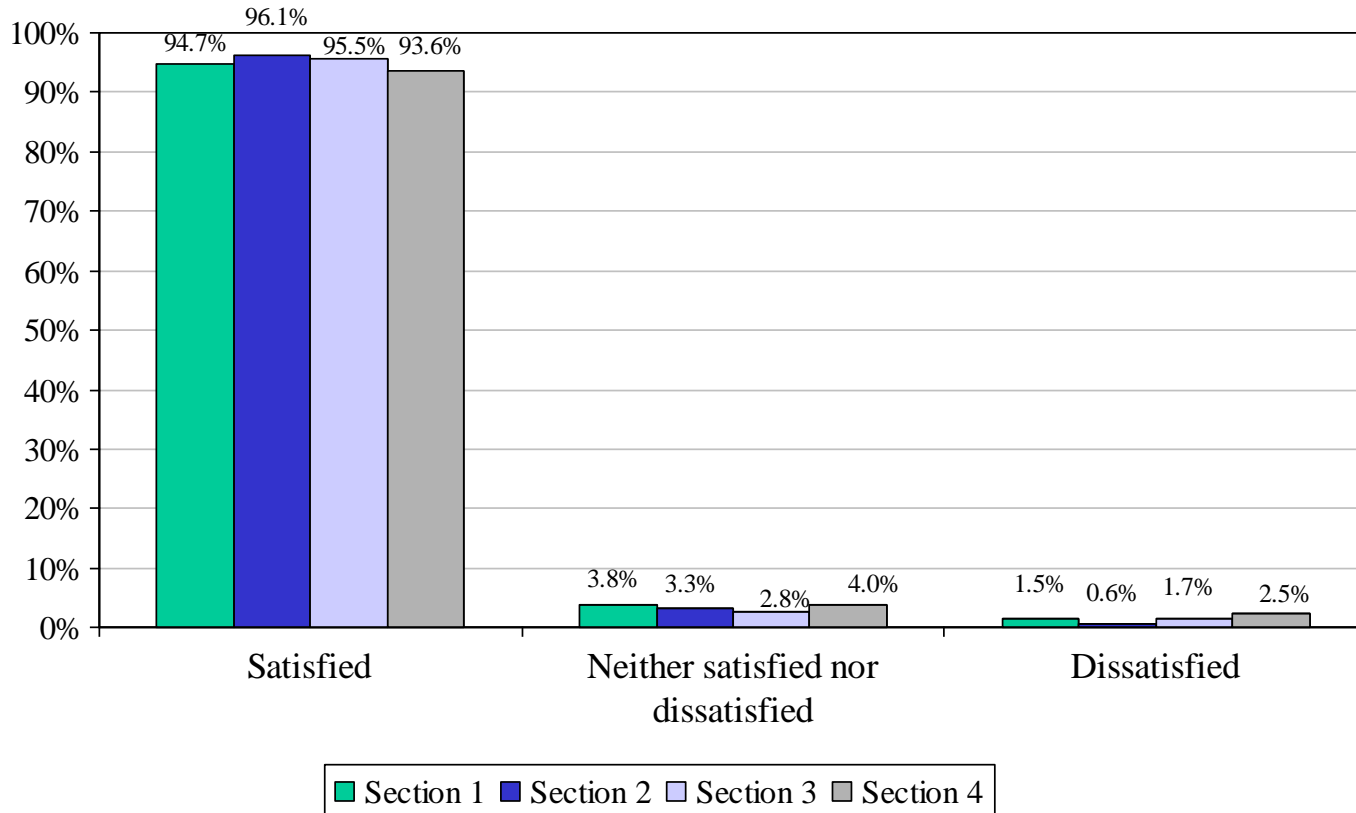

(Question 6b) Satisfaction with Fire and Emergency Medical Services

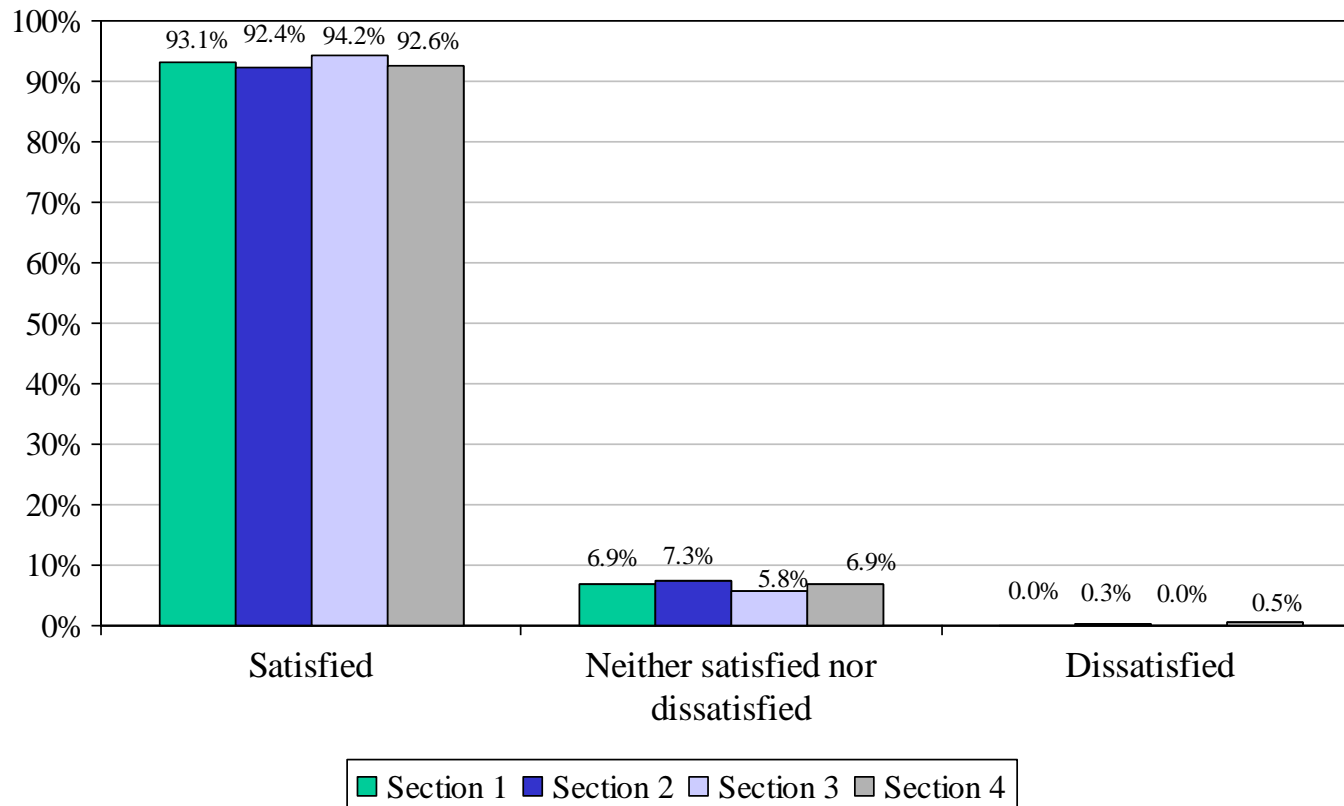

(Questions 6a-6j) Mean Satisfaction with City Services (Services with an Importance Mean of 4 or Higher)

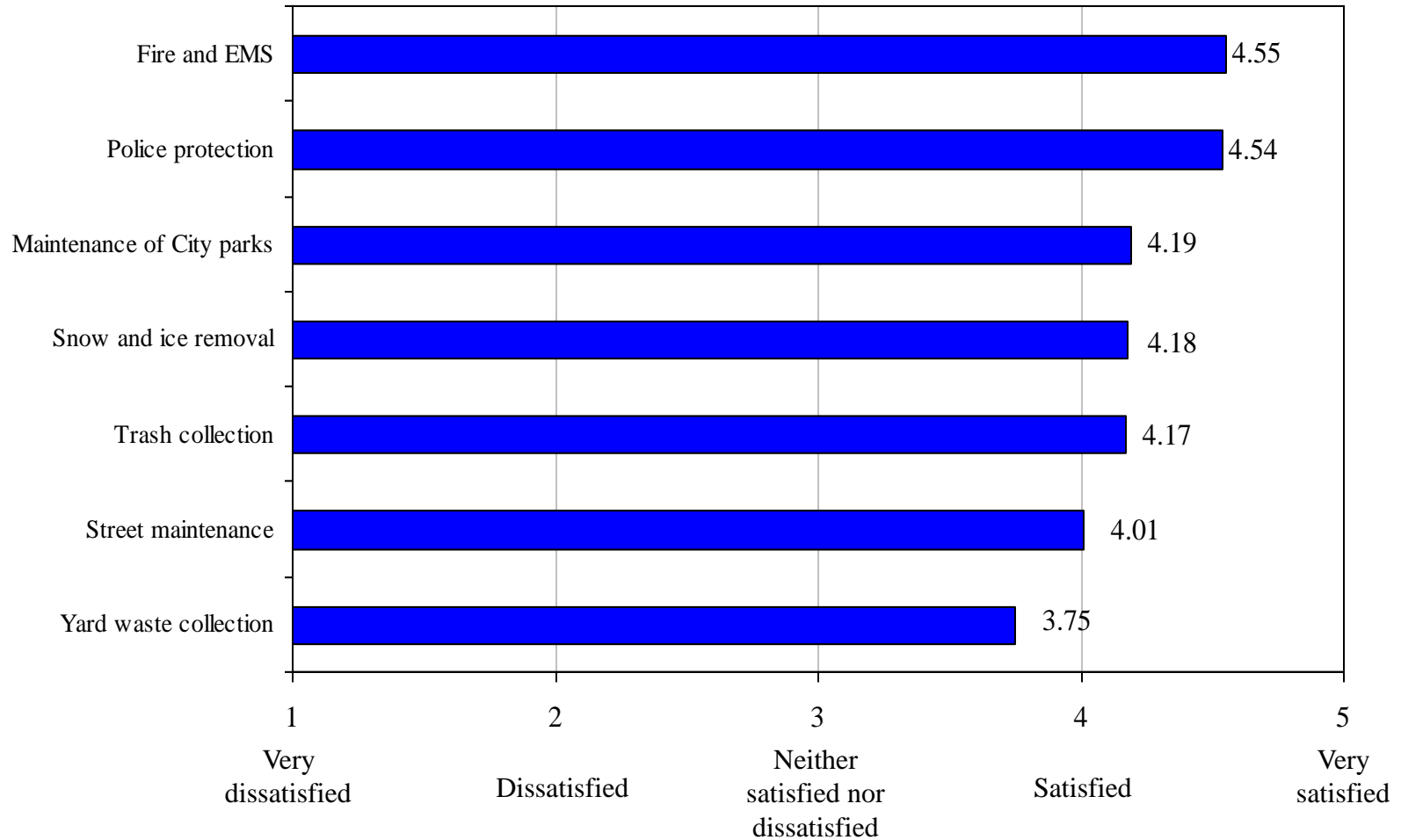

(Questions 6a-6j) Mean Satisfaction with City Services (Services with an Importance Mean of 3.99 or Lower)

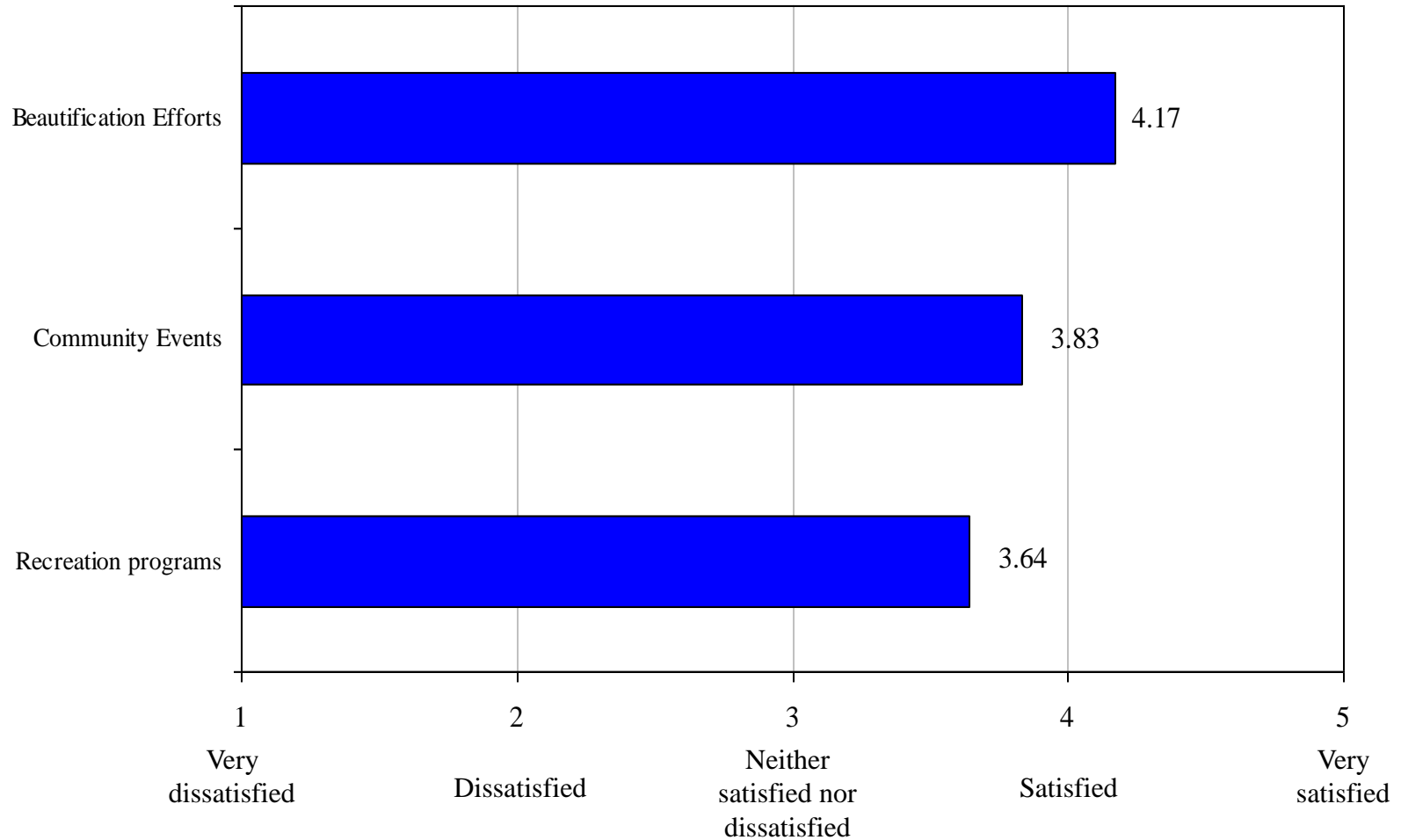

(Question 6e) Satisfaction with Yard Waste Collection

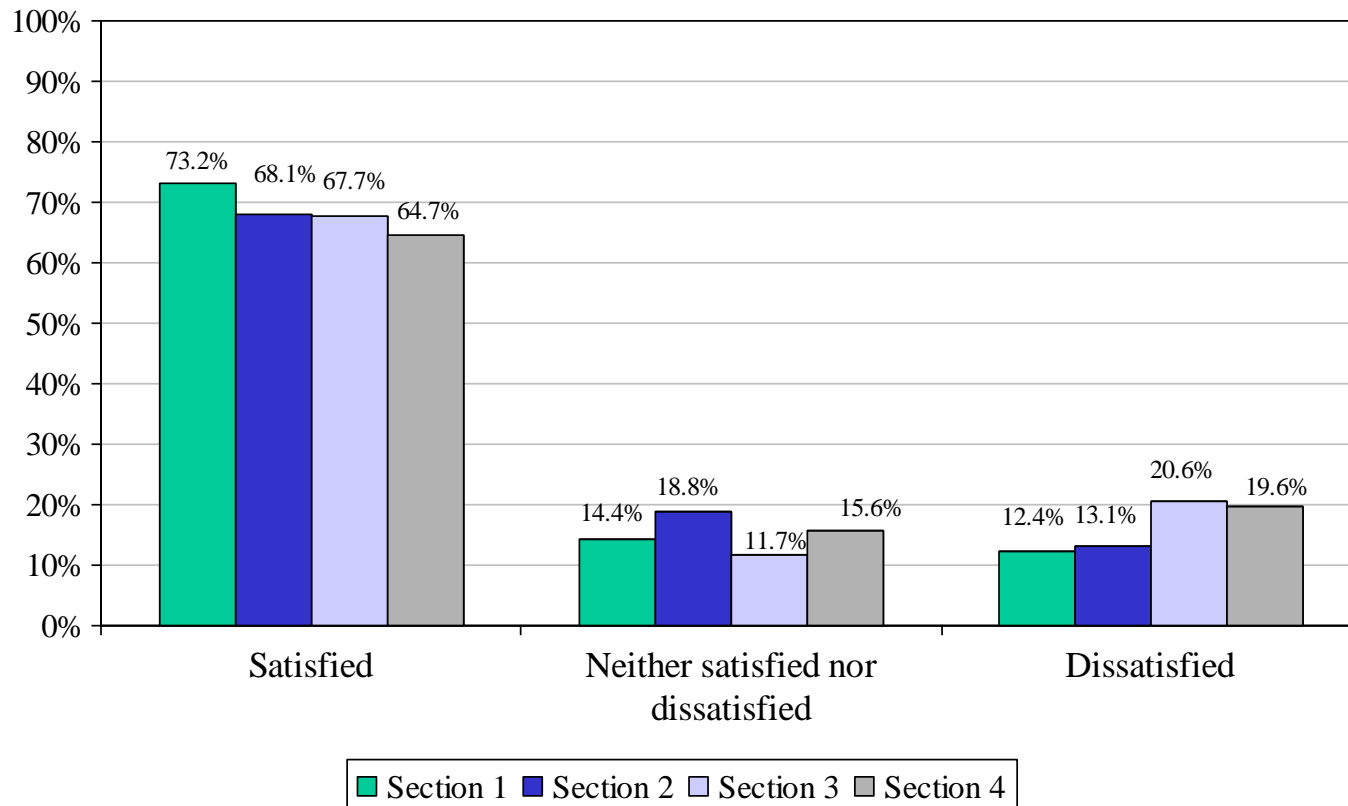


Chart 25. (Question 6h) Satisfaction with Recreation Programs

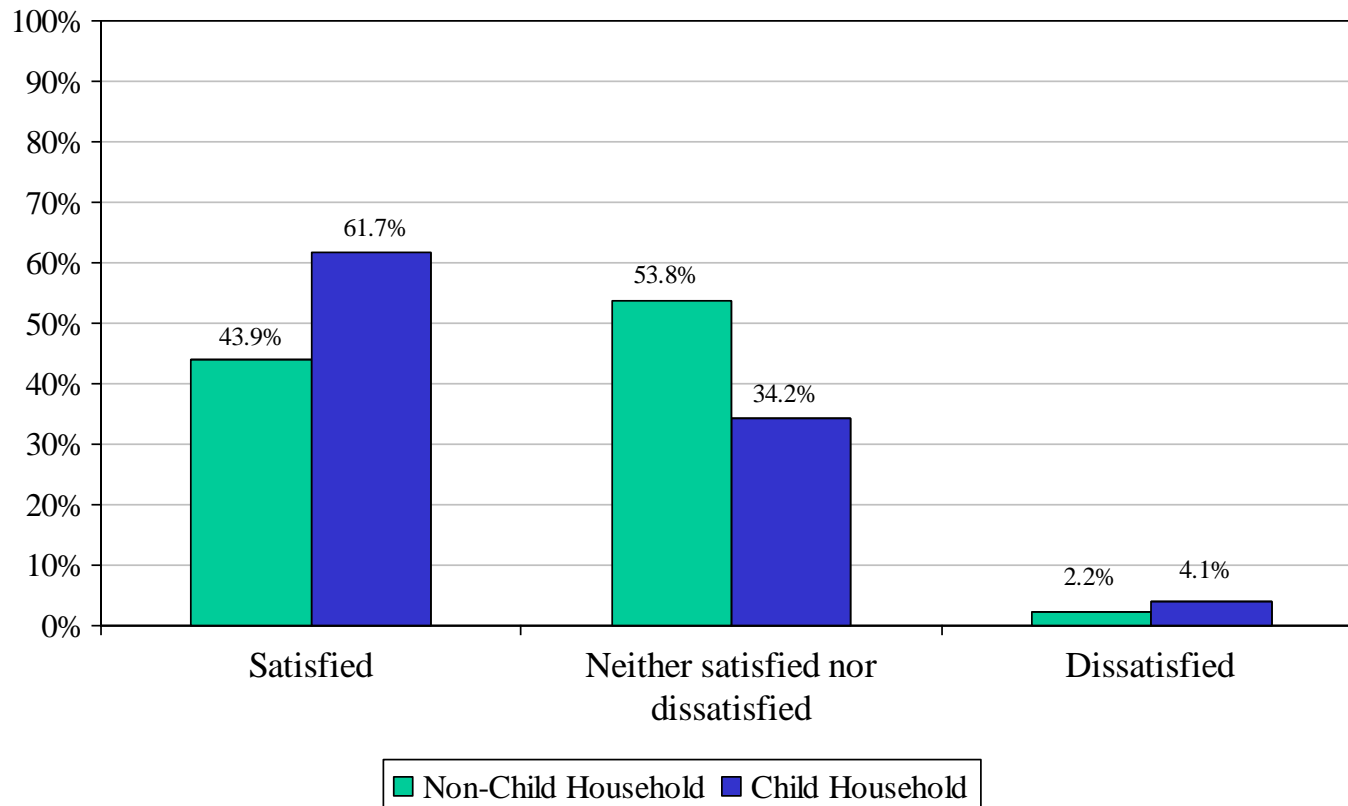

(Question 7a-7d) Percent Favoring Heritage District Development Options

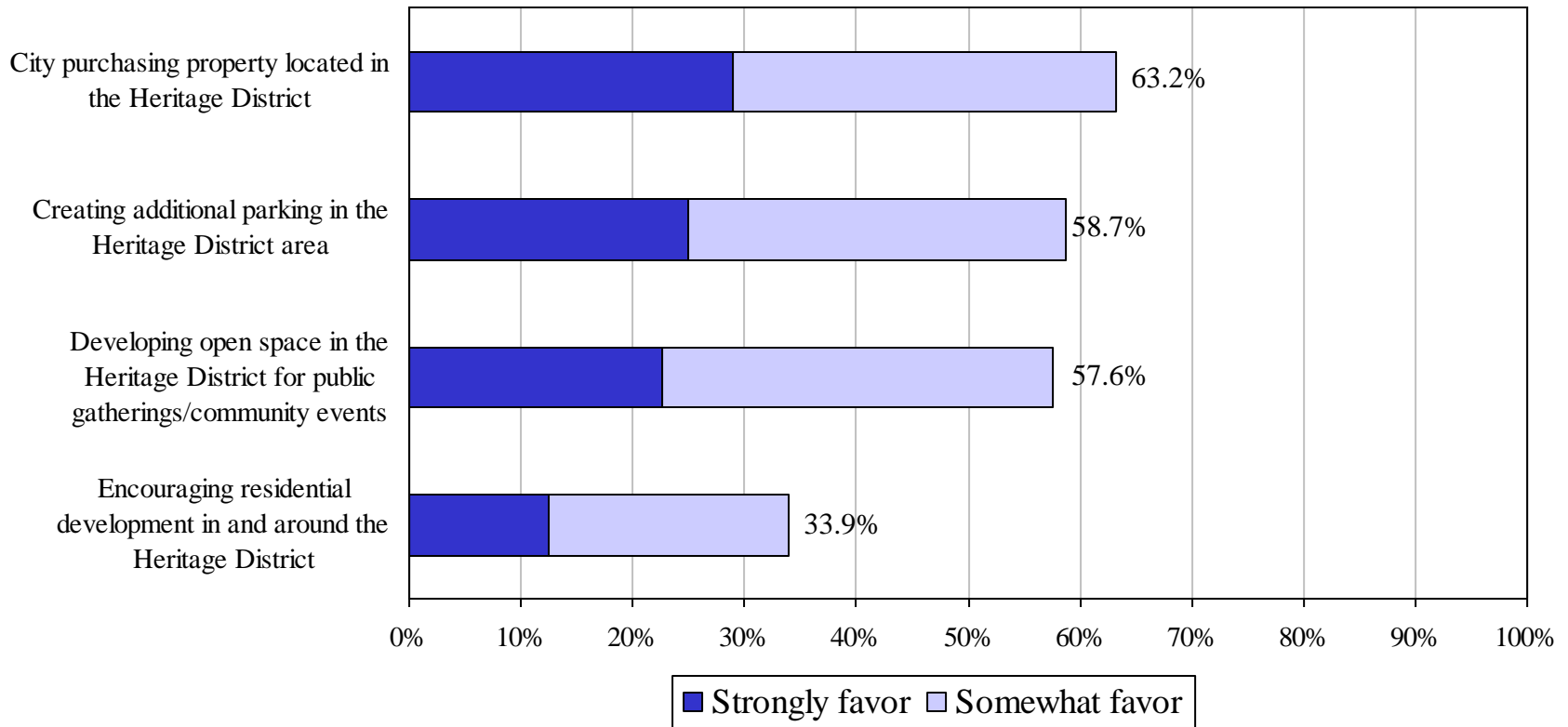

(Question 7b) Favor or Oppose Encouraging Residential Development in and Around the Heritage District Including Cluster Homes or Town Houses

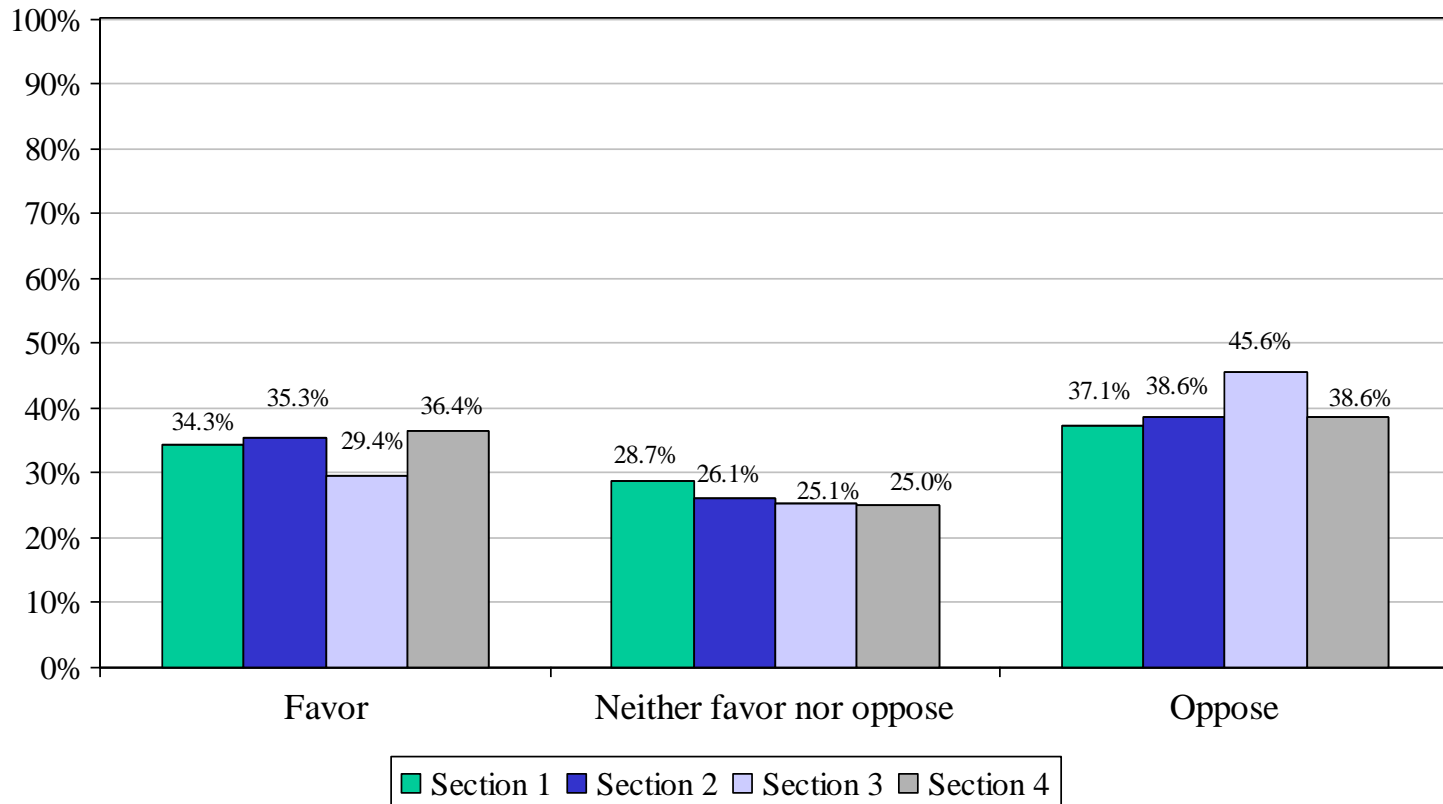

(Question 8) “Do you feel there is a need for additional housing (e.g. town houses, condominiums, or cluster homes) designed specifically for smaller households?”

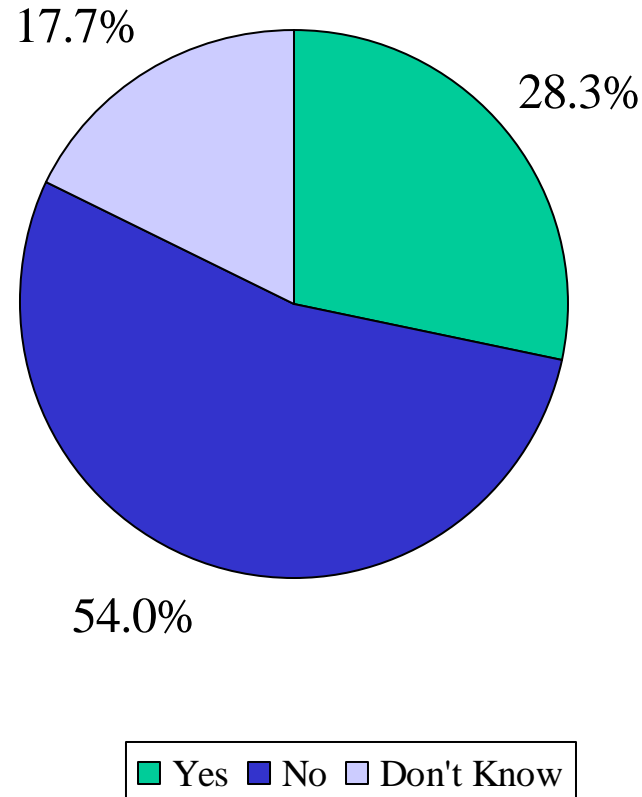

(Question 8) “Do you feel there is a need for additional housing (e.g. town houses, condominiums or cluster homes) designed specifically for smaller households?”

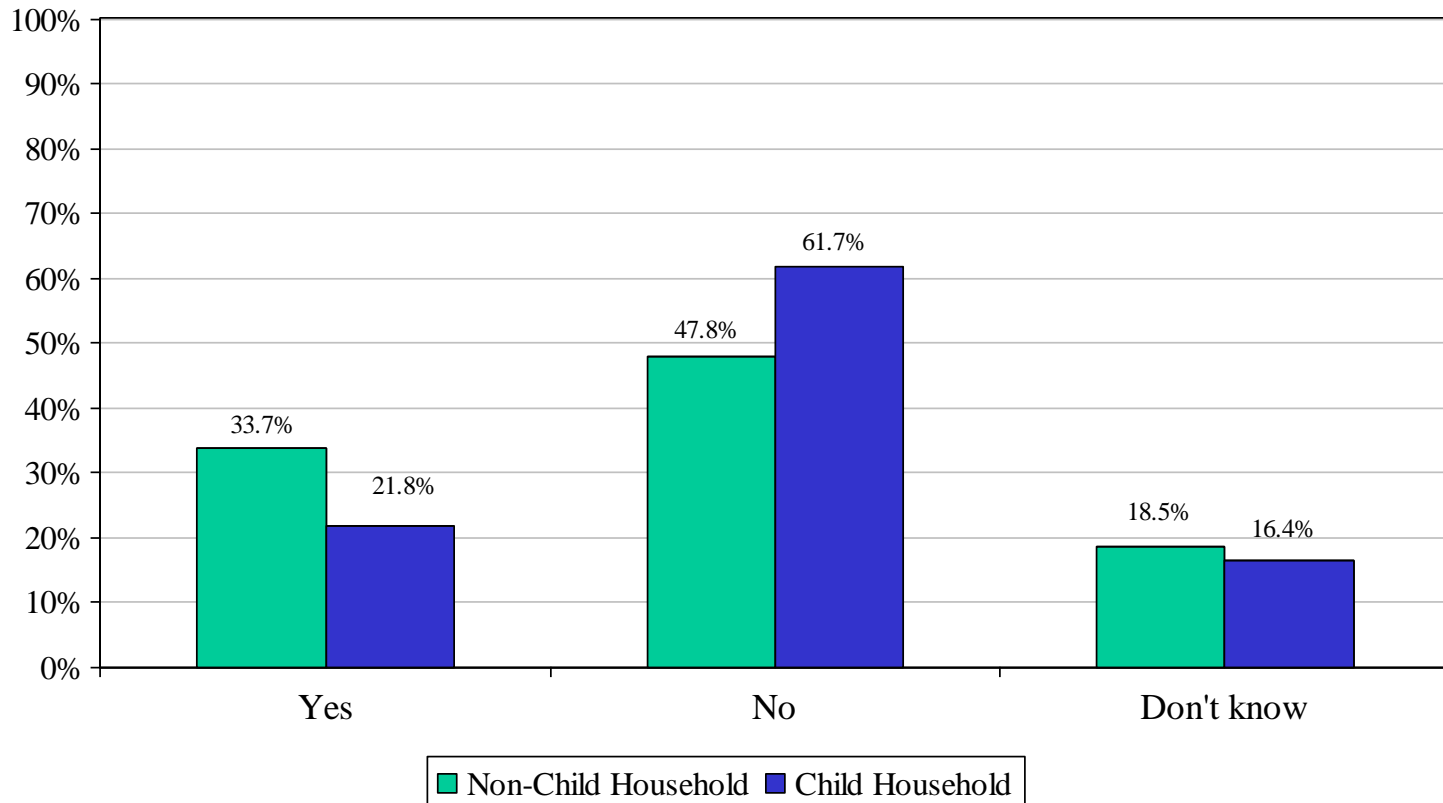

(Question 9a-9d) “Please indicate how likely your household would be to use each of the following services if they were offered via the City of Montgomery Web site . . .”

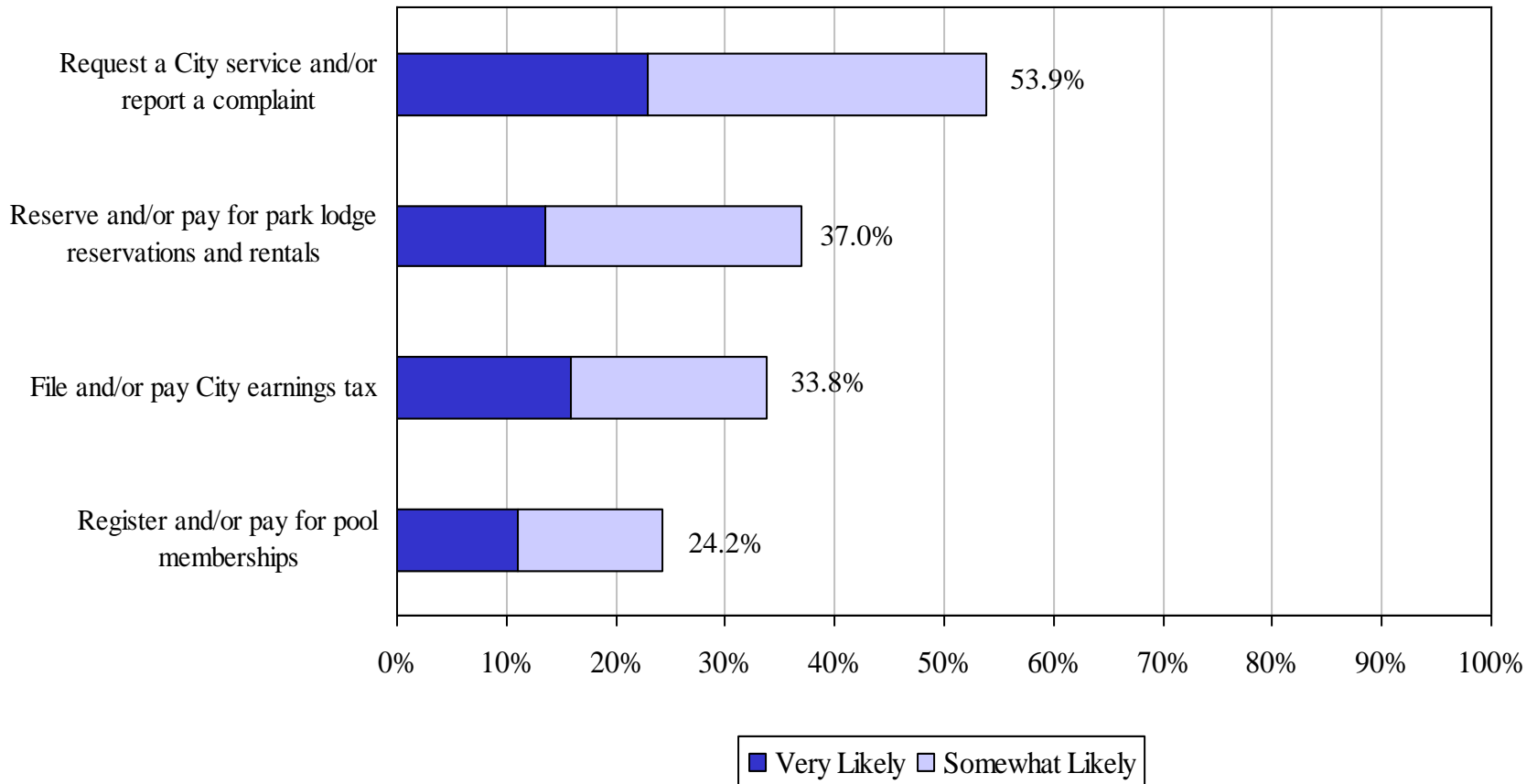

Do you feel that the city was responsive to your request?”**

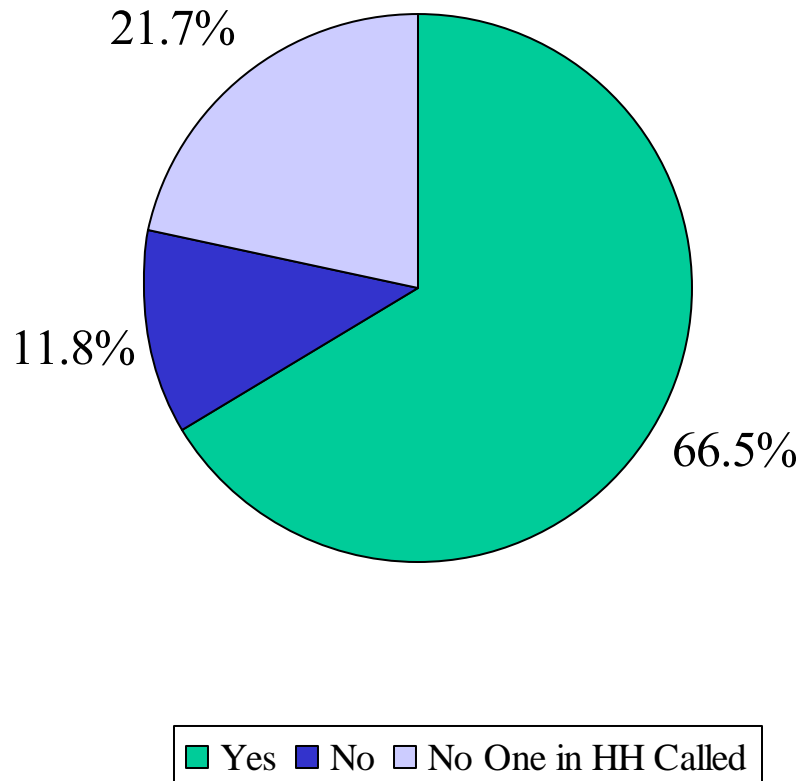

(Question 11) “Thinking about the most recent time a member of your household called the City with a request for service or assistance . . . Was that member of your household treated courteously?”

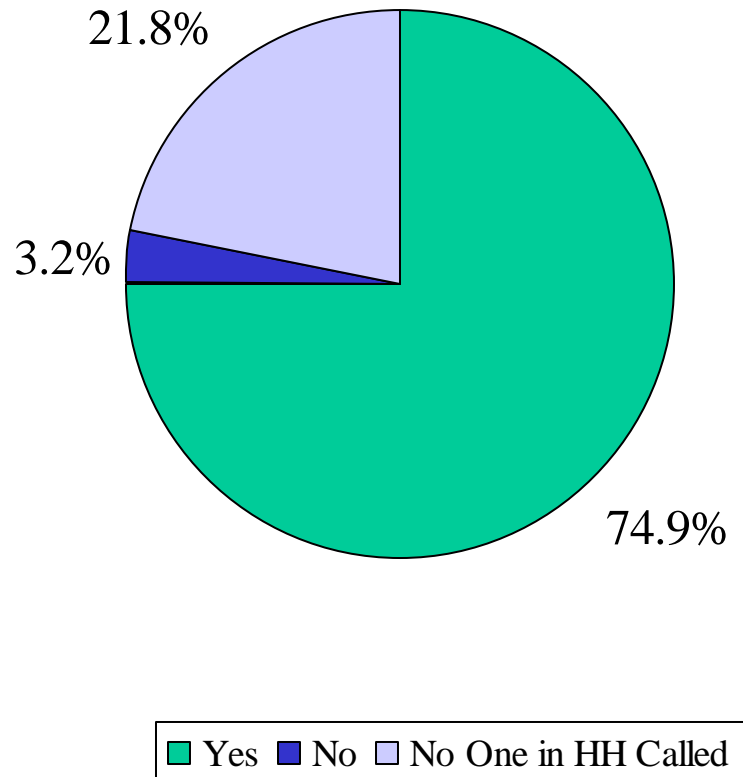

for the property tax dollars I/we pay?’ ”**

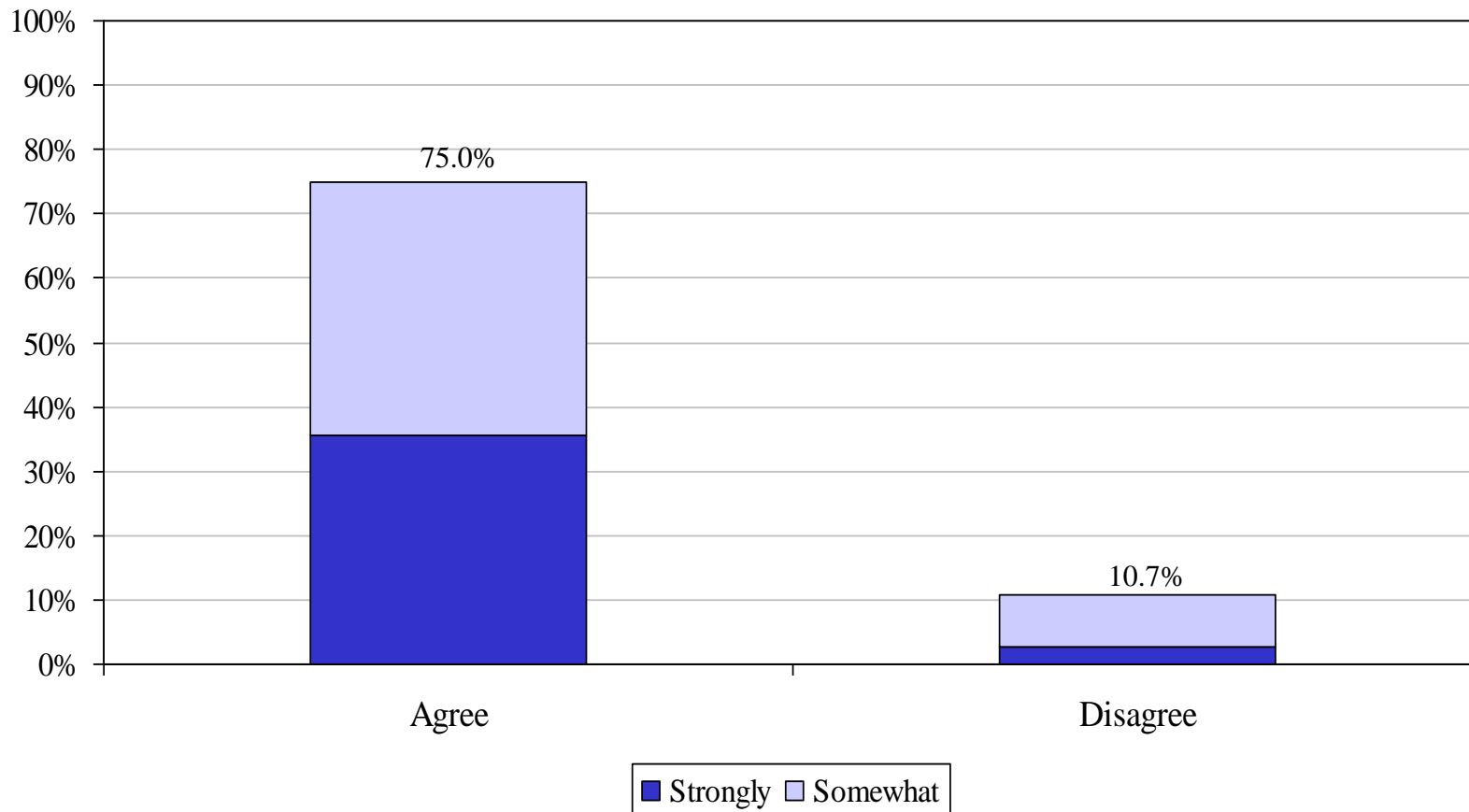

(Percent “Agree”)

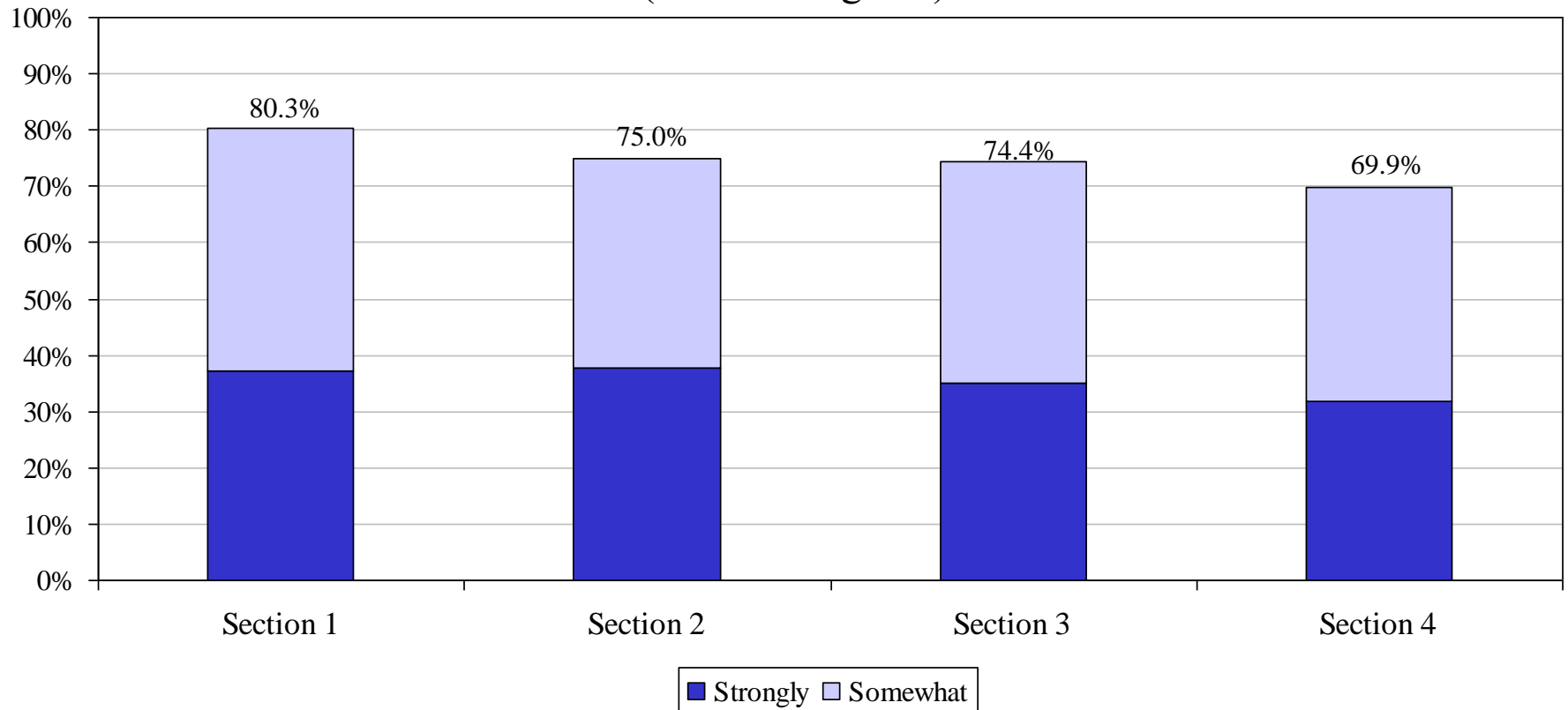
