

**RESOLUTION NO. 6 , 2023**

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO  
A CONTRACT WITH ELA HOLDING CORPORATION, D/B/A TURNKEY  
TECHNOLOGY, FOR A SECURITY CAMERA SYSTEM**

**WHEREAS**, R.C. § 9.48 authorizes Counties, Townships, and Municipal Corporations to participate in a contract for equipment, materials, supplies or services with another political subdivision without competitive bidding; and

**WHEREAS**, the Cincinnati Metropolitan Housing Authority (“CMHA”), an Ohio political subdivision, has contracted with ELA Holding Corporation, d/b/a Turnkey Technology, to purchase a security camera system, and within the contract between CMHA and Turnkey Technology the parties agreed to a Right of Joinder to allow other Public Agencies such as the City to Montgomery to Piggy-Back upon such contract under the same terms and conditions; and

**WHEREAS**, based upon a review of available systems and services, the Administration has determined that the equipment provided by Turnkey Technology through the CMHA contract is the best option for the City of Montgomery and therefore has recommended that the City Piggy-Back upon the CMHA contract to purchase such equipment and supplies from Turnkey Technology.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the City of Montgomery, Hamilton County, Ohio, that:

**SECTION 1.** Pursuant to R.C. § 9.48, the City Manager is hereby authorized to enter into a contract with ELA Holding Corporation, d/b/a Turnkey Technology, for the purchase and installation of a security camera and door access system throughout the City

with data storage and management services for a Three (3) year period consistent with the terms and conditions of the Cincinnati Metropolitan Housing Authority contract, and consistent with the proposal from Turnkey Technology, attached hereto, in the proposed amount of \$282,999.38.

**SECTION 2.** Council hereby finds that purchasing these materials and supplies through the contract awarded by the Cincinnati Metropolitan Housing Authority is in the best interest of the City of Montgomery and is consistent with the terms and conditions of R.C. § 9.48.

**SECTION 3.** The City Manager is authorized to execute a contract with Turnkey Technology and such additional documentation as may be necessary with the Cincinnati Metropolitan Housing Authority to implement this joint purchase.

**SECTION 4.** This Resolution shall be in full force and effect from and after its passage.
