RESOLUTION APPROVING AUTHORIZATION TO EXECUTE SEWER/WASTEWATER TREATMENT AGREEMENT WITH THE TOWNS OF ATOKA AND BRIGHTON

WHEREAS, the City of Munford owns and operates a wastewater system that provides services to residents of Munford, Atoka, and Brighton; and

WHEREAS, the 1989 agreement between the three cities has become outdated due to changes in population of the same, and

WHEREAS, the new addition of a 1M gallon wastewater lagoon funded by a TDEC-ARPA grant and funds paid by Atoka and Brighton has created a need for a new agreement, and

WHEREAS, all three cities desire to end the 1989 contract, and

WHEREAS, all three cities have agreed to the terms of the new agreement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the City of Munford, Tennessee:

That the Mayor be authorized to execute an agreement with Atoka and Brighton to provide sewer services to the same.

The Mayor declared the Resolution duly adopted and effective from and after this 14th day of November 2024 the welfare of the City requiring it.

RESOLUTION 2024-11-02

RESOLUTION APPROVING REFUNDING UTILITY DEPOSITS TO CUSTOMERS

WHEREAS, the City of Munford has deposits for the water, sewer, and gas service on their books as a liability for twenty plus years, and

WHEREAS, these funds are normally credited to customer bills after service termination by the customer, and

WHEREAS, the City of Munford no longer requires deposits for utility service and has not since 2006; and

WHEREAS, the City deems it no longer necessary to hold these funds; and

WHEREAS, the City desires to refund all deposits on the November 2024 billing.

NOW, THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the City of Munford, Tennessee:

That all deposits for the water, sewer and gas funds been refunded to the customers as of the November 2024 billing.
