MINUTES – April 24, 2017

**Regular Monthly Meeting – Monday April 24, 2017, 7:00 p.m.

 - Mayor Cole presented for a first reading **ORDINANCE 2017-04-01**: An Ordinance of the Board of Mayor and Alderman of the City of Munford to establish new water and sewer rates and fees effective on the July 2017 Meter Readings. *Motion was made by Alderman Bomar to approve **ORDINANCE 2017-04-01**. Motion was seconded by Alderman Arthur. Motion carried, all members present voting aye.*
 - Mayor Cole requested a motion to approve the preliminary Walker Field development plan for a Planned Residential Development (PRD) to be located on Doctor's Drive and McLaughlin Drive. The development came to the Board with a positive recommendation from the City of Munford Planning Commission. *Motion was made by Alderman Deneka to approve. Motion was seconded by Alderman Watson. Motion carried, all members present voting aye.*

- Mayor Cole requested a motion to approve the Munford – Atoka Water Contract. The Town of Atoka approved the contract in their most recent Board of Mayor and Alderman meeting. *Motion was made by Alderman Bomar to approve. Motion was seconded by Alderman Arthur. Motion carried, all members present voting aye.*
