Motion was seconded by Alderman Bomar. Motion carried, all members present voting aye.*
- Mayor Cole presented for a second reading **ORDINANCE: 2020-06-02** An Ordinance amending the annual operating budget for fiscal year beginning July 1, 2019 and ending June 30, 2020. *Motion was made by Alderman Wilson to approve **ORDINANCE 2020-06-02**. Motion was seconded by Alderman Glass. Motion carried, all members present voting aye.*
- Mayor Cole presented for a second reading **ORDINANCE: 2020-06-03** An Ordinance amending the annual State Street Aid budget for fiscal year beginning July 1, 2019 and ending June 30, 2020. *Motion was made by Alderman Bomar to approve **ORDINANCE 2020-06-03**. Motion was seconded by Alderman Wilson. Motion carried, all members present voting aye.*
- Mayor Cole presented for a second reading **ORDINANCE: 2020-06-04** An Ordinance amending the annual Drug Fund budget for fiscal year beginning July 1, 2019 and ending June 30, 2020. *Motion was made by Alderman Glass to approve **ORDINANCE 2020-06-04**. Motion was seconded by Alderman Turner. Motion carried, all members present voting aye.*
- Mayor Cole presented for a second reading **ORDINANCE: 2020-06-05** An Ordinance amending the annual Solid Waste Fund budget for fiscal year beginning July 1, 2019 and ending June 30, 2020. *Motion was made by Alderman Wilson to approve **ORDINANCE 2020-06-05**. Motion was seconded by Alderman Turner. Motion carried, all members present voting aye.*
- Mayor Cole presented for a second reading **ORDINANCE: 2020-06-06** An Ordinance to set the property tax rate for the City of Munford at the certified tax rate. *Motion was made by Alderman Bomar to approve **ORDINANCE 2020-06-06**. Motion was seconded by Alderman Glass. Motion carried, all members present voting aye.*



- Mayor Cole presented **RESOLUTION: 2020-07-01** A Resolution granting the Parks and Recreation Department approval to apply for a Safety Partners matching grant. *Motion was made by Alderman Glass to approve RESOLUTION 2020-07-01. Motion was seconded by Alderman Turner. Motion carried, all members present voting aye.*
- Mayor Cole requested a motion to award the asphalt road repairs for Wooten Oaks Subdivision *Motion was made by Alderman Bomar to approve. Motion was seconded by Alderman Glass. Motion carried, all members present voting aye.*
- The Mayor requested a motion to accept Green Meadows Blvd as a city street. *Motion was made by Alderman Wilson to approve. Motion was seconded by Alderman Bomar. Motion carried, all members present voting aye.*
- The Mayor requested a motion to declare a 2008 Ford Crown Victoria in the Police Department surplus property and available for transfer to another government entity. *Motion was made by Alderman Glass to approve. Motion was seconded by Alderman Bomar. Motion carried; Alderman Turner abstained from voting all other members present voting aye.*


