**I. CALL TO ORDER**

Mayor Cole called the October 26, 2020 meeting of the Board of Mayor and Aldermen of the City of Munford to order at 7:00 p.m. Alderman Bob Wilson gave the invocation.

- Mayor Cole noted the City had received a “Certificate of Sound Financial Plan” recently from the Tennessee Comptroller’s Office. This certificate was awarded based on the adoption of the city’s budget before the end of the previous year, the budget was filed within 15 days of adoption with no issues of concern during the review, and the city is not under the oversight of the Water & Wastewater Financing Board.
- Mayor Cole presented a proclamation stating November as “Munford DECA’s No Excuse for Child Abuse” month in the City of Munford. Officers of the club made a short presentation to the Mayor of Board and Aldermen.
- Mayor Cole presented **ORDINANCE: 2020-10-01** An Ordinance to amend the Munford Municipal Zoning Map to rezone property on U.S. Highway 51 (Randall Robbins and Ryan Payne properties) from PB (Planned Business) District to M-1 (Light Industrial) District. *Motion was made by Alderman Turner to approve **ORDINANCE 2020-10-01**. Motion was seconded by Alderman Deneka. Motion carried, all members present voting aye.*
- Mayor Cole presented **RESOLUTION: 2020-10-01** A Resolution approving awarding of contract for 12- inch sanitary sewer force main to Dozer Trax USA. *Motion was made by Alderman Wilson to approve **RESOLUTION 2020-10-01**. Motion was seconded by Alderman Glass. Motion carried, all members present voting aye.*
