**March 2021 Library Report** 



- The library has sold \$87.00 in books with the ongoing book sale.
- The library has collected \$0.50 in library fines, overdue fees, and lost items.
- The monthly collection for copies and faxing was \$180.90.
- The Library collected **\$218.34** in donations. **\$150** in memory of Joyce Bibb & **\$68.34** from Kroger Community Rewards.
- The Library had **35** people use our computers and **30** requiring computer help. In addition we had **189** use the Wi-Fi. The library had **481** reference questions asked and answered.
- Library staff provided 8 one-on-one technology device sessions lasting more than 10 minutes.
- Library staff served as proctors for 4 TWRA Boat Tests.
- The Library has gained **16** new users, with **1,281** materials checked out (including books, movies, audio, R.E.A.D.S circulation, etc.). We have a total of **4,192** patrons.
- Through Interlibrary Loan 21 books were loaned out, and 15 were borrowed.

- Virtual Story Times were posted to Facebook. Staff reads a book and posts the video to Facebook. We posted 4 videos in March with 349 views.
- The Library staff made take home crafts for children. 20 crafts were picked up from the Library.
- The Library had many passive program displays for March, including: Green books for St. Patrick's Day, Read it and Weep display, Easter books & April Shower's books. 6 patrons participated in these passive programs.
- Library staff started a monthly Staff Recommendation and Book Spotlight display that we shared to our Facebook page.
- We continue to offer curbside services to patrons. 137 patrons were assisted curbside.







WHEREAS, *Tennessee Code Annotated* 6-51-102 requires that a plan of service be adopted by the governing body of a city prior to annexing an area; and,

WHEREAS, the Munford Municipal-Regional Planning Commission has recommended that the following Plan of Service for the annexation of an area located on George Ellis Drive (Owned By Stephen Toarmina And Anthony Terhune).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MUNFORD, TENNESSEE:

SECTION 1. Pursuant to <u>Tennessee Code Annotated</u> Section 6-51-102, there is hereby adopted for the proposed annexation area the following Plan of Service:

### A. Police

- (1) Patrolling, radio responses to calls, and other routine police service, using present personnel and equipment, will be provided on the effective date of annexation.
- (2) No additional personnel or equipment will be added during the first year after the effective date of annexation, but as the area develops, additional personnel and equipment may be expanded as needed.
- (3) Traffic signals, traffic signs, street markings, and other traffic control devices will be installed as the need therefore is established by appropriate study and traffic standards.

### B. Fire

(1) Fire protection by the present personnel and the equipment of the fire fighting force, within the limitations of available water and distances from fire

stations, will be provided on the effective date of annexation.

(2) No additional personnel or equipment will be added during the first year after effective date of annexation, but with the growth and development of the area additional personnel and equipment may be expanded as needed.

### C. Water

- (1) Water for domestic, commercial, and industrial use will be provided at the rates presently charged by the City of Munford, on the effective date of annexation, and thereafter from new lines as extended by developers as development occurs in accordance with current city policy.
- (2) Water for fire protection will be available immediately following annexation and from new lines as extended in accordance with current city policy.

### D. Sewer

A sanitary sewer lift station is located on George Ellis Dr. The extension of sanitary sewer lines for future development will be the responsibility of the developers.

### E. Natural Gas

The necessary natural gas lines will be installed on undeveloped property by developers as development occurs according to current city policies. Gas is currently available to existing property owners.

### F. Refuse Collection

The same regular refuse collection services now provided within the city will be extended to the annexed areas after 30 days of the effective date of annexation.

### G. Streets

There are currently no streets within the Annexation area. After the new streets are inspected and accepted into the City street system by the Board of Mayor and Alderman. The City will provide the following services to new streets constructed in the annexed area:

- (1) Emergency maintenance of streets. (repair of hazardous chuck holes, measures necessary for traffic flow, etc.)
- (2) Routine maintenance, on the same basis as in the present city.
- (3) Reconstruction and resurfacing of streets, installation of storm drainage facilities, construction of curbs and gutters, and other such major improvements, as need therefore is determined by the governing body, will be accomplished under current policies of the city.

### H. <u>Inspection Services</u>

Inspection services are currently provided by the city. Code Enforcement will begin in the annexed areas on the effective date of annexation.

### I. Planning and Zoning

The planning and zoning jurisdiction of the city will extend to the annexed areas on the effective date of annexation. City planning will thereafter encompass the annexed areas. The area will be zoned R-1 (Low Density Residential) District

### J. <u>Street Lighting</u>

Street lights will be installed by developers as development occurs in accordance with standards currently prevailing in the existing city policies.

### K. Recreation

Residents of the annexed areas may use all existing recreational facilities, parks, etc. on the effective date of annexation. The same standards and policies now used in the present city will be followed in expanding the recreational program and facilities in the enlarged city.

WHEREAS, providing for the issuance of permits and collection of fees; therefore, and

**WHEREAS,** repealing Ordinance No. 2018-08-05 of the City of Munford, Tennessee and all other ordinances or parts of laws in conflict therewith:

# NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF MUNFORD, THAT:

**Section 1.** That a certain document, one (1) copy of which are on file in the office of the City Recorder of the City of Munford, Tennessee, being marked and designated as Regulations for *Swimming* Pool, Spa and Hot Tub Enclosures., is hereby adopted; providing for the issuance of permits and collection of fees; therefore, and each and all of the regulations, provisions, penalties, conditions, and terms of said Regulations for Swimming Pool, Spa and Hot tub enclosures on file in the office of the City Recorder are hereby referred to, adopted, and made a part hereof, as if fully set out in this legislation, with the additions, prescribed in Section 2 of this ordinance.

**Section 2.** The following sections are hereby revised:

#### **Section 101.1.** Swimming Pools, Spas and Hot tubs

Swimming pools spas and hot tubs shall be maintained in a clean and sanitary condition, and in good repair.

#### **Section 101.2** Enclosures

Private swimming pools, hot tubs, and spas, containing water more than 24 inches (610 mm) in depth shall be completely surrounded by a fence or barrier at least 48 inches (1219 mm) in height above the finished ground level measured on the side of the barrier away from the pool. Gates and doors in such barriers shall be self-closing and self-latching. Where the self-latching device is a minimum of 54 inches (1372 mm) above the bottom of the gate, the releasing mechanism shall be located on the pool side of the gate. Self-closing and self-latching gates shall be maintained such that the gate will positively close and latch when released

from an open position of 6 inches (152 mm) from the gate post. No existing pool enclosure shall be removed, replaced, or changed in a manner that reduces its effectiveness as a safety barrier.

Exceptions: Spas or hot tubs with a safety cover that complies with ASTM F 1346 shall be exempt from the provisions of this section.

**Section 3.** That Ordinance No. 2018-08-05 of City of Munford, Tennessee referencing the 2012 International Residential Code, appendix G "Swimming Pools, Spas, and Hot Tubs" and all other ordinances or parts of laws in conflict herewith are hereby repealed.

**Section 4.** That if any section, subsection, sentence, clause, or phrase of this legislation is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Board of Mayor and Alderman hereby declares that it would have passed this law, and each section, subsection, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional.

**Section 5.** That nothing in this legislation shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this law; nor shall any just or legal right or remedy of any character be lost, impaired, or affected by this legislation.

**Section 6.** That the City Recorder is hereby ordered and directed to cause this legislation to be published.

**Section 7**. This ordinance shall take effect from and after its passage, the welfare of the city requiring it.

**Section 8**. It shall be unlawful for any person to violate or fail to comply with any provision of the code as herein adopted by reference and modified. The violation of any section of this chapter shall be punishable by a penalty of up to fifty dollars (\$50.00). Each day a violation is allowed to continue shall constitute a separate offense.

The regular monthly meeting of the Munford Municipal-Regional Planning Commission met on Tuesday, April 13, 2021 at 6:30 P.M. With the following:

There was a motion by Vernon Pairmore, seconded by David Keeton to approve the minutes from March 9, 2021 as presented, all present voting aye. Motion carried.

#### IV. <u>NEW BUSINESS</u>

#### A. Evins Minor Subdivision Plat

#### **Background**

A minor subdivision plat has been submitted on behalf of Christopher and Kellie Evins to combine 3 lots into a 3.99-acre tract. The property is located on McCormick Road. The properties can be further identified as Parcel number 6.01, 7.00 and 8.00 on Tipton County Tax Map #126E, Group A. The properties are zoned R (Residential) and FAR (Forestry, Agricultural, Residential) in the Munford Planning Region. The property does not appear to be located in a federally identified flood hazard area.

#### **Analysis**

McCormick Road is a collector street on the Munford Major Road plan and the plat is showing the appropriate amount of right of way currently in existence. (60 feet)

The lots meet the requirements of the R and FAR districts.

The plat is showing the necessary certificates for approval.

#### Recommendation

Staff recommends approval of the plat.

There was a motion by Mayor Dwayne Cole, seconded by John Moren Cole to approve the Evins Minor Subdivision Plat as presented. Motion carried, all present voting aye.

#### B. Central Park Subdivision Phase 2 – Final Plat

#### Background

A final subdivision plat has been submitted on behalf of PFMT Holdings, LLC to create 35 lots. The properties are located near Charles Avenue and Laurel Lane. The property can be further identified as Parcel number 79.00 on Tipton County Tax Map #111. The area is zoned R-2 (Low Density Residential) District. The property does not appear to be located in a federally identified flood hazard area according to FIRM #47167C0310F, effective on 12/19/2006.

#### **Analysis**

This phase of the subdivision was part of an overall preliminary plat approval that included 46 lots. The Preliminary and Construction Plats for the entire development were approved in October 2019.

The lots meet the requirement of the R-2 district. (8,000 sq.ft.)

Construction Plat staff report stated that a development contract was requested by the City prior to final plat approval.

The plat is showing necessary certificates for approval.

#### Recommendation

Staff recommends approval of the plat.

There was a motion by David Keeton, seconded by Vernon Pairmore to approve the Central Park Subdivision Phase 2 – Final Plat contingent upon a check for the final asphalt being received by the City of Munford. Motion carried, all present voting aye.

#### C. Walker Meadows North Construction Plat

#### **Background**

A Planned Residential Development (PRD) Construction Plat has been submitted on behalf of Charles Walker Residuary Trust and Munford Development Company for properties along Doctor Drive and McLaughlin Drive to create 57 lots and new right of way. The properties can be further identified as Parcel 2.00 on Tipton County Tax Map 111. The properties do not appear to be located in a federally identified flood hazard area according to FIRM #47167C0310F, effective on 12/19/2006.

#### **Analysis**

The Construction plans have been received and approved by the City Engineer.

The maintenance of the Detention Pond areas needs to be clearly articulated in the notes on the final plat.

After installation of improvements, staff recommends the City Engineer inspect the installed improvements to determine the bonding amount that is necessary to cover any uninstalled infrastructure (final wearing surface) and an appropriate warranty period.

City Staff has requested a development contract be entered into with the development and the City prior to final plat approval.

#### Recommendation

Staff recommends approval of the construction plat provided all above-mentioned issues have been adequately addressed.

There was a motion by Rick Wilson, seconded by Sue Arthur to approve the Walker Meadows North Construction Plat as presented. Motion carried, all present voting aye.

## D. Resolution to Adopt Underground Electric Requirements in the Munford Municipal Subdivision Regulations

#### **Background**

Staff has been asked to present Underground Electric requirements for new subdivisions to the Planning Commission. Staff is proposing the following language for Planning Commission review:

Underground electric service is required by the City. With the exception of existing street facing infill development, and they must be approved by the city on a case-by-case basis. Consult with Southwest Tennessee Electric Membership Corporation for specific design standards.

Staff has been asked to propose a definition for "infill development".

"Infill Development" means any case where lots are being divided in an established subdivision or where electric is already installed.

There was a motion by Sue Arthur, seconded by David Keeton to approve the Resolution to Adopt Underground Electric Requirements in the Munford Municipal Subdivision Regulations as presented. Motion carried, all present voting aye.

## E. Resolution to Adopt New Pavement Standards in the Munford Municipal Subdivision Regulations

#### Background/Analysis

Staff is presenting language to be added to the Municipal Subdivision Regulations that would change the pavement standards to the following language:

#### 4. Pavement Base Course

After preparation of the subgrade, the roadbed shall be surfaced with an approved material conforming to the Technical Specification of the City of Munford. T (2) options are available to the developer for construction of base course as follows:

#### a. Alternative A

For streets with rights of way less than 80 feet:

Six inches (6") of grading D limestone over the pavement width installed in two inch (2") to three inch (3") compacted lifts per Tennessee Department of Transportation Section 303.

For streets with rights of way of 80 feet or more:

Ten inches (10") of grading D limestone over the pavement width installed in two inch (2") to three inch (3") compacted lifts per Tennessee Department of Transportation Section 303.

#### b. Alternative B

For streets with rights of way less than 80 feet:

Six inches (6") of soil cement over the pavement width, with design mix formula for soil type subject to planning staff approval, installed per Tennessee Department of Transportation Section 304.

For streets with rights of way 80 feet or more:

Ten inches (10") of soil cement over the pavement width, with design mix formula for soil type subject to planning staff approval, installed per Tennessee Department of Transportation Section 304.

## F. Resolution to Adopt Administrative approval of Minor Subdivision Plats of Two Lots or Less within the Municipality.

Staff is presenting language to be added to the Municipal Subdivision Regulations that would allow for administrative approval of minor subdivision plats of two lots.

4. Whenever subdivision meets the criteria described below, the Secretary of the Munford Municipal - Regional Planning Commission may approve a subdivided plat without the approval of the Planning Commission.

There was a motion by David Keeton, seconded by John Moren to approve the Resolution to Adopt Administrative approval of Minor Subdivision Plats of Two Lots or Less within the Municipality. Motion carried, all present voting aye.

## G. Resolution to Adopt Administrative approval of Minor Subdivision Plats of Two Lots or Less within the Region.

Staff is presenting language to be added to the Regional Subdivision Regulations that would allow for administrative approval of minor subdivision plats of two lots.

4. Whenever subdivision meets the criteria described below, the Secretary of the Munford Municipal - Regional Planning Commission may approve a subdivided plat without the approval of the Planning Commission.

There was a motion by Mayor Dwayne Cole, seconded by Rick Wilson to approve the Resolution to Adopt Administrative approval of Minor Subdivision Plats of Two Lots or Less within the Region. Motion carried, all present voting aye.

- Park Street is being repaired as soon as school gets out for the summer. This road suffered a lot of damage this winter.
