#### ITEM BEFORE THE COUNCIL:

Approval of the proposal from Pavement Maintenance Systems for sections of Barker, Barton, Madison, Biddle, and Berrien.

#### **DISCUSSON:**

The city is continuously exploring methods to preserve or improve the street system. Streets Department Lead Bolton discussed the possibility of doing chip sealing on some of the city's gravel roads with Pavement Maintenance Systems.

Pavement Maintenance Systems provided a quote to chip seal Barker (Washington to Clay); Barton (Madison to the dead end); Madison (Whittaker to Barton); Biddle (Clay to Detroit ROW); and Berrien (Washington to dead end). The quoted amount for a Double-Chip Seal is \$20,970 and funding is available in the Fiscal Year 2025 Local Streets budget.

#### **RECOMMENDATION:**

That the New Buffalo City Council approves the road chip seal proposal for Barker (Washington to Clay); Barton (Madison to the dead end); Madison (Whittaker to Barton); Biddle (Clay to Detroit ROW); and Berrien (Washington to dead end) in the amount of \$20,970 from Pavement Maintenance Systems.
