## Consent Judgment to Vacate the Public Alleys in Block 4 in Rose Addition to the Village of New Buffalo

At a session of Court held in the City of St. Joseph, County of Berrien, State of Michigan, this \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2006.

WHEREAS, this matter having come to be heard upon the complaint of Plaintiff Angela Reichert to vacate the public alleys in Block 4 in Rose Addition to the Village of New Buffalo; and Plaintiff having represented to this Court that all parties required by MCL 560.224a(1) to be joined have been so joined, and that those parties have either stipulated to this Judgment, consented to the vacation of the public alleys in Block 4 in Rose Addition to the Village of New Buffalo, been given notice of the proceedings leading to this Judgment, or been defaulted;

NOW, THEREFORE, IT IS ORDERED AND ADJUDGED THAT:

- 1. All of the public alleys in Block 4 in Rose Addition to the Village of New Buffalo, part of the E. ½ of the NW ¼ of Section 10, T8S, R21W, City of New Buffalo, County of Berrien, State of Michigan are hereby vacated.
- 2. Title to the vacated public alleys, as described above, will vest in the rightful proprietors thereof pursuant to MCL 560.227a(1) upon the recording of the amended plat as required by this Judgment.
- 3. Lots 1, 2, 3, Block 4 and the northwesterly ½ of the vacated public alley adjacent thereto lying between the southeasterly extension of the common line for Lots 3 and 4 and the

east boundary of Rose Addition to the Village of New Buffalo shall be consolidated into one lot to be identified by the first available consecutive lot number in Block 4 in Rose Addition to the Village of New Buffalo on an amended plat.

- 4. Lots 4, 5, 6, 9, 10, 11 Block 4 and all of the remaining vacated public alleys adjacent thereto shall be consolidated into one lot to be identified by the second available consecutive lot number in Block 4 in Rose Addition to the Village of New Buffalo on an amended plat.
- 5. Private easements to Indiana Michigan Power Company for the purpose of power transmission are hereby established on the lots proposed in paragraphs 3 and 4 as depicted on attached Exhibit A and shall be shown on the amended plat. The easements shall include rights-of-way for the construction, operation, use, maintenance, repair, renewal and removal of a line or lines of overhead and underground facilities and equipment for the transmission of electrical energy, and for communication purposes including the right to permit attachments of others to said facilities, in, on, along, under, over, across and through the premises together with the right of ingress and egress to, from and over said premises, and also the right to cut or trim any trees and bushes which may endanger the safety or interfere with the construction and use of said facilities, and further provided that no structure or building shall be erected on said easement.
- 6. Other than the easements established in paragraphs 5, only lawfully existing recorded easements located within the boundary of the amended plat are hereby preserved, and the amended plat shall show only lawfully existing recorded easements, and shall be accompanied by a statement of the surveyor that he or she, in determining the type, width, and location of any utility easements shown has reviewed any existing title search and/or policy of

the title insurance and had searched, or caused to be searched, the records of the Register of Deeds for any recorded easements burdening the subject lands which were created between the date of a title search or issuance of a title policy and the submittal date of the amended plat and shall provide a copy of those records to the Michigan Department of Labor and Economic Growth, Office of Land Survey and Remonumentation upon submission of the amended plat.

- 7. Plaintiff shall record this Judgment in the Office of the Register of Deeds for the County of Berrien, State of Michigan, within 30 days of entry if this Judgment, as required by MCL 560.228.
- 8. Plaintiff shall prepare and file, within 90 days of the entry of this Judgment by this Court, an amended plat for Lots 1-6 and 9-11, Block 4 and the vacated public alleys in Rose Addition to the Village of New Buffalo in a recordable form in accordance with MCL 560.101, et seq. and this Judgment, for the review and approval of the Michigan Department of Labor and Economic Growth, Office of Land Survey and Remonumentation.
- 9. This Judgment will be declared null and void *nunc pro tunc* should the amended plat not be prepared and filed as required by this Judgment and by the requirements of the Land Division Act within 90 days from the entry of this Judgment.
- 10. This Court shall retain jurisdiction over this matter until final approval of the proposed amended plat has been granted by the Michigan Department of Labor and Economic Growth, Office of Land Survey and Remonumentation.
  - 11. This resolves the last pending claim in this matter and closed this case.
