The Regular Meeting for November 12, 2020 of the Downtown Development Authority (DDA) was called to order by Chair, Robert Kemper at **8:00 am** in the City Council Chambers at 224 W. Buffalo St., New Buffalo, MI and virtually on Zoom.

### **New Business**

### • Request by David's Deli and False Front

Member Lindsay gave an overview of the request for temporary heat and wind protection on City property in front of their business on Whittaker Street. Since the dining room is still closed due to COVID-19, the request includes two outdoor umbrella heaters on the sidewalk and a temporary tent at the carryout-pickup window, to keep customers warm as they wait in line outside.

A "blanket" recommendation was mentioned to extend to all New Buffalo businesses and possibly make the heating units and tents uniform.

Per the City Manager, a request could be made to extend the existing outdoor seating ordinance to include outdoor heating options.

## Request by 120 West Buffalo Street Development

Architect, Bill McCollum, is requesting variances for a development of a mortgage company office and administrative offices on the site of 120 West Buffalo Street. Overtime, the site would be office space.

It was mentioned there may be some historical representation on the site that may need to be preserved.

Duhn remarked it was a good idea and inquired if there are any limitations to keeping it retail as it was in the past.

Gradowski would like to see the plans and is concerned how it will look and match the rest of the town.

Other members suggested the DDA offer "general support" and ask the Zoning Board (ZBA) to assure everything is kept within ordinances.
