#### **Parks Director Report**

Discussion highlighting:

- the completion of the beach bathrooms by June 2<sup>nd</sup>
- the two vandalized pedestals at the marina have been repaired
- the Dune Walk grant is ready to be sent out for bid. Comments made that the bids may take four weeks before they are received due to contractors being very busy. Per the Parks Director the project may turn into a three-phase project as funds allow. The Parks Director has a goal of getting the existing walk demolished by the end of summer 2021.

#### City Manager email

The grant for electrical upgrades was approved and is out for bids. There was discussion on upgrading the pedestals at the Transient Marina to accommodate the advancements in boat manufacturing.

#### **New Business**

- a. Stern-in Docking Discussion with Marina Supervisor, Audrey Tuszynski Marina Supervisor, Audrey Tuszynski addressed the Commission briefing them on her previous experience and her current experience at the Municipal Marina. Audrey showed an aerial picture of the transient marina and explained the average size of a boat currently is 50' and larger boats require more power than what some of the docks are set up to supply. She stated the small slips are empty a lot of the time. Audrey has a goal to allow larger boats in the marina. She explained stern-in docking was being allowed with assistance from the Marina employees to allow access for larger boats and to allow better/easier access to the power supply located on the pedestal in the middle of the dock. She also discussed removing the piling in slip #26. Lastly, discussions took place regarding:
  - Updating the CAMIS System at the DNR with slip sizes and prices
  - Recommending having lights on back of boats be mandatory and always on, if the boat hangs out past the end of the dock
  - More lighting needed on pilings

#### **Commission Comments:**

Commissioner Susan Stoneburner resigned her position on the Commission, effective immediately.

Commissioner Gabryszewski commented the marina is an asset to the City.

Park/Harbor and the City Council to meet and design strategies.

## CITY OF NEW BUFFALO EXISTING PARKS ASSESSMENT

#### **City Beach**

#### Assessment:

City Beach is a 15 acre parcel with 800 feet of Lake Michigan Shoreline to the north.

The the newly installed playground equipment is not ADA accessible as it does not have an access walk or accessible surfacing however the play structure does contain a transfer platform. The playgroup equipment is located on beach sand proximal to the parking area and the existing concession stand. There are two new outdoor spray showers with grab bars near the entrance to the park that seem to meet accessibility requirements. There is a newly installed boardwalk sections that sit on top of the sand and extend from the parking lot sidewalk near the outdoor spray showers to the north to provide an accessible route through the sand and out toward the waterfront. The boardwalk is sloping at a cross slope that is currently not ADA accessible and the sections with more that 2% cross slope should be reset in place. There is a seating area at the end of the boardwalk with two benches and room for a companion seat however the benches do not have arms to assist the disabled.

The existing parking lot contains ADA parking spaces near the beach and additional spaces with an access route near the concession building area.

#### Accessibility Rating: 2

#### Ways to improve rating:

- Consider adding an accessible route to the new play structure and accessible surfacing.
- Adjust the boardwalk sections to meet cross slope requirements for ADA access.
- Verify that the concession stand area new renovation has included accessible walkways, restrooms, and other amenities.
- Provide a minimum of 20% of all picnic table with ADA accessibility.
- Add a sidewalk in front of the ADA parking spaces located along the edge of the parking lot closest to the beach. Connect to the accessible route along Riverfront Park

#### **Lions Pavilion Park**

#### Assessment:

This park is 2 acres and is located across the street from the City beach. There is a pavilion with a concrete floor. The pavilion contains picnic tables and a built-in fireplace within the wall at the south end of the structure.

There is not an accessible route to the pavilion or other amenities as they are located in the lawn area. There are also mature trees near the shelter with additional outdoor picnic tables and grills within the lawn.

#### Accessibility Rating: 2

#### Ways to improve rating:

- Add an accessible route to the pavilion.
- Add outdoor picnic facilities including accessible tables and grills
- 20% minimum of all picnic table and grills should be ADA accessible

#### **Boat Launch**

#### Assessment:

The boat launch facility is located on 4.75 acres and contains 8 boat launch ramps. There are 140 boat trailer spaces and two ADA parking spaces without access aisles. There is a small building being used for payment however the newly installed concrete sidewalk leading up to the window is not at an accessible slope and there is an additional height difference between the door thrush hold and the new sidewalk. The restroom building is not currently accessible but with improvements and interior wall removal and replacement of the fixtures and the addition of grab bars and other ADA required elements these restrooms could be made accessible, and an accessible route should be added to the exterior.

#### Accessibility Rating: 2

Ways to improve rating:

- Add proper access aisles to the accessible boat trailer parking
- When making future improvements verify all new surfaces meet ADA with slope and cross slope and all new building improvements are designed to meet ADA requirements.
- Add accessible routes to connect all on site amenities.

#### **Riverfront Park**

#### Assessment:

Riverfront Park is a narrow parcel of .75 acres and is located along the Galien River. The park has direct access to the City Beach parking lot and is proximal to the Lions Pavilion Park. The park contains sculpture pads and has fishing access.

Accessibility Rating: - Access once the improvements are completed.

Ways to improve rating:

- When making improvements verify that all new surfaces meet ADA with slope and cross slope.
- Add accessible routes to connect all on site amenities with connectivity to nearby Lions Park Pavilion and City Beach.
- If benches are added select ones with backs and armrests and provide companion seating spaces.

#### **Transient Marina**

#### Assessment:

This 3.5-acre parcel is a transient marina for boaters visiting New Buffalo. Improvements have been made on the marina side of the building including new private restrooms for boaters and a new sidewalk to the boater restroom area. The new sidewalk appears to have too much cross slope to meet ADA requirements for level landings at the restroom doors. The new sidewalk portion that enters the main entrance to the marina side of the building appears to now meet accessibility. The parking area has one ADA parking space – it needs to be upgraded to provide van accessible parking with a van accessible access aisle and van accessible signage.

The passive portion of the park has a sloping sidewalk from the marina area up to the Whitaker Street sidewalk connection. The slope of the walk appears to meet accessibility and a new shade structure has been added with benches along the route located in level landing areas.

This route appears to be accessible although the benches do not have arms to assist the disabled, but it does appear that there is room on the surface near the shade structure for companion seating.

Accessibility Rating: 3

How to improve the rating of this park:

• ADA parking space needs to be van accessible.

#### Oselka Park

#### Assessment:

This 17.5-acre park is in good condition there is an accessible route around the perimeter that is paved in asphalt. The path is in need of crack seal and sealcoating and in places replacement of the surface. There are also locations throughout the park where the path meets the existing parking and there is a curb instead of an accessible ramp. The existing playground located at the far northwest corner of the park is not ADA accessible as the surfacing beneath the equipment is sand nor does it have ADA accessible parking nearby. The equipment is outdated however a new shade structure has been added but it is also not ADA accessible. The ballfields are all in good condition, but they do not have an accessible route and companion seating near the bleachers. The pavilion has accessible restrooms, an accessible drinking fountain and an accessible route around it. The shelter contained 14 picnic tables but none of the 14 were ADA accessible. The parking should be evaluated as it appears that the slope on the access route does not meet accessibility requirements. The football field has a ramp leading up to the bleachers and has accessible seating in the bleachers and the rubberized surface on the track is also fully accessible. The parking however does not appear to meet the requirements as it appears that the slope on the concrete sidewalk is too steep. There is a sled hill and a port-a-john located at the furthest west location near the playground.

Accessibility Rating: 2

How to improve the rating of this park:

- ADA parking space needs to be van accessible.
- The play equipment should be evaluated by a certified playground inspector to determine if compliant and if so then install an accessible surfacing to improve the rating since both playstructures contain a transfer platform.
- Add accessible parking and an accessible route from the parking lot to the play equipment.
- Add accessible seating areas adjacent to the bleachers at all the ballfields and connect to the primary accessible route.
- Repair the accessible route around the park perimeter.
- Replace or add picnic table 20% minimum of all tables should be ADA compliant.
- Add curb ramps at parking lot areas or replace existing sloped walkways to meet ADA requirements.

#### **Sari Asher Memorial Park**

#### Assessment:

This 1.8 acre parcel is developed as a dog park with a small enclosure for small dogs furthest to the west and another enclosure closest to the parking facility that is much larger in size. The parking area is gravel with a port-a-john located adjacent to the parking. The route to the park is not accessible as the surface is wood chip mulch. The double gate areas for each dog park entrance enclosure is paved in concrete. Within the larger enclosure there is also a park shelter with a concrete floor and a few benches. There is a drinking fountain with concrete around it that is ADA accessible but does not have an access route leading to it. There is also a trash receptacle and a pet waste bag dispenser and other benches located along the perimeter of the fencing. The benches have backs but do not have arm rests. A picnic table is located in the lawn area near the shelter, and it is not accessible.

The small dog park area does not have an access route and has a pull spicket for the source of water that is located in a lawn area outside the enclosure. There is one trash receptacle and a pet waste bag dispenser both located in lawn areas.

The park has signage regarding the Dog Park Rules located by the parking lot and there is a dog sculpture near the road entrance to the park and other signage within the park.

#### Accessibility Rating: 1

How to improve the rating of this park:

- Add ADA parking spaces and an access route to the paved dog gate entrance.
- Add accessible space within the dog park area and an accessible route to the drinking fountain, trash receptacle and pet waste station.

#### **Turtle Pond Natural Area**

#### Assessment:

This beautiful parcel is 2 acres in size and is located adjacent to Washington Street. Turtle Pond is a nature trail that does not meet ADA requirements. The area is beautiful and contains several boardwalk segments that are laid in place many of these segments require adjustment and repairs. There are two bridges leading over the low lying areas and the remaining non-boardwalk portion of the trail is open and not covered in vegetation although muddy and low lying in areas.

There is gravel parking adjacent to the trail and the trail does not loop back to the parking but exists on the road further to the west.

#### Accessibility Rating: 1

How to improve the rating of this park:

- Add ADA parking spaces and a designated access route.
- Create an accessible route and accessible boardwalk to a viewing area for the pond.

#### A. Introduction

A community's access to resources and activities directly impacts the quality of life of its residents and visitors. Park and recreation facilities engage people in a community and keep them active and healthy while improving their surroundings.

The City of New Buffalo has undertaken this revised plan in an effort to:

- Maintain an updated plan to guide investment in parks, recreation, and open space;
- Assess present community and area recreational facilities and programs;
- Inventory natural areas and open spaces contributing to a green infrastructure network;
- Solicit public input and response regarding parks, recreation, and open space in New Buffalo;
- Identify priority parks, recreation, and open space improvements and acquisitions;
- Establish a course of action for improvements and acquisition for the next five years; and
- Identify potential sources of funding to satisfy the goals of the plan and the needs of residents and visitors.

The City of New Buffalo has developed this plan in accordance with the Guidelines for the Development of Community Park, Recreation, Open Space, and Greenway Plans established by the Michigan Department of Natural Resources (MDNR). In order to retain eligibility for State and Federal park and recreation grant programs, the City must have a current five-year plan approved by MDNR. The purpose of this document is for planning purposes and all elements are dependent upon availability of funding.



## **B.** Community Description

This plan encompasses all parks, recreation, and open space within the city limits (see Map 1). The City of New Buffalo is located in Berrien County, in the southwest corner of the State of Michigan. The city is bordered by Lake Michigan to the west, and is surrounded on three sides by New Buffalo Township. From the Chicago area, New Buffalo is just over an hour away while from South Bend the city is only a 30-minute drive. Likewise, large communities in Michigan such as St. Joseph, Benton Harbor, and Kalamazoo are less than 45 minutes away. The city is approximately two (2) miles from the Indiana State Line.

The City of New Buffalo has an unusually important position in the State of Michigan. Often referred to as the "Gateway to Michigan", New Buffalo is the first city that visitors encounter in the state as they travel from the west on I-94 or US-12. In recognition of this important gateway, the Michigan Department of Transportation constructed its first Visitors Center here. The Visitors Center is now a State Historic Landmark.



The City of New Buffalo not only serves as one of the first locations to welcome visitors who pass through the community to reach other destinations in Michigan; its proximity to large population centers, along with its natural features such as Lake Michigan and the Galien River, attract a large number of tourists and summer residents.

The United States Census count for New Buffalo's population is 1,883 in 2010. This is a 33.2% decline from the recorded high of 2,821 in 1980. The reported population has declined in each decennial census from 1980 until the present. However, from 2000 to 2010 there has been the addition of 266 housing units and an increase in the number of vacant housing units. While the year-round population has decreased, the number of total and vacant housing units has increased. Of the vacant homes, 83% are for seasonal, recreational, or occasional use compared to 75% for 2000. This indicates a growth in the number of seasonal or vacation homes.



New Buffalo's location and its natural features have contributed to the way in which the city evolved. Many homes are in locations that are best suited to take advantage of the natural views and settings offered by this important lakeshore community. A majority of the commercial development, on the other hand, has occurred on major transportation routes.

The physical form of the city is largely a reflection of its lakeside location, its orientation to the Galien River, and the major transportation routes such as US-12, Red Arrow Highway, and the rail lines that connect the community to the larger constellation of cities along the I-94 corridor. New Buffalo's layout follows the traditional grid pattern of most Midwestern cities and towns developed during the mid-1800s. The grid, which is bisected by US-12, is oriented to the lakeshore and consists of condominium development on the lakeshore, modestly scaled residential neighborhoods, and a traditional commercial downtown. While the city is predominantly residential, commercial development is found in the Central Business District, the US-12 corridor,

and on Whittaker Street as it leads from one of two interchanges of I-94 which serve the city. In February 2008, Ordinance 175 took effect which made parks and recreation a use permitted by right in all zoning districts.



Berrien County and New Buffalo have a rich cultural history that predates early European settlement. Historians believe that as glaciers receded, hunters followed the animals into the area. In addition, New Buffalo's location at the base of Lake Michigan and at the mouth of the Galien River also served as an important trading area for Native Americans.

More recently, the pioneer history of the community dates back to the end of the seventeenth century when early French missionaries and explorers first settled the area. In 1679, the French explorer LaSalle discovered the Galien River. The fur trade in the early 1700's was followed by more permanent agricultural based settlements. As development continued in the community, its residents began to learn more about the rich history of the area.

Two (2) registered historic sites exist within or near the city - the Saint John German Lutheran Evangelical Church (pictured) and the Tourist Lodge Informational Center on I-94. The wealth and diversity of natural resources found within New Buffalo and the surrounding area provides an excellent environment for recreation. There are a number of unique ecosystems found within the community that are seldom found in combination elsewhere in the world. The dune ecology found along Lake Michigan, combined with the high quality wetlands alongside the Galien River, further contribute to the diverse ecology in the New Buffalo area.

The varied landscape of the region, in turn, supports a broad range of plant and animal species. In addition, the strategic location of the community is not only important to people, but to migratory birds as well. New Buffalo is located in three different migratory fly-ways. The varied habitats of the area provide ideal settings for birds; the community is a popular destination for avid bird watchers. However, the area is also attractive to geese, which have caused some problems along public walkways near the harbor and lakefront. In 2016, the City introduced a plan using permitted dogs to patrol the waterfront, thusly disturbing the population without harassment or harm.

The estuary of the Galien River and its tributaries serve as important resources to Lake Michigan and the recreational and charter fishing industries of the area. The River and its tributaries provide an ideal setting as a hatchery for a variety of freshwater fish species and provide fishing opportunities during the fall spawning season for salmon and steelhead. The presence of Lake Michigan on the northwestern side of the city is an obvious water resource within the community and the entire state. Lake Michigan is the third largest Great Lake by surface area and the sixth largest freshwater lake in the world. The City Beach provides the primary public access point to the shoreline within the city. There are also several road end access points in New Buffalo and Chikaming Townships.

The Galien River and its large, wooded flood-plain provides natural areas and important wildlife habitat. The river parallels the Lake Michigan shoreline in the eastern half of the community before emptying into Lake Michigan near the City Beach. The river basin or watershed consists of a main branch and a southern branch. The Galien River Watershed is 112, 222 acres in size, with 82,665 acres in Michigan. A watershed does not respect state, county, township, village or city boundaries. Through the efforts of the Galien River Watershed Project, there is a recognition that watershed communities must work together to improve and protect water resources.

The communities in the Galien River Watershed have expressed concerns about water quality and the impacts on public safety, wildlife habitats, and financial livelihoods. The Michigan Department of Environmental Quality (MDEQ) has included several reaches in the watershed on the Clean Water Act, Section 303(d) list for not meeting water quality standards. In consequence, a Total Maximum Daily Load (TMDL) process was initiated. The identified pollutants that are impairing those waters include sediment, nutrients, and bacteria. The Galien River Watershed Management Plan identifies the causes and sources of the pollutants and recommends actions to improve water quality.

Further, the water quality of the ground and surface waters is being threatened by growth and development that does not limit impacts on these water resources. If not

planned carefully, growth and development will cause water currently reaching the river through groundwater to be redirected and reach the river through overland flow via runoff from impervious surfaces. This threatens to change the watershed's flow regime, creating flashy streams and rivers with high flows after storm events. The increased runoff will also increase stream bank erosion and result in more pollutants (sediment, nutrients, etc.) reaching surface waters.

In 2008, Michigan Department of Environmental Quality (MDEQ) provided grant funds to The Conservation Fund and Chikaming Open Lands to preserve and improve the water quality of the Galien River Watershed. Some of the grant funds were used to provide tools and planning assistance to local units of government within the watershed and to purchase conservation easements in the watershed. Over sixty percent (60%) of the wetlands in the Galien River Watershed have been lost since pre-settlement times. There are many remaining wetland areas surrounding and within the city. Remaining wetland areas provide invaluable functions such as flood protection, pollutant removal, and wildlife habitat. The Department of Natural Resources has identified the Galien River Marsh (located just upstream from where the Galien River enters Lake Michigan) as being one of the best fresh water estuaries in the State of Michigan. There are at least fifteen (15) different types of Threatened or Special Concern plants located within this wetland. In addition, large marsh and wooded wetland areas provide sanctuary for migrating waterfowl such as the American Wigeon, Shoveler, Gadwall, Bufflehead, Goldeneye, Green-Winged Teal, and many others.

#### C. Administrative Structure

1. City Council, Advisory Boards, and Commissions


The <u>City Council</u> is responsible for approving the City's Community Park, Recreation, Open Space, and Greenway Plan and decides the parks and recreation budget and policies, with the assistance of four (4) bodies:

The <u>Park and Recreation Board</u> advises the City Council on matters concerning the City's parks and recreational opportunities. They make recommendations to the City Council for improving, planning, and developing outdoor and indoor recreational, educational, and social facilities and programs for the community. It is formed pursuant to the Recreation and Playgrounds Act (1917 PA 156).

The <u>Department of Public Works</u> provides for the operation and maintenance of City owned or controlled parks, recreational facilities, and other facilities as assigned by the City Manager, to enable the public to enjoy recreational amenities and opportunities, while striving to enhance those facilities. Parks maintenance and operations is managed by the Parks Director. Please see the organizational chart on the following page.

The <u>Planning Commission</u> approves long range land use policies for the City, including the Master Plan, and advises the City Council on planning and zoning related issues.

The <u>Harbor Commission</u> advises the City Council on matters related to harbor access and facilities (City Marina, boat launch and federal navigation channel), and acts as the agency responsible for seeking grant funding for harbor improvements.



#### 2. Staff

Under the direction of the City Council, the City Manager and the Parks Director administer all matters concerning City recreational facilities. The City of New Buffalo maintains nine (9) parks, including Turtle Pond Natural Area which is under a conservation lease. The Skate Park is jointly managed with New Buffalo Township and New Buffalo Area Schools. The Recreational Facilities Department is also responsible for the City's Amtrak Station.

Construction projects are authorized by the City Council, and overseen by the City Manager and Parks Director. All construction projects are completed by private contractors under direction from, and under contract with, the City. The City does not administer any recreation programs as of October 2018.

Besides the full-time Parks Director, parks and recreation staff consists primarily of seasonal, part-time employees. During the summer months, individuals are hired as lifeguards, rangers, attendants, and maintenance laborers. Seasonal employees of the City's Recreational Facilities Department perform maintenance of the soccer fields and ball diamonds at Oselka Park.

### 3. Budget and Sources of Funding

Fund for park construction and maintenance are approved by the City Council on an annual basis. Although General Fund monies are frequently used to supplement park revenues, beach parking, boat launching fees, and mooring fees at the Transient Marina primarily fund the park system.

#### b. Other Funds

As can be seen from the above budget, City revenues do not always cover actual or anticipated expenses. Therefore, the City actively seeks funding from sources outside the City. As noted in the next section, the City has received three development grants from the Michigan Department of Natural Resources to develop facilities at the City Beach, the City Boat Launch, and the Transient Marina. The City also investigates private funding programs, such as the Great Lakes Fisheries Trust, for individual projects and monitors both public and private grant funding sources and submits applications for promising programs. The City also seeks individual and corporate private donors.

Another source of funding is the partnership with the Pokagon Fund, a local foundation formed as a result of the casino, which has funded several recreation related initiatives and projects in New Buffalo and the surrounding area. In addition, the City of New Buffalo receives a percentage of casino revenues and can use this towards recreation projects.

The casino places an additional demand on City infrastructure and facilities, particularly with regard to recreation. The thousands of people drawn to the area by the casino require additional lodging, restaurants, and amusements in the area. In terms of public recreation, the need for additional camping and lake access will likely be acute. The agreement between the Pokagon Band and the City and Township guarantees a percentage of casino revenues and foundation grant funding that can be used to improve parks and recreation opportunities. If the experience of other small cities with nearby casinos is any proof, the casino presents a source of funding to meet the challenges of increased population and visitors.

However, The Pokagon Fund and local revenue sharing should not be viewed as an unlimited source of funding. Most casinos are very popular at the outset, but outside forces often militate against long-term success at the same high level. Therefore, plans for recreation facilities, particularly for capital improvements, should be realistic and not rely strictly on gaming related funding. Those items identified in the Action Program that are dependent on the Pokagon Fund or local revenue sharing for funding may need to be re-prioritized if the casino is no longer able to generate sufficient funds.

#### c. Volunteers

The City does not directly operate any recreation programs as of October 2018. Summer baseball and softball leagues are managed by the volunteer-led local foundation New Buffalo Sports, Inc. Volunteer committees manage other programs that take place on parks grounds, such as the Ship and Shore Festival, Harvest and Wine Festival, New Buffalo Community Picnic, and Apple Cider Century. The Oselka Park concession stand is operated by volunteers representing the group using the facility for fundraising during events, in particular Bison Band Boosters runs concessions during home varsity football games.

#### d. Relationships with Other Agencies

The City is continually exploring ideas to improve relationships and develop collaborative and cost-saving partnerships with the New Buffalo School District, New Buffalo Township, and the Pokagon Band of Potawatomi Indians to provide recreation programming and facilities. Currently the City works cooperatively with New Buffalo Area Schools and New Buffalo Township to operate the Skate Park. Further, the City has been active in the development of the Harbor Country Hike and Bike Plan which was funded by the Pokagon Fund. The City Council also appoints a council member to serve on the Friends of Harbor Country Trails Board of Directors which is a non-profit grassroots organization tasked with the implementation of the Harbor Country Hike and Bike Plan.

## D. Recreation and Resource Inventory

An inventory of the recreational facilities located in and near the City of New Buffalo was conducted by on-site visits to the facilities. The City of New Buffalo owns and operates Oselka Park, City Beach, Boat Launch, Lion's Pavilion Park, Riverfront Park, Transient Marina, and Sari Asher Memorial Park. The City leases the Turtle Pond Natural Area from a private landowner. The City works cooperatively with New Buffalo Area Schools and New Buffalo Township to operate the Skate Park.

The park classification corresponds to the classification system in Appendix B of the Guidelines for the Development of Community Park, Recreation, Open Space and Greenway Plans published by the Michigan Department of Natural Resources in June 2018. Accessibility at each park was reviewed by Abonmarche Staff in September 2018 by comparing it to the 2010 ADA Standards for Accessible Design. The number listed in the **Accessibility Rating** column (also taken from the Guidelines) is as follows:

- 1. None of the facilities/park areas meet accessibility guidelines
- 2. Some of the facilities/park areas meet accessibility guidelines
- 3. Most of the facilities/park areas meet accessibility guidelines
- 4. The entire park meets accessibility guidelines
- The entire park was developed/renovated using the principles of universal design





# Non-Motorized Road and Trail Inventory

Trails, paved shoulders on streets, bike lanes, and sidewalks are not only important for transportation, but also provide recreational opportunities for walking and biking. These facilities bring numerous benefits to a community. The benefits are very diverse and include advantages in economic, social, environmental, health, and overall quality of life.

The streets of our cities are an important part of the livability of our communities and ought to be for everyone, whether young or old, motorist or bicyclist, walker or wheelchair user, bus rider or shopkeeper. New Buffalo City instituted a Complete Streets program ensuring that road projects are designed with all users in mind - including bicyclists, public transportation vehicles and riders, and pedestrians of all ages and abilities.

In 2018, sidewalk access to Oselka Park was greatly improved with a 3.3 mile Safe Routes to Schools project. The \$600,000 project included sidewalk installation along city streets and was funded by the Michigan Fitness Foundation, MDOT, and the City of New Buffalo. These additional sidewalks and safe crossings helped increase connectivity between Oselka Park, the schools, and residential areas of the city.

In 2011, the Southwest Michigan Planning Commission completed a non-motorized plan for southwest Michigan which includes Berrien and eight (8) other counties in the Michigan Department of Transportation's southwest region. There are just over 800 miles of roads with non-motorized facilities in southwest Michigan, with 100 miles in Berrien County.

Local priority routes for bicycling near New Buffalo include US Bike Route 35, connecting to the Marquette Greenway in Indiana and paved shoulders on the entire length of US 12.

### a. Marquette Greenway Trail

The Marquette Greenway Trail is a non-motorized trail under development that travels from Chicago to the Indiana border. A 3.8 mile portion of the trail is proposed for continuing into downtown New Buffalo with a trailhead in the city limits. Future extensions would see the trail continue even further into Michigan. One 12 mile stretch of trail is also proposed from New Buffalo to Bridgman along Red Arrow Highway.

### b. U.S. Bike Route 35

Designated in 2012, USBR 35 is a mapped bicycle route intended for experienced long distance touring bicyclists. It is not a trail and no construction is proposed related to this route. It is meant to be a mapped recommendation as the best route to ride a bicycle long distance along the Lake Michigan coast from New Buffalo to Sault Ste. Marie. USBR 35 attracts bicycle tourists from near and far, providing economic, social, and health benefits to the communities that the route intersects. Approximately 500 miles in length, the route passes through dozens of small lakefront towns, past sandy beaches, scenic and historic destinations, as well as services and cultural attractions. 



# NBAS Nature Study Trails (source: www.naturestudytrails.com)


Our Interpretive Trails and Nature Walks are a part of the Holbrook Creek Watershed (also known as Lighthouse Creek) and pass through prime examples of dune forests and interdunal wetlands. There are over 4.5 miles of trails with markers and plaques scattered along the paths that relate to their natural history. A portion of the trails has been identified as a cross country ski trail in the winter and a 5k course for Cross Country meets has been plotted.





## **Turtle Pond Nature Preserve**

The New Buffalo Turtle Pond Nature Preserve has a 0.15 mile walking trail complete with boardwalks and on-site parking. The trail meanders around and over a natural pond which hosts a wide variety of wildlife. Turtle Pond is only one block away from Nature Study Trails.




## Sesquicentennial Historical Walking Tour

This route highlights sites of historic significance located in the central business district. The sites are marked by bronze plaques.




### e. Harbor Country Hike and Bike Plan

In 2008, a group of individuals representing interests in the New Buffalo area came together to form a vision for connected on-road and off-road facilities for Chikaming Township, City of New Buffalo, New Buffalo Township, Three Oaks Township, Grand Beach, and the Village of Three Oaks. The Harbor Country Hike & Bike Trail project is a long-term comprehensive project to bring a network of interconnected non-motorized facilities to the corner of Southwest Michigan known as Harbor Country. When complete, the Hike & Bike Trail project will offer bicyclists and hikers the ability to connect between New Buffalo, Three Oaks, Sawyer, Grand Beach, Harbert, Union Pier, Michiana, and points in between using safe, convenient, attractive paths and shared access ways. 
The Friends of Harbor Country Trails is working to implement the Hike and Bike Plan. The Friends group recently worked with the Berrien County Road Commission to install bike signage and five foot shoulders along Maudlin Road. Currently the Friends group is working with the City of New Buffalo on the Proposed Pere Marquette Railside Greenway Trail which would connect New Buffalo Elementary School and the High School/Middle School campus via a three-mile non-motorized trail. This project provides for multiple in-town connections and utilizes somewhat natural areas or at least undeveloped portions of the city for a more tranquil pathway system. The city has reconstructed Whittaker Street in 2018 which also provides a central spine to connect for walkers and bicyclists. The City of New Buffalo passed a resolution supporting the development of the trail in 2012.



### f. Trail Town Master Plan

The "Lake Michigan Coastal Communities Trail Towns Master Plan" is designed to better leverage and maximize the economic potential of trail-based tourism within the community. The primary focus was on the Lake Michigan Water Trail with consideration given to terrestrial trails and access sites. A conceptual site plan (see page 20) and other improvements are discussed for the City Boat Launch as a water trailhead. The plan was developed by Land Information Access Association (LIAA) and funding was provided through the Michigan's Coastal Zone Management Program (CZMP) and the Southwest Michigan Planning Commission. A map of the Coastal Zone Management Boundary and Area is below. The CZMP supports wise management of the cultural and natural resources along the lakeshore for healthy and productive coastal ecosystems and communities.

### g. Water Trail Inventory

## Lake Michigan Water Trail

The Lake Michigan Water Trail is a designated National Recreation Trail, as sanctioned by the U.S. Department of the Interior. It will offer safe, legal and adequate access around the entire 1,200 mile long lakeshore of America's Greatest Lake, Lake Michigan. The trail will be the longest continuous-loop water trail in the world. In 2011, 75 miles (from Chicago to New Buffalo) was designated as the Lake Michigan Water Trail National Recreation Trail by the National Parks Service. ### Galien River Marsh Water Trail

The Galien River Marsh Water Trail is approximately three miles between the Department of Natural Resources (DNR) boat launch on U.S. 12 (near Kruger Road) and the City of New Buffalo's public boat launch. The trail meanders through woodlands and marsh, including the 156-acre Louis J. Sima Great Lakes Marsh and the 86-acre Galien River County Park Preserve, as well as by a number of privately-owned residential properties, before arriving at the City's harbor and, ultimately, Lake Michigan. Brochures and a sign showing the way along the Water Trail are located at the DNR boat launch, courtesy of Chikaming Open Lands, the American Electric Power Foundation, the National Park Service, and the Michigan DEQ.



# 6. Open Space and Greenway Inventory

There are features in any community that many residents would readily recognize as important to the character of the area and to their personal quality of life. Some of these features may be cultural, such as a downtown business district, historic buildings, lighthouses, or other similar man-made features. Other features used to connect a community to its residents will be natural resources such as lakes, woods, wildlife, scenic views, and other similar features. How these elements are integrated in the fabric of a community can have a profound influence on their value. Clearly there are some resources, which if lost, would significantly detract from the environment and the community as a whole.

Natural features such as native vegetation, woodlands, wildlife habitat, and wildlife corridors add to the natural features that attract people to the New Buffalo area. Degrading these natural features will not only alter the landscape of a community but it can also lead to water quality issues such as increased runoff, erosion, and flooding.

The Potential Conservation Areas map represents the last remaining remnants of the area's ecosystems and natural plant communities. The map ranks areas where the landscape is dominated by native vegetation that has various levels of potential for harboring high quality natural areas and unique natural features. These areas provide critical ecological services such as maintaining water quality and quantity, soil development and stabilization, habitat for pollinators of cropland, wildlife travel corridors, stopover sites for migratory birds, sources of genetic diversity, and floodwater retention.

The City is surrounded by large areas of some the highest ranking natural areas in southwest Michigan. It is to a community's advantage that these sites be carefully integrated into the planning for future development. This information can be used to create a connected system of green infrastructure. Striking a balance between development and natural resource conservation and preservation is critical if the New Buffalo area is to maintain its unique natural heritage and offer a high quality of life for residents and visitors.

Green infrastructure is a connected network of natural areas and other open spaces planned and managed to conserve natural ecosystems and the services that they provide. These lands provide multiple benefits to people and wildlife such as maintaining clean air and water, providing areas for recreation and providing wildlife habitat. Green infrastructure elements can be in urban, suburban and rural areas and may or may not be open to the public. Green infrastructure is essential to the health, safety and welfare of the area residents.

Natural resource conservation is a fundamental component of a community's longterm environmental and economic health. Communities that incorporate both the built and natural environment into their future land use map or vision will ensure that the areas that provide important natural functions such as filtering drinking water supplies, recreational opportunities for residents and habitats for wildlife, will be protected. In effect, the features that the community has grown to enjoy will be there for generations to come. A community with a clean environment, clean water, green spaces and trails will be the community that has a stable, sustainable future and offers a high quality of life for its residents and visitors. Communities that provide this high quality of life will be able to retain talented workers and attract new residents and businesses.

# 7. Recreation Programs, Events, and Activities

There are no recreational programs organized by the City of New Buffalo as of September 2018, though discussions are underway to develop low-or no-cost programs through the New Buffalo Park and Recreation Board. Organized baseball, softball, and other programs are administered on an individual basis through area churches, schools, businesses, and recreation organizations. ### New Buffalo Public Library

A variety of excellent programs are offered at the New Buffalo Public Library for all age groups.

### New Buffalo Railroad Museum

Located on South Whittaker in New Buffalo, the Museum was established to highlight the role the railroad played in the area's development and offers a map of a historical walking tour.

### **Boat Charters**

There are several charter operators providing service from New Buffalo Harbor. They include: Oselka Marina Power Boat Cruises, Salmon Hunters Fish Charters, and New Buffalo Sail Excursions.

### <u>Lodging: Hotels, Inns, Bed and Breakfasts and Vacation Rentals</u>

The attractiveness of the New Buffalo area to tourists has encouraged the success of area lodging options.

### Harbor Country Chamber of Commerce

Promoting Local businesses, tourism and economic development in Southwest Berrien County. Visit their office at the corner of Three Oaks Road and Warren Woods Road.

### Local Color Gallery

This art gallery in Union Pier offers a series of week-long children's summer classes in sculpting, clay, painting and drawing. They also founded and organize the Art Attack even in April.

### Shopping at Union Pier

Union Pier is full of small art galleries, unique boutiques, and antique furniture shops. This area located in Union Pier attracts many of the area's seasonal residents and tourists.

### Four Winds Casino

Four Winds Casino Resort is located just off I-94 in New Buffalo Township. The Four Winds Casino is over 130,000 square feet with 3,000 slot machines. Connected to the casino is a hotel with 165 rooms and there are several dining options available on the property.

### Blue Chip Casino, Lighthouse Place, and Other Attractions in Michigan City

The Blue Chip Casino in Michigan City, Indiana offers various games of chance as well as live entertainment on weekends. Lighthouse Place, also located in Michigan City is a large, successful retail outlet mall that attracts shoppers from long distances.

# E. Description of the Planning and Public Input Process

# 1. Statement of Public Representation

The methods used for soliciting public input included an online survey, review and public comment period for the draft plan, and a public hearing held by City Council. These were broad enough to represent the community at large. Participants included members of the public at all age and socioeconomic levels as well as key stakeholders in parks and recreation programs within the City.

# 2. On-Line Survey

An online survey was conducted in September and October of 2018. The survey contained several questions pertaining to recreation, open space, and parks. There were 286 total responses of which 55% were full-time residents, 26% were part-time residents, 17% were residents of neighboring communities, and 2% were non-residents/visitors. The full results and comments can be found in the Appendix.

# 3. Public Hearing and Public Review

The final draft of this Plan was made available at the New Buffalo Township Public Library and New Buffalo City Hall from October 19, 2018 to November 19, 2018. It was also available on the City's website. A notice of availability to review the plan was published on the City's main webpage on October 19, 2018. The notice was also posted to their Facebook page and in the New Buffalo Times. Following the public review period, the New Buffalo City Council held a public hearing on the Plan on November 19, 2018. A copy of the public notice for the public comment period and public hearing is in the Appendix, as well as the minutes from the hearing. Two comments were received during the comment period and are included in the Appendix. There were no public comments during the hearing. The City Council approved the plan on January 22, 2019. A copy of the resolution of approval is in the Appendix.

In accordance with MDNR requirements, copies of the final plan were transmitted to Berrien County and to the Southwest Michigan Planning Commission. Copies of the transmittal letters are in the Appendix.

# F. Mission, Goals, and Objectives

The information gleaned from the public input process was evaluated and used to formulate a mission, goals and objectives. These goals form the basis of the Action Plan in the next chapter.

**Mission:** The mission of the Park and Recreation Board is to plan, maintain, develop and acquire, in cooperation with surrounding municipalities, school district, county, state and all interested individuals and groups, a responsive, safe, environmentally sensitive, efficient and innovative community recreation system available to all citizens, seasonal residents and visitors with consideration of age and abilities.

# Goals and Objectives

- 1. Maintain and improve the community recreation system.
  - a. Eliminate **non-barrier free conditions** in the park system when improvements occur.
  - b. Increase marketing efforts and use consistent **signage and way-finding** elements to improve/increase recreational tourism.
  - c. Ensure all maintenance and improvement activities are sensitive to and protect sensitive lands, water quality and historic and cultural resources.
  - d. **Annually evaluate** the progress of Action Plan implementation
- 2. Develop additional recreational opportunities to meet the current and future needs and desires of the community with a geographical balance along with safe and convenient access.
  - a. Develop a non-motorized system (including bike lanes, sidewalks, off-road separated paths, water trails, trail heads, etc.) to connect residents, businesses and recreation resources (locally and at the county and regional level).
  - b. Offer **recreational programming** opportunities in coordination with neighboring communities and other partners.
  - c. **Acquire land** or secure conservation easements to expand the recreation system as needed (such as to increase contiguous public land holdings, protect natural resources, increase accessibility to water resources and provide additional recreational opportunities that are geographically balanced in the community)
  - d. Ensure **year-round activities** are available.
  - e. Ensure all new facilities are barrier-free.
- 3. Enhance partnerships and relationships with residents (full-time and seasonal), tourists, youth and adult sports leagues, local businesses, agencies, community organizations, neighboring municipalities, Pokagon Band of Potawatomi, Berrien County and the State of Michigan.
  - a. **Involve the community** in anticipating recreational needs and determining priorities.

- Utilize City, Township and School District facilities to provide year round indoor and outdoor recreation programming and opportunities.
- c. Increase collaboration and **develop partnerships** to fund park improvements and additional recreation opportunities (facilities and programming).
- d. Use local funds to leverage State and/or federal grants.

# **G. Action Program**

The following Action Program is intended to implement the Goals and Objectives over the next five (5) years. A number of recreation needs have been identified in conjunction with City staff and officials and through the public input process. The needs identified are distributed among improving and expanding existing facilities and programs and acquiring or developing new ones. The City of New Buffalo hopes to initiate the following improvements as funding and planning allow.

#### **Public Comments Received during Comment Period**

Although the new Parks and Recreation plan has many ambitious and exciting improvements that would greatly enhance a city located in an ideal location next to Lake Michigan, the budget information is very concerning and reflects a government leadership that does not put parks and recreation as a priority.

The Parks Budget reflects a \$145,000 revenue reduction from FY 2015/16 to 2019/20. The reduction from the general fund from 2015/16 to 2019/20 is \$95,000 leaving only a \$30,000 allocation in 2019/20. This helps the Council members with their goal to carry a surplus in the general fund but reflects a disinterest in improving our parks.

The Parks Budget also shows a \$31,345 actual decrease in parking lot fees from 2015/16 to 2016/17 with a \$20,000 decrease goal for 2019/20. This is after increasing the daily parking fee from \$10 to \$12 in late 2016. The decrease from 2016 to 2017 came after the city employees changed the cash collection policy in late 2016 that allows them to count cash at the beach in a truck instead of direct deposit at the bank. This policy should be changed back as it might be impacting beach parking revenues.

By the 2019/20 budget, the lifeguard line item is blank. While the Parks and Recreation plan shows strong community support for a lifeguard program that safeguards residents and visitors, the City Council evidently puts no value in that program. Establishing a surplus in the general fund appears to hold top priority instead of allocating funds for popular community programs

It appears that former general fund expenditures are being pushed into the Parks Improvement Fund. This is a voter approved millage fund with specific ballot language that legally requires it to be used for parks improvements only. Since FY 2016/17, the City Council shifted from the general fund to the Park Improvement Fund both the maintenance/purchasing of park equipment \$154,530 and dredging the river \$143,376. These two line items reflect \$297,906 or 60% of the total collection in a five year time period of voter restricted park improvement millage funds. This leaves only 40% of the funds going for actual park improvements. It is illegal for the City to move voter restricted funds from the fund approved by the voters to another fund that is routinely paid through general funds.

The City Council is also increasing the fees for boat launching this coming year. Instead of increasing user fees and transferring expenditures to the Park Improvement Fund, the expenditures should be from the general fund. We are a community dependent on our recreation and beach front so it makes sense to keep user fees low and provide popular programs like lifeguards for our local residents whose taxes should be used for services and programs that serve them. Instead the Council members appear interested in creating a surplus in the general fund that they can use for their pet projects. The residents voted through a millage for parks improvements three times, the council could at least ensure those funds are placed where they are intended. A park and recreation plan requires a commitment from the elected officials, this can be accomplished by replenishing both the Park Fund and the Park Improvement Fund.





### Q1 Which of the choices represents your residency in New Buffalo?





### Q2 What is your age?






## Q4 Does anyone in your household have special accessibility needs for park amenities?





## Q6 How much should the City of New Buffalo encourage parks and public open space development?








### Q9 Level of personal safety felt in the parks during the day?












# Q11 Would you favor an improved bike network (either non-motorized or on-road facilities) through New Buffalo?





# Q12 Would you favor an improved/ expanded trail system for walking and hiking?









# Q15 If parking at the City Beach was full, how likely would you be to park at an off-site lot with a shuttle if it was available?










### Q23 What is your gender?

# Q24 How many children are you parent or guardian to and live in your household (aged 17 or younger only)?





# Q33 Would you favor an improved bike network/trail system (either non-motorized or on-road facilities) through the New Buffalo area?









### Q67 How does New Buffalo Transient Marina compare to other transient facilities in Lake Michigan Harbors?




### Q68 What marina amenities are most important to you as a transient boater? Pick up to three.
