Mayor Wilson said that we will have a long process. The city has had ups and downs in income. We have additional developers developing in the area. One employee is not enough to handle all the growth. We need to make sure that all permits cover costs. The city will have many tax input meetings before the city will put a tax in place. Councilman Johnson said that we need to know what we are going to need in our budget right now and not 5 years from now. Motion seconded by Councilwoman McPherson. Motion passed by all Councilman White, Johnson and McPherson. Valuations will be coming soon before July 1st. We will have something in place by August.
