### ITEM NUMBER III. NEW BUSINESS:

A. <u>Discuss, consider, and act on an amendment to our financial policies.</u>
General Fund Minimum Reserve Policy

The City of New Fairview shall maintain an unrestricted minimum General Fund reserve of 25% of the city's annual general fund expenditures. The General Fund reserve is limited to one-time uses, meaning that any use of the General Fund reserve would have to be rebuilt over time. If there is no "new" source of revenue to replenish the General Fund reserve, the city must develop and/or amend the budget to replenish the established minimum reserve.

City Administrator Ben presented to council the financial policies that were adopted in June 2020. There is rules and guidelines that we have to follow. Best practice is 25% in 90 days. The city will save money and not have to pay a lot of interest. The financial policy will be part of the budget and will be on the website. Councilman Clements made a motion to amend the financial policies as stated. Motion seconded by Mayor Pro Tem Patrick Gunter. Motion passed unanimously.
