REGULAR SESSION: 7:00 PM

- 1. Call to Order and roll call. (Mayor Nolan Schoonmaker called the meeting to order at 7:00 pm; Roll call with the above-mentioned names present.)
- 2. Pledge to the flags.

 - B. Texas Flag Honor the Texas Flag, I pledge allegiance to thee, Texas, one state under God, one and indivisible
- **OPEN FORUM:** The City Council invites persons with comments or observations related 3. to city issues, projects, or policies to briefly address the City Council. Anyone wishing to speak should sign-in with the City Secretary before the beginning of the City Council Meeting. In order to expedite the flow of business and to provide all citizens the opportunity to speak, there is a three-minute limitation on any person addressing the City Council. State law prohibits the City Council from discussing or taking action on any item not listed on the posted agenda. (Phillip Harrison - maintenance of roads seems to run out prior to getting to Latham Lane; Steven King - the Council wants to raise taxes for water, EMS, streets but this is through bonds, large amounts of debt - we need to save money and vote no on taxes; Nema House - new citizen and enjoy country life and believe that Falcon Ridge pays the majority of taxes with no benefits; Billy Lee - why no notice of tax increase, this will be hard for many people, plan for the growth increase over the next 10-years; Jimmy Royston - live in Falcon Ridge, opposed to any tax increase, the water pipe will always have to be bigger; Vicki McNeil - this will impact those on fixed incomes, blames the city admin, people will not come to New Fairview with this tax rate, referenced claims of financial fraud, and asked why we would go into debt for new development; Scott Johnson - former council member who voted for the first property tax, scared by what is being considered by the new Council, nobody can afford a 3X increase in taxes and has no idea what the new funding would cover; Harvey Burger - what's going on at city hall, there is no trust, most people moved here for no taxes.)
- NEW BUSINESS: All matters listed as New Business will be discussed and considered separately.
 - A. Conduct a public hearing and consider an Ordinance adopting the revised budget for the fiscal year ending September 30, 2021, adopting the proposed operating and capital budget for the fiscal year ending September 30, 2022, including an investment policy, financial procedures, and debt management policy.
