Anyone wishing to speak should sign-in with the City Secretary before the beginning of the City Council Meeting. In order to expedite the flow of business and to provide all citizens the opportunity to speak, there is a three-minute limitation on any person addressing the City Council. State law prohibits the City Council from discussing or taking action on any item not listed on the posted agenda.

(**Council members reviewed the nine applications from community members willing to serve: Luis Cordova, Scott Johnson, John Judge, Vicki McNeil, Thaddeus Niestewski, Jimmy Royston, Anna Thacker, and Arne Wissman; Councilwoman Cindy Poe made a motion for Arne Wissman but there was no second; Councilman Steve Misner made a motion for Vicki McNeil and was seconded by Councilwoman Julie Burger (votes in favor Julie Burger and Steve Misner, opposed John Taylor, Cindy Poe, and Nolan Schoonmaker); Councilman Steve Misner made a motion for Jimmy Royston and was seconded by Councilwoman Julie Burger (votes in favor Julie Burger and Steve Misner, opposed by John Taylor, Cindy Poe, and Nolan Schoonmaker);**

Councilman John Taylor made a motion for Scott Johnson which was seconded by Cindy Poe (votes in favor John Taylor, Cindy Poe, and Julie Burger, opposed by Steve Misner); Scott Johnson was appointed to fill the vacancy).
