1. Call to Order and roll call. **(Regular Session called to order by Mayor Nolan Schoonmaker at 7:00 pm; Roll call with the above-mentioned names present.)**
2. Pledge to the flags. **(Mayor Nolan Schoonmaker led the pledges of allegiance to the United States and Texas Flags.)**
3. **EXECUTIVE SESSION:** The Council will conduct an executive, or closed, session pursuant to Section 551.074 (Personnel Matters) and Section 551.071 (Consultation with Attorney) of the Texas Government Code to (i) deliberate the appointment, employment, evaluation, duties, discipline, or removal of the City Secretary and (ii) discuss legal matters and potential legal issues related to the same. **(Adjourned to Executive Session at 7:02 pm; Adjourned to Regular Session at 8:52 pm)**
4. **OPEN FORUM:** The City Council invites persons with comments or observations related to city issues, projects, or policies to briefly address the City Council. Anyone wishing to speak should sign-in with the City Secretary before the beginning of the City Council Meeting. In order to expedite the flow of business and to provide all citizens the opportunity to speak, there is a three-minute limitation on any person addressing the City Council. State law prohibits the City Council from discussing or taking action on any item not listed on the posted agenda. **(No public comments.)**
5. **NEW BUSINESS:** All matters listed as New Business will be discussed and considered separately. **(Called Regular Session back to order at 8:59 pm)**
 - A. Consider action on a resolution removing the City Secretary for lack of confidence as allowed under Texas Local Government Code, Section 22.077(b). **(A motion was made by Councilman Steve Misner to table this item until the next meeting; the motion was seconded by Councilman Scott Johnson; Mayor called for a vote, resulting with two in favor and three in opposition of tabling the item; Mayor Schoonmaker asked for other motions and received none.)**

Vote: 2 in favor; 3 in opposition; 0 abstained
Result: Motion to table failed; no additional motions made, no action was taken on the item.
