- 1. Call to Order and roll call. (Regular Session called to order by Mayor Nolan Schoonmaker at 7:01 pm; Roll Call with the above-mentioned names present.)
- 2. Discussion of all items on the agenda.
- 3. Work Session discussion items:
 - A. Receive an update and presentation from Dr. Warren, the Northwest ISD Superintendent. (Dr. Warren presented the current state of NISD and how they are progressing on the bond program for new facilities. He invited the Council to participate in the recruitment process for his replacement.)
 - B. Discuss with staff and provide feedback on the City Secretary position profile. (The City Council reviewed the City Secretary position profile and discussed reducing the qualifications and experience to be considered; following the discussion, the Council approved the position profile as presented.)
 - C. Discuss with staff the 2021 Streets Improvement Project. (Staff presented the current status of the streets improvement project, the TxDOT FM 407 feasibility study, and the funding shortfall to complete the whole project as originally bid out; staff referenced potential solutions for this under the regular session items C and D.)

- 7. OPEN FORUM: The City Council invites persons with comments or observations related to city issues, projects, or policies to briefly address the City Council. Anyone wishing to speak should sign-in with the City Secretary before the beginning of the City Council Meeting. In order to expedite the flow of business

and to provide all citizens the opportunity to speak, there is a three-minute limitation on any person addressing the City Council. State law prohibits the City Council from discussing or taking action on any item not listed on the posted agenda.

- 8. **NEW BUSINESS:** All matters listed as New Business will be discussed and considered separately.
 - a. An ordinance of the City of New Fairview, Texas, adopting and enacting a new code of ordinances; providing for the repeal of certain ordinances not included therein; providing a penalty for the violation thereof not exceeding \$500 generally or not exceeding \$2,000 for violations relating to fire safety, zoning or public health and sanitation or not exceeding \$4,000 for violations relating to dumping of refuse; providing for the amendment of such code; and providing when such code and this ordinance shall become effective.

b. An ordinance of the City of New Fairview, Texas, providing for a change in the municipal contributions to the current service annuity reserve at retirement of the employees of the City of New Fairview, Texas. (Staff informed the Council that they approved and appropriated the funds for this in the most recently adopted budget; TMRS requires an updated ordinance to reflect the changes; Council Members Burger and Misner stated that the Council should hold off on this action until the next fiscal year, while the remaining Council members stated that it was already approved in the budget.)

Discuss, consider, and act on a resolution of the City of New Fairview, Texas, amending the Council adopted fee schedule to include commercial safety inspection fees, establish the inspection schedules and criteria, and authorize the City Administrator to enter into agreements with East Wise Fire Rescue and Modern Geosciences to provide the commercial safety inspection services. (Staff asked to combine the discussion of items C and D due to their relationship in being able to help fund the streets funding shortfall, provide needed equipment to implement the commercial safety inspection program, and provide improved public safety operations without impacting the tax rate; Council agreed to discuss the items together.)

d. Discuss, consider, and act on a resolution of the City Council of the City of New Fairview, Texas, regarding a financing agreement for the purpose of procuring a hot box, crack seal unit, seal coat unit, a trailer, vehicles, and safety inspection equipment. (Staff presented an opportunity to use currently budgeted dollars for the maintenance of streets in the bond funds, as well as purchase of streets improvement and public safety equipment to help fill the gap for streets improvement by financing the equipment over a four-to-six-year timeframe; the cost of borrowing (\$33K to \$42K) would be much less than the cost of the

interest on the loan and mobilization fees (approximately \$175K) for construction crews to return and complete the project at a later date; staff explained that the funding method would allow the City to meet three of its primary goals, improve streets, improve public safety, and efficient use of public funds without impacting the tax rate; staff informed the Council that if they did not provide the necessary tools and resources (funding) that it was likely that street(s) would have to be pulled from the 2021 project and that the the commercial safety inspection program would not be able to be implemented; staff informed the Council that they would bring back a list of streets for their consideration and selection for the removal from the 2021 project.)
