5. Discuss, Consider, Act on making an exception to the Travel Trailer/Motor Home ordinance to allow a 6-month Hardship permit on Graham Road.

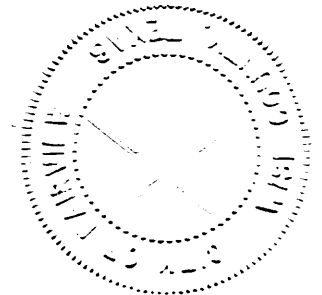

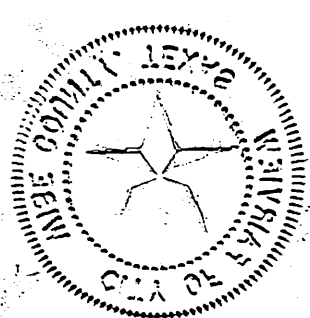
