## REGULAR SESSION

- 1. Call to Order and Determination of Quorum
- 2. Pledge to the Flags.
  - A. United States of America
  - B. Texas Flag Honor the Texas Flag, I pledge allegiance to thee, Texas, one state under God, one and indivisible.
- 3. <u>Public Comment:</u> The City Council invites persons with comments or observations related to city issues, projects, or policies to briefly address the City Council. Anyone wishing to speak should sign-in with the City Secretary before the beginning of the City Council Meeting. In order to expedite the flow of business and to provide all citizens the opportunity to speak, there is a three-minute limitation on any person addressing the City Council. State law prohibits the City Council from discussing or taking action on any item not listed on the posted agenda.
- 4. <u>Consent Agenda:</u> All matters as Consent Agenda are considered to be routine by the City Council and will be enacted by one motion. An item can be removed from the consent agenda by the City Administrator, Mayor, or any member of the City Council and will be considered after approval of the consent agenda.
  - A. Approve the City Council Meeting minutes for July 18, and Joint Meeting with Planning and Zoning for July 18.

- B. Approval of the July 2022 Financial Reports.
- 5. New Business: All matters listed in New Business will be discussed and considered separately.
  - A. Receive, consider, and act on a Resolution calling Special Meetings on August 29, and September 12, and re-scheduling the September 5 Regular Meeting to September 6, 2022.
  - B. Hold a public hearing regarding an amendment to the City's TxCDBG Contract CDV21-0100.
  - C. Receive and consider the Section 3 requirements as required for the City's TxCDBG contract CDV21-0100.
  - D. Receive, consider, and act to approve a Resolution regarding Civil Rights and related policies for the City's TxCDBG program.
  - E. Receive, consider, and act to approve a Resolution approving an amendment to the City's TxCDBG Contract CDV21-0100.
- 6. Executive Session: Recess to Executive Session to discuss matters relating to real property pursuant to §551.072, Texas Government Code; deliberation of economic development negotiations pursuant to §551.087, Texas Government Code; discuss personnel matters pursuant to §551.074, Texas Government Code; discuss IT network or critical infrastructure security pursuant to §551.089, Texas Government Code; and to consult with the City Attorney pursuant to §551.071, Texas Government Code. The Council may go into closed session for any matter on the agenda at any time, when permitted by Chapter 551, Texas Government Code or Chapter 418, Texas Tax Code. Before going into closed session, a quorum of the Council must be present, the meeting must be convened as an open meeting pursuant to proper notice, the presiding officer must announce that a closed session will be held and must identify the sections of Chapter 551 or 418, Texas Government Code authorizing the closed session.
- 7. <u>Return to Open Session:</u> Discuss and take appropriate action, if any, resulting from the discussions conducted in Executive Session.
