Law Enforcement Services

DESCRIPTION:

Receive a report and hold a discussion regarding law enforcement services, challenges, and opportunities in the city.

BACKGROUND INFORMATION:

Currently, the City contracts with three Wise County Sheriff Office (WCSO) deputies, under the Resident Deputy Program. Each deputy is contracted to work no more than twenty (20) hours per week, but their work hours vary based on their availability. The deputies work for the City during times they are not scheduled to work for the Sheriff Department. Unfortunately, this leaves gaps of law enforcement coverage for the city.

There have been some complaints from residents lately regarding noise ordinance violations, with parties in residential areas. Unfortunately, if this type of violation is taking place and there is not a resident deputy working, the WCSO will still respond to any complaints called into the public safety answering point (PSAP), however WCSO deputies cannot enforce city ordinances. Staff is working with Sgt. Scheps with WCSO, and one of our resident deputies, on coming up wit a solution on being able to use the WCSO incident report on any noise violation as the "complaint" for the filing of a citation after the fact.

There is also the option of contracting with another municipality, through an Interlocal Agreement (ILA), for law enforcement services from their police department. This is a common model used by smaller cities next to larger cities that have the resources and capacity to provide this type of service. Locally, the City of Aurora is in the process of trying to contract with the City of Rhome for law enforcement services. There are pros and cons when entering into these types of ILA's, but the cost for this type of service will be more than what is currently being budgeted for law enforcement services under the resident deputy program.

This item was requested by City Council.

FINANCIAL CONSIDERATION:

In the Fiscal Year 2022-23 Public Safety Budget, \$44,000 has been approved for paying for the contract law enforcement services.

2023-24 Texas CDBG Grant Administrator

DESCRIPTION:

Receive, consider, and act on a Resolution authorizing the submission of a 2023-2024 Texas Community Development Block Grant (TxCDBG) application to the Texas Department of Agriculture, and authorize the city administrator to negotiate a contract with GrantWorks to act as the City's grant administrator for this grant.

BACKGROUND INFORMATION:

Staff is interested to know if the City Council would like to consider applying for the next round of Texas Community Development Block Grant (TxCDBG) funding from the Texas Department of Agriculture (TDA) for road projects in Chisholm HIIIs. This round of grant funding is for up to \$500,000 and requires a local match from the City of \$10,000 up to \$25,000.

If you recall, in 2021 the City was awarded a TxCDBG grant (CDV21-0100) in the amount of \$350,000 for the reconstruction of Wilson Ct. and Creasser Lane. The City Council has contracted with JR West Texas Construction to do the drainage work for this project for a total of \$426,991.50. The City is waiting on final approval from TDA so that the drainage work can proceed.

In preparation for another TxCDBG application, staff developed and sent a TxCDBG Phase Two Solicitation for Administrative Services Request for Project-Specific Proposal (Form A506) to four Pre-Qualified Administrators on the Texas Department of Agriculture (TDA) Approved Vendor List. We received two responses and a review team made up of the Mayor, Mayor Pro Tem, City Administrator, and City Operations Administrator was established to review the submissions. Based on the following evaluation criteria: Experience (30 points), Prior Work Performance (30 points), Capacity to Perform (20 points), and Proposed Cost (20 points), the review team recommends the City Council approve GrantWorks for the City's TxCDBG grant administrator on this application. If the City moves forward with the TxCDBG application, staff will work with residents in Chisholm Hills subdivision to complete a community survey that will be used to identify areas that meet the Low Income/Low -Middle Income (LI?LMI) levels for application of the TxCDBG.

Staff recommends approval of the resolution.

FINANCIAL CONSIDERATION:

In their proposal, GrantWorks is willing to negotiate the Cost and Scope of Services before final selection, as TDA allows. Their proposed fee is \$34,400 or 11% of the total grant award, whichever is lower. This is for Administrative Services and is only payable in the event of a 2023-2024 Texas Community Development Block Grant award to the City.

WHEREAS, the City of New Fairview, Texas is a Type A general-law municipality located in Wise and Denton Counties, created in accordance with the provisions of Chapter 6 of the Texas Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council desires to participate in the 2023-2024 Texas Department of Agriculture, Community Development Block Grant Program (TxCDBG); and

WHEREAS, the City put out a TxCDBG Administrative Services Request for Project-Specific Proposal to several Pre-Qualified Administrators on the Texas Department of Agriculture Approved Vendor List; and

WHEREAS, the City received two submissions and the Review Team found that the submission from GrantWorks scored highest on the evaluation criteria and best meets the needs of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NEW FAIRVIEW, TEXAS, THAT:

SECTION 1. That, all matters stated in the recitals herein above are found to be true and correct and are incorporated herein by reference as if copied in their entirety.

| Disposal of Surplus Property | |

DESCRIPTION:

Receive, consider, and act on a Resolution declaring certain City surplus property and authorizing the City Administrator to sell, donate, and/or dispose of it in accordance with this Resolution and state law.

BACKGROUND INFORMATION:

The City of New Fairview needs to dispose of both accumulated salvage as well as surplus personal property owned by the City. As defined by state law, "salvage" property is that which has no further feasible use, is obsolete or unusable. Surplus property, on the other hand, is that which is in excess of required inventory or has exceeded its useful life cycle but has some value, that is, it may still be used for its intended purpose. The salvage property includes technology, furniture, and miscellaneous acquired items. The surplus property includes damaged wooden cabinetry and some office chairs. See attached 2022 Asset Disposal List.

For general law cities, the fundamental authority for the disposition of personal property is found in Chapter 51 of the Local Government Code. Under Sec. 51.015, a Type A city may "lease, grant, or convey" property and may "manage and control the property belonging to the municipality."

Sec. 51.015. AUTHORITY TO HOLD, PURCHASE, LEASE, OR CONVEY PROPERTY.

(a) To carry out a municipal purpose, the municipality may take, hold, purchase, lease, grant, or convey property located in or outside the municipality.

(b) The governing body of the municipality may manage and control the property belonging to the municipality.

Acts 1987, 70th Leg., ch. 149, Sec. 1, eff. Sept. 1, 1987.

Surplus property may be disposed of by means of sale at auction, or disposal by other means. However, to dispose of personal property—regardless of whether the property is sold, leased, or disposed by other means cities must always consider the constitutionality of the transaction.

Of particular relevance are those provisions of the Texas Constitution, TEX. CONST. arts. III, § 52(a), which prohibit a city to from granting public monies or anything of value in aid of, or to any individual, association or corporation"), XI, § 3 (prohibiting a city from making any appropriation or donation to a private corporation or association). A transaction to dispose of surplus personal property does not violate these provisions of the constitution if: (1) it has as its predominant purpose the accomplishment of a public purpose of the city (as opposed to a private purpose); (2) the city places sufficient controls on the transaction to ensure that the public purpose is carried out; and (3) the city receives a return benefit. See Tex. Attorney Gen. Op. Nos. GA-0583 (2007) (lease of a county-owned generator to a radio station), GA-0085 (2003) (sale of county-owned dirt to a private party), GA-0084 (2003) (city's conveyance of personal property and equipment to a volunteer firefighter-EMS association). There is no statute that generally requires that a city hold an auction or advertise and receive bids to sell its surplus personal property sold by a city is exempt from Local Government Code Chapter 252).

In this case, the surplus items are being removed from City premises at no cost to the city, thereby avoiding the cost of a governmental auction or sale, including staff time. The salvage property, in turn, is being taken by staff for salvage value.

Staff recommends approval of the resolution.

FINANCIAL CONSIDERATION:

There is no cost to the City associated with the asset disposal.

RECOMMENDED MOTIONS:

I move to **Approve/Deny** a resolution declaring certain City property as surplus and/or salvage and authorizing the City Administrator to sell, donate, and/or dispose of it in accordance with this Resolution and state law.

A RESOLUTION OF THE CITY OF NEW FAIRVIEW, TEXAS, DECLARING CERTAIN CITY PROPERTY SURPLUS AND/OR SALVAGE, AUTHORIZING THE CITY ADMINISTRATOR TO SELL, CONVEY, AND/OR DISPOSE OF IT IN ACCORDANCE WITH THIS RESOLUTION AND STATE LAW; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of New Fairview, Texas is a Type A general-law municipality located in Wise and Denton Counties, created in accordance with the provisions of Chapter 6 of the Texas Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council recognizes that in the normal course of providing municipal services, the various departments will exhaust the useful life of its capital equipment, and other personal property that does not meet the capital equipment threshold, to the point where it is no longer cost effective to maintain and operate; and

WHEREAS, Chapter 51 of the Texas Local Government Code gives the City the fundamental authority for the disposition of personal property belonging to the City; and

WHEREAS, the City has determined the personal property described in Exhibit A, attached hereto and incorporated herein by reference, is not currently needed by the City, that the City no longer has any foreseeable need or use for such property, and that said property should be declared surplus and/or salvage and respectively sold or conveyed or disposed of, in accordance with state law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NEW FAIRVIEW, TEXAS, THAT:

SECTION 1. The City Council declares the property identified in Exhibit A, hereto, surplus and/or salvage, and authorizes the City Administrator or his designee to sell, convey and/or dispose of the property according to state law.

<u>SECTION 2</u>. This Resolution shall be effective immediately upon approval.
