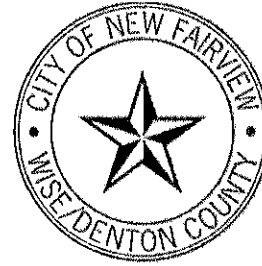

Deborah Greene: Is keep New Fairview Beautiful apart of the city?

John Cabrales Jr.: It is therefore we are not able to fundraise.

Joshua W Barnwell: According to the KTB affiliate handbook we are able to fundraise.

Julie Burger: Has there been any progress made on the triangle?

Mr. Cabrales, that will be discussed as apart of the next agenda Item. In the meantime staff will be working on our part to get the checklist completed.

B. **Receive, consider, and discuss an update on Code enforcement activities.**

Joshua W Barnwell: At current we have 15 active code enforcement cases throughout the city. We have so far received minimal voluntary compliance. We will be moving forward with citations and complaints filed with the court. Most of our current code enforcement violations are tall grass and weeds, trash and debris, and junk vehicles.

John Cabrales Jr: The problem we are having with he triangle is mostly because Dcad and the Denton county tax office have wrongly placed the triangle property as part of the constellation lakes property.

Julie Burger: Has TxDot been dumping there?

Mr. Cabrales: They denied they have; however it is road debris that somebody has been dumping there. We now know who actually owns this portion of land.

Julie Burger: Its not connected to Joe Max?

Mr. Cabrales: Absolutely not.

Julie Burger: Is there a time frame for Denton to correct the ownership?

Mr. Cabrales: DCad is responsive.

Mr. Cabrales: Now that we have this committee, we are starting to have control over some of the issues in certain areas.

Julie Burger: Do we need TxDot's permission, If so is that a long process?

Mr. Cabrales: Yes and Yes.

Deborah Greene: Pilot could pitch in.

Mr. Cabrales: They would be a good corporate partner.

Mr. Cabrales: Any other Questions?

Deborah Greene: What code enforcement falls under KTB?

Mr. Cabrales: Aesthetic Violations primarily, not so much property deterioration.

John Cabrales Jr.: Just like Parks, we put money for KNFB. We are under Code/Health and Safety. We put \$5,000 aside for beautification projects, signs, planning, adopt a spot.

Julie Burger: When do you want us to start spending this money?

Mr. Cabrales: Let's start brainstorming for our September meeting. Keep in mind KTB will send us a great deal of supplies.

Julie Burger: We can talk about putting yard of the month on the agenda?

Mr. Cabrales: Yes, we can start getting this started.

Julie Burger: Its good to get people involved and excited!

Mr. Cabrales: Let us start brainstorming for our next meeting. We have money to pay consultants for grant assistance, money for our dump days, which are always very successful.

Julie Burger: Do you guys know when the next one is?

Mr. Cabrales: We talked about early October.
