# Oakwood Public Safety Officer takes part in 'Saved by the Helmet' event for Motorcycle Awareness Month

In recognition of May being National Motorcycle Awareness Month, the Oakwood Public Safety Department would like to remind all drivers to expect to see more motorcycle riders on the road as peak riding season is upon us. The state of Ohio has over 500,000 registered motorcycles, and 600,000 endorsed riders, making Ohio one of the top five states in the U.S. for total motorcycle riders.

Recommended minimum safety equipment for every motorcycle rider and passenger includes: a DOT approved helmet, eye protection, over the ankle footwear, long pants, and full fingered gloves. Recent statistics provided by the Center for Disease Control and Prevention show wearing a motorcycle helmet reduces the risk of death by 37 percent for riders, and 41 percent for passengers. Helmets also reduce the risk of severe head injury by 69 percent.

The impact and importance of wearing a helmet while riding a motorcycle was locally highlighted on April 26, when Oakwood Safety Department personnel, Captain Mike Tanner and Public Safety Officer Chris Slone, attended the Motorcycle Ohio, a division of the Ohio Traffic Safety Office, 'Saved by the Helmet' award presentation held on the grounds of Wright-Patterson Air Force Base. Six motorcycle riders were presented with the Saved by the Helmet award recognizing them for surviving serious crashes while wearing a helmet, with one of those riders being Zach Gold.

On July 20, 2021, Oakwood Public Safety Officers responded to the intersection of Far Hills Avenue and Patterson Road on the report of a motorcycle crash. Gold, who was riding his motorcycle and was wearing a helmet at the time of the crash, collided with a vehicle and suffered serious injury as a result of the crash. The fact that Gold was wearing a helmet was credited with saving his life.

Public Safety Officer Slone, who was not only the on-scene paramedic responsible for Gold's patient care, is also a certified

accident reconstructionist and was later assigned to investigate the crash said, "It was great to see Zach and his family at the event, and more importantly to see he is doing well. In Public Safety, we don't always get to see the positive results of our work, but this is a moment in my career that will always remember."

Motorists are encouraged to always check mirrors and blind spots before

changing lanes as motorcycles can be difficult to see. Additionally, motorists are reminded to always keep a safe distance by not following a motorcycle too closely. .f you see a motorcycle with a turn signal on, be careful to ensure that the rider is turning before moving ahead. Intersections are danger zones for motorcycles, so motorists should always take a second look prior to making a left-hand turn.

# Recreational marijuana likely for sale in June

Existing dispensaries also expected to sell non-medical products.

COLUMBUS – Recreational marijuana could be available for sale in Ohio by mid-June, after new licensing rules for dispensaries cleared a key legislative hurdle Monday.

Adult-use sales have been in limbo in the state since December, when an initiated statute approved by voters went into effect. Ohioans over 21 were immediately able to legally grow and possess cannabis at home, but they had nowhere to legally buy it, prompting concern by Gov. Mike DeWine and some fellow Republicans in the Legislature that openings would be created for a black market.

On Monday, the Joint Committee on Agency Rule Review allowed rules to proceed without objection that clear the way for a dual licensing program that will allow existing medical marijuana dispensaries to also sell non-medical pot products.

Jim Canepa, superintendent of the Division of Cannabis Control, said applications will be available by no later than June 7, as the new law requires.

"I don't want to give anyone false hopes," he told reporters, when asked whether applications might even be available before then. "We're following the timeline in the initiated statute. We have a small but mighty staff, but there's (a) bandwidth (issue) there."

Canepa didn't want to speculate on how long approval of each application might take, saying it will depend on the circumstances.

But Tom Haren, spokesperson for Ohio Cannabis Coalition and a key backer of last fall's ballot effort, said dispensary operators will be ready right away. He said the Division of Cannabis Control has been "working tirelessly" over the last several months to meet the deadlines laid out in the law for getting the program up and running, and his members have been trying to match their speed.

"Our members have obviously been anticipating the rollout of adult-use sales," he said. "They've been working on getting processes in place, making whatever changes they need to procedures. We're really excited."

Haren said he anticipates most of Ohio's existing dispensaries will apply to be dual licensees, allowing them to sell both medical and recreational products.

Canepa said this is one of several rules packages that must be created to fully implement the program by the final deadline, which is Sept. 7. The new law allows adults 21 and over to buy and possess up to 2.5 ounces

of cannabis and to grow up to six plants per individual or 12 plants per household at home.

It gave the state nine months to set up a system for legal marijuana purchases, subject to a 10% tax. Sales revenue is to be divided between administrative costs, addiction treatment, municipalities with dispensaries, paying for social equity and jobs programs supporting the cannabis industry.

Republican state Rep. Jamie Callender, a longtime supporter of legalizing adultuse cannabis, said the speed with which Cannabis Control, a division of the Ohio Department of Commerce, is gearing up the program validates his contention last year that working through the rules process was better than passing a swiftly negotiated legislative package.

DeWine and the Republican-led Ohio Senate struck a deal at the 11th hour on a sweeping rewrite of what voters had approved, angering the issue's backers and alarming both parties in the House.

The bill the Senate passed would have outlawed growing at home, cut the allowable amount of pot that can be possessed to 1 ounce and raised taxes on purchases to 15%.

It would also have eliminated tax revenue funding for social equity programs supporting the marijuana industry and direct most of the tax money raised to a general state government fund. But the House adjourned without taking a vote.

Callender said legislation will still no doubt be needed to address several issues "not inconsistent with what voters voted on," such as child safety packaging, prohibiting marketing cannabis to kids, and assuring business owners are protected.

The week of April 15, PSO Greg Ortel attended the annual Fire Department Instructor's Conference in Indianapolis, Indiana.


April 28, 29, and 30, Chief Alan Hill attended the Ohio Association of Chiefs of Police annual in-service training conference in Columbus, Ohio.


Lastly, during the month of April, Public Safety Officers completed a 2-hour OPOTA Online training covering Arrest, and Search and Seizure.



# Oakwood principal still out 3 months later; district will only say probe continues

#### By Nick Blizzard Staff Writer

It's been more than three months since Oakwood High School's longtime principal was ordered to take paid administrative leave. The region's highest-performing school district has declined interview requests, instead issuing a statement that the investigation continues, fewer than two weeks before graduation



and the end of the school year. Principal Paul Waller's suspension came after a Jan. 23 theft involving a male student caught

in a girls' locker room stealing clothes, including undergarments, district records show.

Questions were raised about what discipline the student received.

Since he was placed on leave for an unspecified time by first-year Oakwood Superintendent Neil Gupta on Feb. 2, Waller's professional activities have been restricted, district records show.

They include avoiding "any contact with Oakwood students or their families regarding Oakwood High School business" and other school-related actions unless authorized by Gupta, according to school district documents.

One Waller supporter, Margot Hadley, last month told the district's board of education the move against the 15-year OHS principal has been "without any guidance or timeline set by the district."

The Dayton Daily News has requested interviews with Gupta on the issue. Those requests were declined.

Instead, the district requested written questions. Several questions were

The district responded with the following statement:

"Oakwood High School Principal Dr. Paul Waller remains on paid administrative leave as the Oakwood School District conducts an internal investigation. The investigation is overseen by an independent external investigator unaffiliated with the Oakwood school district. We are not working on any investigation with Oakwood Safety" (the police department).

"During this period of administrative leave, Dr. Waller is allowed to participate in school and athletic events in his capacity as a

parent. However, it's important to note that he does not represent the district in any official capacity during these occasions.

"Given that the investigation is still in progress, the district is unable to provide additional comments at this time regarding ongoing investigations."

Several attempts to reach Waller for comment via different means have been unsuccessful. His automated email response has stated "I am currently out on extended leave" and directs inquiries to interim Principal Patrick Masters, a retired administrator from Dayton and Northmont schools.

Since late January, the issue has prompted extensive social media comments and speculation. But few people in the district have publicly raised the matter – either pro or con – at board of education meetings.

The length of Waller's forced leave "seems unprecedented" in that he "had no prior issues as far as a suspension or leave," Hadley told the school board last month. She called Waller one of the district's "most talented and dedicated employees."

Since starting as OHS principal in August 2009, Waller has consistently scored in the top two categories in annual evaluations, Oakwood records show. The high school regularly ranks among the top 10 in Ohio on measures of the state report card, as does the Oakwood school district as a whole.

Only one other Oakwood resident has addressed the school board on the topic of Waller. In April, Sean Geehan called the issue "a sensitive matter" that should be resolved "with the best interest of everybody involved."

Geehan also said he was "highly supportive" of Waller, calling him "accessible, engaged and serious" in key situations, and adding that his children's feedback on Waller has been "extremely positive."

Since late January, others have expressed a different view, according to school district documents obtained through public records requests.

One person sent an email to Waller and Gupta the night of Jan. 24, more than 24 hours after the theft occurred. The sender asked about "the steps the school has taken to involve the police in this theft offense and if not, why and what steps the school is taking internally in terms of discipline and safety for the girls."

The email's sender was "alarmed that several of the items stolen from the girls over the last few months were returned to the girls today for them to take home."

The email also stated, "I learned today that the student involved was at the school today as if apparently nothing happened."

Police were called to the school by Waller the next morning, according to the

Oakwood Safety Department's incident report.

This news organization has sought subsequent Oakwood police records. But those requests have been denied as "the matter is still a pending law enforcement investigation," law director Robert Jacques said.

Gupta twice mentioned the girls' locker rooms investigation in his Feb. 2 letter to Waller notifying the principal that he was on paid leave, school district records state.

On that same day, one basketball player who said she was a victim of theft sent an email to the principal.

"No matter the reason" for the thefts, she wrote, "... It's still unacceptable for our clothing items to be stolen, and on top of that, trying to create excuses for a child who has single handedly made me and my teammates uncomfortable in the place we come to learn."

#### Introduction

### May 16, 2024

The city of Oakwood prepared this report to provide information to you, the consumer, on the quality of our drinking water. This report includes general health information relating to drinking water; a description of the Oakwood water system; general information about water quality; Oakwood water quality test results; information on how to participate in decisions concerning your drinking water; and water system contacts.

The city of Oakwood owns and operates a public municipal water system that serves the residents and businesses throughout the community. The system is comprised of eight production wells, three water treatment plants, 44 miles of underground water lines, 352 fire hydrants and a 1.5 million gallon water tower. The Director of Public Works oversees the operation of the public water system. The Water Plant Superintendent is charged with the day-to-day operation of the wells, water tower and water treatment plants.

#### Source water information

Oakwood receives its drinking water from groundwater pumped through eight production wells. These wells draw water from tributary aquifers flowing towards the Great Miami Buried Valley Aquifer. The city's system produced 100% of the total city water demand in 2023. Had additional water been needed, it would have been supplied from the city of Dayton water system.

Oakwood has two reserve water connections with the city of Dayton and one with Montgomery County. During 2023, Oakwood produced 403.274 million gallons from the eight Oakwood water wells. We purchased no water from the city of Dayton. This report does not contain information on the city of Dayton water quality but a copy of the Dayton Consumer Confidence Report can be obtained by contacting the city of Dayton, Division of Environmental Management, at (937) 333-6093 or by viewing the Dayton website at www.daytonohio.gov/documentcenter/view/14745/2023-Water-Quality-Report.

The aquifer that supplies drinking water to Oakwood has a moderate susceptibility to contamination, due to the sensitivity of the aquifer in which the drinking water wells are located and the existence of several potential contaminant sources within the protection zone. This does not mean that the wellfield will become contaminated, only that conditions are such that the groundwater could be impacted by potential contaminant sources. Possible contamination may be avoided by implementing protective measures. For this reason, Oakwood has an Ohio EPA endorsed Source Water Assessment and Protection Program. See page 6 of this report for information on how you can help protect our water supply. More detailed well field protection information can be obtained by calling the Water Plant Superintendent at (937) 298-0777.

### **City of Dayton Source Water Assessment**

The Ohio EPA conducted a source water assessment of Dayton's water source. The assessment concluded that the aquifer supplying water to the city of Dayton's well fields has a high susceptibility to contamination. This determination is based on: the influence of surface water recharge to the aquifer; the presence of a relativity thin protective layer of clay overlying the aquifer; the shallow depth of the aquifer; contaminant plumes in Dayton's well field protection area; the presence of significant potential contaminant sources in the protection area; and the presence of contaminants in treated water. More information about the source water assessment or what consumers can do to help protect the aquifer is available by calling the city of Dayton Division of Environmental Management at (937) 333-3725.

#### What are sources of contamination to drinking water?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include: (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife; (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses; (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; and (E) Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the United States Environmental Protection Agency (USEPA) prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. #### Who needs to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with immune system disorders, some elderly, and infants can be particularly at risk from infection.

These people should seek advice about drinking water from their health care providers. USEPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (1-800-426-4791.)

#### About your drinking water

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with water service lines and home plumbing. Oakwood is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. A list of laboratories certified in the State of Ohio to test for lead may be found at <u>www.epa.ohio.gov/ddagw</u> or by calling (614) 644-2752. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline (1-800-426-4791) or at www.epa.gov/safewater/lead.

The EPA requires regular sampling to ensure drinking water safety. Oakwood conducted sampling for bacteria, nitrates, total trihalomethanes (TTHM), haloacetic acids (HAA5), synthetic organic compounds (SOC) and lead and copper during 2023. Over the past three years, samples were collected for a total of 125 different contaminants, most of which were not detected in the city of Oakwood's water supply. The Ohio EPA requires Oakwood to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, are more than one year old.

As the data shows, Oakwood complied with all Maximum Contaminant Level (MCL) standards for drinking water during 2023. Oakwood softens its water from approximately 27 grains per gallon to an average of 12 grains per gallon. In 2023, Oakwood had an unconditioned license to operate the public water system as issued by Ohio EPA.

### **Revised Total Coliform Rule (RTCR) information**

All water systems were required to begin compliance with a new rule, the Revised Total Coliform Rule, on April 1, 2016. The new rule maintains the purpose to protect public health by ensuring the integrity of the drinking water distribution system and monitoring for the presence of total coliform bacteria, which includes E. coli bacteria. The USEPA anticipates greater public health protection under the new rule, as it requires water systems that are vulnerable to microbial contamination to identify and fix problems. As a result, under the new rule there is no longer a maximum contaminant level violation for multiple total coliform detections. Instead, the new rule requires water systems that exceed a specified frequency of total coliform occurrences to conduct an assessment to determine if any significant deficiencies exist. If found, these must be corrected by the Public Water System.

### How do I participate in decisions concerning my drinking water?

Public participation and comments on any city issues, including our public water system, are encouraged. This can be done by contacting city staff or by attending regular meetings of Oakwood City Council. City Council typically meets at the City Building, 30 Park Avenue at 7:30 pm the first Monday of every month. Please check the city website <u>www.oakwoodohio.gov</u> to verify meeting dates and times.

#### Definitions of terms contained within this report

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant Level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Parts per Million (ppm) or Milligrams per Liter (mg/L) are units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.

Parts per Billion (ppb) or Micrograms per Liter ( $\mu$ g/L) are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.

Picocuries per liter (pCi/L): A common measure of radioactivity.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Treatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

Not Detected (ND): The level of contaminant was below the level detectable with current testing technology.

The < symbol: A symbol which means less than. A result of <5 means that the lowest level that could be detected was 5 and the contaminant in that sample was not detected.


The pool membership season generally extends from May 25-Sept. 2. But operations rely on students and other seasonal employees, so dates are subject to adjustment, according to the city.

#### In Memoriam

The Oakwood Historical Society was saddened to learn of the passing of Bruce Walton Ronald (92) on April 28, 2024.

0

Bruce, along with his wife Virginia, partnered with The Oakwood Historical Society and coauthored the history of Oakwood, resulting in the publication of *Oakwood: The Far Hills* in 1983. It was published to coincide with Oakwood's 75th anniversary year.

The book evolved from a modest idea into a comprehensive accounting of almost twice the size of the Ronalds' original proposal—a testimony to their dedication and skill.

Bruce and Virginia were Oakwood residents, and Virginia was both an alumnus and teacher of the Oakwood School system. Virginia once led an excavation at the high school, which resulted in the discovery of what is considered to be the original stone pump drain of Gabriel Harman's farmhouse, now the site of the high school. This stone drain was donated to the Society and is proudly showcased in the House Museum's pump house. Virginia Ronald died in 2017.

*Oakwood: The Far Hills* is no longer in publication, but the book forever remains as an important recording of Oakwood's history, and is an outstanding reference for our members, local historians and the community.

Rumpke Waste and Recycling recently announced the expansion of their acceptable items by adding hard-to-recycle plastics as part of the Hefty<sup>®</sup> ReNew<sup>™</sup> Program. The city of Oakwood collects recyclables weekly from residential households and delivers them to the Rumpke material recovery facility for sorting and eventual conversion into new materials. The Hefty<sup>®</sup> ReNew<sup>™</sup> Program allows residents to purchase specific orange bags from local retailers and place materials in those bags that were previously unacceptable in the loose co-mingled recyclable container. Once the orange bag is full, simply place it in your current co-mingled container at your home or in the co-mingled recycle container at the Recycling and Yard Waste Drop-Off Facility located at the entrance to the J. David Foell Public Works Center, 210 Shafor Boulevard. The orange bag is delivered to Rumpke where it is removed from the loose recyclables and separated for delivery to specialized recyclers. This program is optional for those residents who wish to further reduce their waste and recover hard-to-recycle plastics. "The Hefty<sup>®</sup> ReNew<sup>™</sup> Program will allow additional materials to be diverted from the landfill and provide another opportunity for residents to continue doing their part in responsible recycling," said Doug Spitler, Director of Public Works.

It is increasingly important that the co-mingled recycling stream contains only recyclable materials. In years past, the guidance was: "when in doubt, throw it in the recycling container". The guidance is now: "learn what is recyclable and what is not, but when in doubt, throw it in the regular trash."
