2025 Montgomery County dog licenses are available for renewal or purchase now through Jan. 31, 2025. License season may only be two months, but protecting your dog is important year-round. To learn more or purchase your license online, visit www.mcohio.org/dogs.

Licenses are the law

Did you know in Ohio, dogs three months and older are legally required to display a current year license at all times? Keep your pup in line with the law and visit www.mcohio.org/dogs to learn more and purchase your 2025 Montgomery County dog license today.

Licenses save lives

If a dog goes missing wearing a current license, they are much more likely to get home without ever setting foot in the shelter - which is GREAT! Shelters, no matter how nice, are very scary for our pets. They are surrounded by unfamiliar sights, sounds and smells when they just want to be home with their family.

Protect your furry family members and purchase their 2025 Montgomery County dog license at www.mcohio.org/dogs now through Jan. 31.

Newsletter Blurb

Under Ohio law, all dogs three months and older must be registered annually with their County Auditor's Office.

2025 Montgomery County dog licenses are available for purchase Dec. 1 through Jan. 31. Licenses cost \$20 for dogs who are spayed or neutered and \$24 for unaltered dogs. Failure to register your dog by the Jan. 31 deadline can result in a penalty fee of up to \$48.

Dog licenses not only serve as legal proof of ownership but also help reunite lost pets with their owners. Licensed dogs are held at the Animal Resource Center (ARC) for 14 days, compared to just three days for unlicensed dogs. Licenses can be traced year-round, making it easier to bring your pet home safely.
