LIBRARY NEWS | Wright Library Celebrates 80th Anniversary in 2019



Wright Memorial Public Library turns 80 in 2019! Opening to the public on Feb. 14, 1939, Wright Library has served Oakwood and beyond for eight decades. The library's roots began in 1913 with a small library housed in the home of the Parrot family. In 1916, the Oakwood Board of Education passed a resolution

to establish a public library for the school district and the library moved to Harman School. In 1923, the house at 45 Park Avenue became the library's home. In 1937, a bond issue was passed to build a new library on Far Hills Avenue on the site of Katharine Wright Park.

REFUSE PROGRAM

One of our primary city services is collection and disposal of refuse including household trash, recyclables, bulk items, and green waste. Given the enormous number of trees in Oakwood and the extensive landscaping throughout our city, we generate a very large amount of green waste (yard debris). Roughly 20-25% of the cost to operate our refuse program is related to the green waste collection and disposal. Below are some details about our comprehensive refuse program.

• Weekly Trash Collection



The primary component of our refuse program is the weekly collection and disposal of household trash and co-mingled recyclables. We provide this service via back door collection with a fleet of refuse scooters. These scooters are equipped with two hoppers... one for trash and one for co-mingled recyclables. The materials are dumped into split-bed refuse trucks. The trash is taken to the Montgomery County Refuse Transfer Station in Moraine. We pay \$38.25 per ton to have the trash transloaded into large refuse haulers and taken to a landfill. The co-mingled recyclables are taken to the Rumpke recycling facility in Dayton. We pay \$20 per ton to drop the recyclables at Rumpke.

• Creager Field Green Waste and Recycling Drop-off

We have several drop-off dumpsters at the Creager Field parking lot adjacent to Shafor and Irving (by the Oakwood Dog Park). There are separate containers for cardboard, for co-mingled recyclables (glass, plastics, metal, etc.) and for yard debris. These containers are accessible 24-7. The more green waste and recyclables that we remove from the landfill stream, the cheaper it is to operate our city refuse program. • Cardboard Recycling

The cardboard from our dumpster containers at Creager Field is taken to a local recycler. Depending on market conditions, we have received up to \$10 per ton for this cardboard. Unfortunately, the current recycling market is poor, and we do not receive any money for the cardboard, nor do we pay anything for Rumpke to take it. Regardless, we encourage our citizens to use the Creager Field cardboard disposal containers as much as possible.

• Special Pickups

All Oakwood property owners are entitled to two special pickups per calendar year at no cost. Additional pickups are charged at \$100 each. Special pickups are for large items only (e.g., furniture, appliances, etc.) and can be scheduled by calling 298-0777. If you are a tenant, you must coordinate your special pickups with the property owner. All items must be placed in an open area where the city bucket loader can safely access them, such as driveways away from structures and fences.

• Leaf Mulch Program

Our fall 2018 leaves are currently being processed into garden mulch. Oakwood citizens will have two options again this year for obtaining the mulch. For those who want mulch delivered, we offer 3 cubic yards for \$100 and 6 cubic yards for \$150. Please call 298-0777 to place an order. We will accept orders beginning March 1. Mulch deliveries will take place on five Saturdays from April 13 to May 11. On the same five Saturdays, residents can obtain free mulch from the public works yard at 210 Shafor Blvd. between the hours of 8:00 a.m. and 2:00 p.m., but must haul the mulch themselves and must provide proof of residency. The free mulch is for Oakwood residents only and no commercial vehicles are permitted.

• Refuse Dumpsters

As an alternative to special pickups, residents can request refuse dumpsters. These are designed for disposal of debris from do-it-yourself home remodeling projects, and for general household clean-up. Dumpsters are for disposing of resident generated debris only (no contractor generated). There is a \$100 delivery and pickup charge for the dumpsters. The person requesting the dumpster will also be responsible for the costs incurred by the city for dumping the discarded materials. Call 298-0777 for more details.

• Free Dumpsters for Yard Debris

If you have a large amount of yard debris (green waste) and would like to use a dumpster for disposing of the material, rather than waiting for the regularly scheduled monthly pickup, please call 298-0777 to request a container drop-off. There is no charge when using dumpsters exclusively for yard debris disposal. Please consider coordinating the dumpster use with your neighbors.

• Yard Debris and Refuse Drop-off

The Foell Public Works Center at 210 Shafor Boulevard is open the first Saturday of every month for residents to drop off yard debris and other household waste and recyclables, including large items such as furniture and appliances. If dropping off a refrigerator, freezer, or air conditioner, the Freon must be removed. For large amounts of construction debris, please use the dumpster program.

Co-Mingled Recyclables Program

Oakwood collects recyclables using scooters with divided dump beds – one side for regular trash and the other side for recyclables. Plastics, glass, paper, metal cans, and cardboard as described below are to be co-mingled in one or more containers marked as recyclables. All items should be clean and free of food and grease. Please make sure that co-mingled recyclable products are placed loosely in the properly marked container. The items should not be placed in plastic bags. Free “Recyclables” stickers to mark containers are available at City Hall or at the Foell Public Works Center.

It is increasingly important that our co-mingled recycling stream contains only recyclable materials. In years past, the guidance was “when in doubt, throw it in the recycling container”. The guidance now is “learn what is recyclable and what is not, but when in doubt, throw it in the regular trash”. The success of recycling and the recycling markets is largely dependent on the quality of the recycling stream.

- **ACCEPTABLE PLASTICS:** Small containers and bottles that have a small mouth and a wider base, such as plastic milk containers, soft drink bottles, jugs, detergent & water bottles and shampoo containers. Empty and crush.

UNACCEPTABLE PLASTIC ITEMS: Plastic items without a bottle neck, plastic tubs, trays & cups, plastic cutlery, clamshell plastic containers, plastic bags, straws, toothbrushes, coffee cup lids, plastic toys & bikes, plastic buckets and plastic wrap. Also, foam and polystyrene are presently not recyclable and should be placed in with the regular trash. Please place loose foam packing material in bags before placing it in with your regular trash so that it does not fly out of our refuse scooters and then blow around your neighborhood.

- **ACCEPTABLE GLASS BOTTLES AND JARS:** All colors of glass bottles and jars. Lids and locking rings should be removed, if possible.

UNACCEPTABLE GLASS ITEMS: Ceramic & porcelain, drinking glasses, window glass, mirrors, light bulbs and dishware.

- **ACCEPTABLE METAL BEVERAGE AND FOOD CANS:** Aluminum, steel, bi-metal cans, and empty aerosol cans are recyclable. Lids and tips should be removed.

UNACCEPTABLE METAL ITEMS: Needles, sharps & medical equipment, metal hangers, metal pots, pans & pipes and metal wire.

- **ACCEPTABLE NEWSPAPERS/PAPER:** Newspapers may be co-mingled with all other recyclables. You may also include junk mail, glossy inserts, magazines, catalogs, telephone books, copier paper and all other clean paper products.

UNACCEPTABLE PAPER ITEMS: Paper plates & cups, take-out coffee cups, hardbound books, tissues, laminated paper, photos, photo paper or specially treated paper, toilet paper, paper towels or contaminated items.

- **ACCEPTABLE CARDBOARD/CARTONS:** Cardboard and carton items including cereal, pasta, cookie and cracker boxes, food and beverage cartons, gift boxes, mailing tubes, corrugated cardboard and brown paper bags may be co-mingled with all other recyclables. Please cut or break down boxes and remove plastic items that may be affixed to the cardboard.

NOTE: Large quantities of the cardboard/carton items listed above should be dropped off in the containers at the Creager Field parking lot. These containers are available 24-7.

THE FOLLOWING SPECIFIC ITEMS SHOULD NOT BE INCLUDED WITH YOUR CO-MINGLED RECYCLABLES

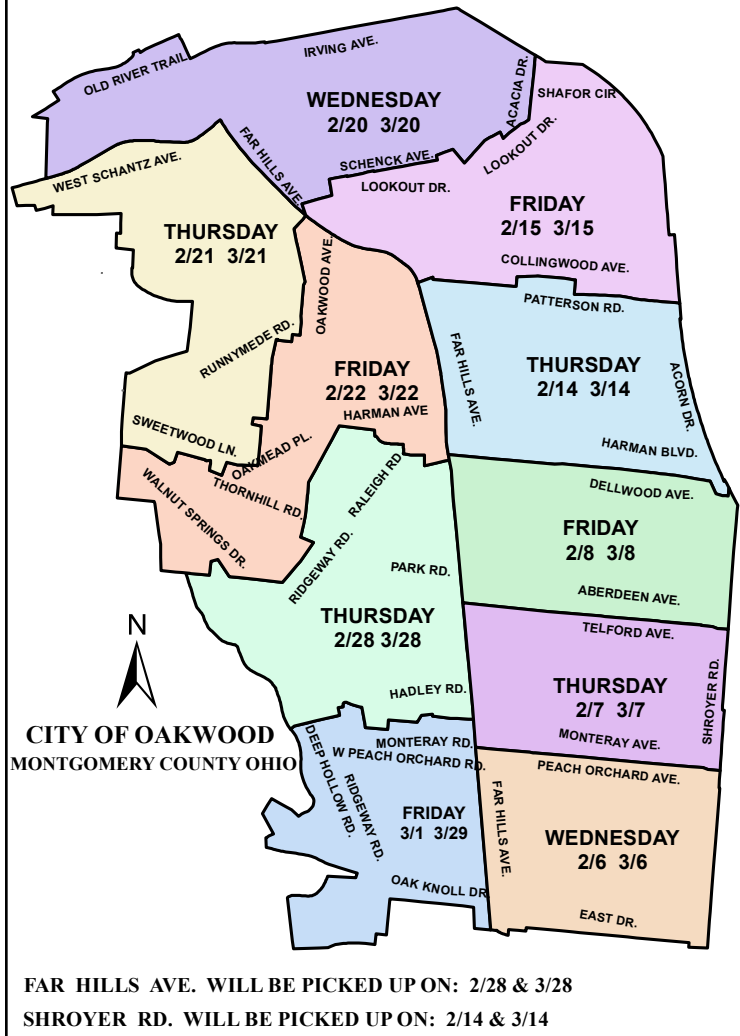

Thoughts from Oakwood Historical Society President Leigh Turben

Most of the time I would describe myself as a person who looks to the future. As the president of the Oakwood Historical Society, there are also times I get to reflect on the past.

There have been a number of outstanding moments in 2018 that both delighted and surprised me. The most exciting moment was when I learned our first holiday home tour had sold out several weeks before the December 8th event. Committee Chair Alex Duncan had the foresight to select Oakwood homes exhibiting varied architectural styles. Enthusiasts of Craftsman, Swiss Chalet, Tudor, Italian Renaissance Revival, and Prairie Style Tutor, were all satisfied. I was delighted to meet our residents who willingly shared their homes with 500 sightseers just weeks before Christmas. And, I was not surprised to find that these guests said they were made to feel most welcomed as they toured. The tour also revealed how many Oakwood homeowners are really do-it-yourselfers, or at the very least can envision the impact of a renovation they contract out. If this group of homeowners held something in common, it appears to be an appreciation for architectural integrity and a gift for fusing the old with the new.

Oakwood Historical Society Board members will evaluate every aspect of the event over the next few months and I hope citizens will contribute their comments so this event will come to best reflect the character of our community.

An equally thrilling moment that I like to think back on occurred at the Lutheran Church of Our Savior on September 16. More than 200 people had come to hear Jim Charters present his research on Dayton's role in WWII. Charters told the remarkable story of Joseph Desch, the WAVES, and the Dayton Codebreakers. Knowing that the Oakwood Historical Society in partnership with Wright Library serves to keep our community's history alive is of course gratifying. What made the day so extraordinary for me, however, was the unexpected appearance of John Harshman—one of the original Dayton Codebreakers. I felt as if I were at a film premier and the film's star made an unannounced appearance! Mr. Harshman is very modest about the role he played in the Navy's top-secret project to build a decoding machine at NCR's Building 26. He contends he knew very little about the greater objective of which he was part. Nevertheless, that afternoon 95 year-old Mr. Harshman was treated like a rock star. People waited their turn to have their picture taken with him. Knowing that I lead an organization that makes moments like this possible gives me an incredible feeling of pride. Mr. Harshman deserved his afternoon of fame—his work helped bring WWII to a close.

There are many more stories I could tell that reflect the generous spirit of this community and the good work of the Historical Society. Involvement in Society events connects me to a community that keeps an eye to the past as it constantly looks forward.

DOOR-TO-DOOR SOLICITING AND CANVASSING – “No Solicitation” Designation



The city of Oakwood provides residential property owners with a means to prohibit certain types of door-to-door solicitation and canvassing. This is addressed in Chapter 733 of the Oakwood Codified Ordinances and can be accomplished by residents requesting that their property be included on the city’s “Do Not Solicit” list.

If you are interested in being added to the “do-not-solicit” list, you can complete one of the following:

- 1) Submit the “No Solicitation Form” from the city’s website at www.oakwoodohio.gov
- 2) Detach the form below and mail it to: City of Oakwood, Attn: Do Not Solicit, 30 Park Avenue, Oakwood, OH 45419.



As the owner or tenant of property with the street address of _____,

I hereby request that this property be registered on the city of Oakwood’s “Do Not Solicit” list.

I understand and intend the following:

1. By registering my address on the “Do Not Solicit” list, all persons will be prohibited by law from contact canvassing, peddling, vending, soliciting, or requesting contributions at my property.
2. This prohibition does not apply to the delivery of advertisements, literature, or other information that may be left at my property, and does not apply to certain youth fundraising activity.
3. Registration of a property on the “Do Not Solicit” list expires after five years or upon the transfer of a property to a new owner or tenant, whichever comes first. Registrations can be renewed upon request by the owner or tenant.

NOTE: The city of Oakwood notifies property owners/tenants via postcard when their five year expiration date is reached. At that point, property owners/tenants must re-register to remain on the “Do Not Solicit” list.

2018 Oakwood Income Tax Returns Due April 15



The city of Oakwood has a mandatory tax filing requirement for all residents. Unless exempted in writing by the City, every individual 18 years of age or older who resides in Oakwood, must file an Oakwood City income tax return, whether or not there is any taxable income to report. Retired residents who have income derived exclusively from non-taxable sources (interest, dividend, social security and/or pension income, etc.) may be exempted from the filing requirement, but must first file a final return in order to apply for this exemption.

If you have filed for an extension of time to file your federal return, you will automatically receive an Oakwood extension. You should attach a copy of your federal extension form to your return when filing so that you will not be charged a late filing penalty. Your extended return is due the same date as your extended federal return – October 15, 2019. If you do not have a federal extension, you may still obtain an Oakwood extension. Simply complete an extension request form, located on the City's website, and submit your request by April 15, 2019. As always, an extension of time to file

your returns does not extend the time to pay your taxes. All taxes paid after April 15, 2019 will be subject to a 15% underpayment penalty, if applicable, as mandated by the State of Ohio.

The 2018 Oakwood income tax return is available on the City's website at www.oakwoodohio.gov. If you do not have internet access, forms will be made available at the City administrative offices, Wright Memorial Public Library, and the Oakwood Community Center.

If you need assistance with the preparation of your Oakwood income tax return, please visit the Tax Department before March 29, 2019. Normal business hours for the tax office are from 8:00 a.m. to 5:00 p.m., Monday through Friday. Extended hours will be provided on Friday, April 12 and Monday, April 15, when the office will be open until 6:00 p.m.

February/March Council Meetings

Credit Card Security

Credit card security continues to be in the news with several high-profile data breaches. In each instance there was nothing the cardholder could have done to prevent their credit card data from being compromised. Nevertheless, there are several steps that you, as the cardholder, can take to improve the security of your credit cards.

General tips regarding credit cards:

- Handle with care - It is never a good idea to carry a credit card on its own outside of your wallet. A credit card can easily get misplaced or stolen, yet they tend to stay put when placed within a slot in your wallet.
- Limit the number of cards you possess. Only carry those cards that you use on a regular basis.
- Shred your credit card statements and any other paperwork that contains information regarding your personal identity before putting it in the trash.
- Check your monthly statements. It is the cardholder's responsibility to spot fraudulent charges and report them to the bank.
- Set up purchase notification alerts through your credit card company so you are immediately informed of any activity on your account.

When making online purchases, adhere to the following tips to protect yourself and your identity:

- Try to use the same credit card for all online purchases so if it is stolen, you will only have to deal with one credit card company.
- Never use debit cards for online purchases - credit cards typically offer better protections to the cardholder.
- Never save credit card information on shopping sites. While this may speed up the process, it puts you at greater risk of becoming a victim of fraud or theft.
- Change your passwords regularly. This should include your email accounts. Use a combination of letters, numbers, symbols, and capital letters to make yourself less vulnerable.
- Don't use public Wi-Fi to make online purchases. Most public Wi-Fi spots offer little to no security protection and your personal information could be easily compromised.

It is imperative that you report the loss or theft of your credit cards, ATM cards, or debit cards to the card issuer as soon as you become aware of loss, theft, or misuse of your account information. The vast majority of credit card companies have toll-free numbers and 24-hour service to deal with such emergencies. In most cases, the credit card company will request that you contact your local police agency to file a report. If your credit card company makes this request, please contact the Oakwood Public Safety Department at 298-2122 to file the report.

Summer Employment Opportunities

Assistance in filing claims to the Veterans Administration includes the preparation of forms and documentation of claims, filing to obtain discharge papers (DD-214), and obtaining medals. Financial assistance may be provided to qualifying veterans as a short-term or onetime payment to assist with the necessities of life. Home fires can happen at any time, but they generally increase during the winter months. You can make your home a safer place by requesting a Residential Fire and Safety Inspection from the Oakwood Safety Department. These inspections are conducted by request only and are free of charge. Home inspections provide an opportunity for residents to learn about fire safety issues and for Oakwood Safety Department inspectors to provide recommendations on measures to improve the safety of home occupants.
