SEPTEMBER 16, 2019 COUNCIL MEETING

City Council met in public session on September 16, 2019. Here are the highlights.

Council meeting minutes were approved for the August 5, 2019 regular session, work session and executive session, and the August 19 work session and executive session.

STATUS REPORTS

<u>Proclamations</u> – Mayor Bill Duncan read a proclamation designating September 17 – 23 as "Constitution Week".

VISITORS

- Joe Braden, Auditor of State Mr. Braden recognized Oakwood City Council and the Oakwood Finance Department for receiving the Auditor of State Award for Excellence in Financial Reporting.
- Stormwater Placards: Little Miami Watershed Network and The University of Dayton River Stewards Wendy Dyer, Little Miami Watershed Network, and Claire Sullivan, The University of Dayton River Stewards, spoke about their organizations. Council thanked the organizations for placing stormwater placards on all Oakwood drainage catch basins.

LEGISLATION

Oakwood City Council approved the following legislation:

- > An Ordinance to establish the Special Improvement District Assessment Fund.
- > A Resolution to approve Existing Property Tax Amounts and Rates.
- > A Resolution authorizing Collective Bargaining Agreements with PSOs and Lieutenants.
- A Resolution authorizing a Collective Bargaining Agreement with the Public Safety Dispatchers.

STAFF REPORT

Public Works Department Presentation: Mr. Klopsch provided an update on Public Works projects and operations.

CITY MANAGER'S COMMENTS

Mr. Klopsch thanked Finance Director Cindy Stafford and the Finance Department for their hard work and excellent performance on the 2018 audit. He also thanked Leisure Services Director Carol Collins and Program Supervisor Karen Earley for another successful pool season. Mr. Klopsch then provided an update on the Budget Review Committee and the Citizens Police Academy.

COUNCIL COMMENTS

Councilmember Anne Hilton shared that she recently attended two events sponsored by Wright Library: Storytime at Smith Gardens and Read-a-Thon on the Lawn. She also attended the annual Classics on the Lawn Car Show hosted by the Oakwood Historical Society. All were great events.

An Oakwood resident shared concerns about the lack of clean-up from Dayton Power & Light after recent tree trimming. City staff will follow up on this.

AN ORDINANCE

NO. 4893

TO CREATE A NEW FUND WITHIN THE FISCAL RECORDS OF THIS CITY TO BE KNOWN AS THE SPECIAL IMPROVEMENT DISTRICT ASSESSMENT FUND; AND TO DECLARE AN EMERGENCY.

WHEREAS, beginning in 2009, the General Assembly adopted various state laws to authorize and implement what is known as Property Assessed Clean Energy ("PACE") financing, a mechanism for funding energy-efficient property improvements through loans which are serviced by the levying and collection of special assessments; and

WHEREAS, PACE financing does not involve the use of city funds, and the city's role in a PACE financing arrangement is limited to the levying of special assessments and transfer of the proceeds thereof to an outside lender; and

WHEREAS, no Oakwood property owners have pursued PACE financing to date, but city staff anticipates receiving the first application in the coming months; and

WHEREAS, Sections 5705.09 and 5705.12 of the Ohio Revised Code require that cities establish certain specified funds within their fiscal records, and permit, but do not require, the creation of additional special funds; and

WHEREAS, the City Manager has recommended the creation of a new fund in the city's financial records to be known as the Special Improvement District Assessment Fund, which will allow for the separate accounting of special assessments relating to Property Assessed Clean Energy (PACE) financing; and

WHEREAS, pursuant to Section 5705.12 of the Ohio Revised Code, the State Auditor's approval is required in order to establish this fund; and

WHEREAS, Council desires to accept the recommendation of the City Manager;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OAKWOOD, STATE OF OHIO, THAT:

SECTION I.

Through this ordinance a new fund entitled the Special Improvement District Assessment Fund is created, subject to and requiring the approval of the State Auditor as provided in Section 5705.12 of the Ohio Revised Code.

SECTION II.

The Director of Finance is hereby authorized to seek the State Auditor's approval of the fund created in Section I, and to take such related actions as may be necessary to secure state approval. If such approval is granted, the Special Improvement District Assessment Fund shall be promptly entered upon the fiscal records of this city and may be utilized immediately. If such approval is declined, and such declination is final, this ordinance shall thereupon become null and void, and shall be repealed automatically by operation of law.

SECTION III.

All revenues and expenditures relating to special assessments for PACE or similar financing within a special improvement district shall be allocated to the Special Improvement District Assessment Fund for use as provided by law.

SECTION III.

This ordinance is hereby declared to be an emergency measure and as such shall take effect immediately, on the basis that it is necessary to create the new fund promptly so that it is in place prior to receiving any applications for inclusion of a property within a special improvement district, and on the further basis of protection of the public peace, health, safety and welfare.

WHEREAS, the proposed agreements have been reviewed with Mayor Duncan and Vice Mayor Byington in their capacity as members of City Council's Finance Committee, and

WHEREAS, the City Manager recommends the execution of separate three (3) year collective bargaining agreements with the public safety officers and lieutenants, to expire on October 26, 2022 and November 3, 2022, respectively;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OAKWOOD, MONTGOMERY COUNTY, OHIO, THAT:

SECTION I.

The City Manager is hereby authorized to execute collective bargaining agreements with Oakwood FOP Lodge No. 107 as discussed, to wit: a three (3) year collective bargaining agreement relating to the public safety officers, to expire on October 26, 2022, and a three (3) year collective bargaining agreement relating to the public safety lieutenants, to expire on November 3, 2022.
