

THE MINUTES OF THE MEETING OF THE BOARD OF HEALTH, CITY OF OAKWOOD,
STATE OF OHIO

The meeting was conducted on Tuesday, May 28, 2019 in the conference room at the city building, 30 Park Avenue.

Dr. Denka called the meeting to order at 5:30 p.m. and led a discussion on the following agenda items:

Minutes of Previous Meetings: The Board reviewed minutes of the March 26, 2019 meeting. There being no requested edits, motion to approve by Dr. Wilson; second by Dr. Coyne. Upon viva voce vote, motion passed and the minutes were approved.

Report from Chair: No report.

Report from Sanitarian: Mr. Scaglione gave the following report:

- That Day in May Inspections: The annual "That Day in May" community celebration was conducted on Saturday, May 18. All food service inspections were completed and there were no issues noted. Mr. Klopsch commented on the new code requirements relating to permitting for the use of food trucks in Oakwood.
- Gardner Pool Inspections and Opening: Gardner Pool opened last Saturday, May 25. All inspections were completed and the pool is in normal operation. No inspection was requested for the pool at Acorn Arms, 1505 Shroyer Road. Mr. Scaglione will follow up on this to determine if the pool is in operation.
- Cost Methodology: The calculations to determine 2020 health department fees will be done prior to the next board meeting.

Report from Health Commissioner: Dr. Enseleit commented on his recent attendance at the Spring Ohio Public Health Combined Conference. It was an informative session and a good opportunity for him to meet other health officials throughout Ohio.

Report from Board Administrator/City Manager: Mr. Klopsch commented on the following items:

- Public Health Emergency Response Plan: Public Health – Dayton & Montgomery County has an Emergency Response Plan that includes the city of Oakwood. Additionally, Montgomery County has an Emergency Management Agency. Together, these two organizations are well-positioned to address any and all health emergencies throughout the region. The city of Oakwood also has an emergency operations plan. That plan is maintained by the Oakwood Public Safety Department. Discussion ensued on the Dayton area tornado events of last night, and the manner in which many jurisdictions throughout the Miami Valley assisted those communities where damage occurred.
- PFAS Water Testing: The city of Oakwood is working with the city of Dayton and Montgomery County to develop a plan for PFAS (per- and polyfluoroalkyl substances) water testing. PFAS chemicals are found in firefighting foams historically used at Wright Patterson AFB, at the city of Dayton Fire Training Center, and many other fire training centers throughout the country. Trace amounts of the chemicals were found last year in the city of Dayton water system. The levels found were in safe amounts, but concerns

persist regarding the chemicals. While the Ohio EPA does not currently require PFAS testing, it is believed that sampling requirements will soon be put in place. The Oakwood testing would likely take place at the two city water plants. The cost for conducting two tests at a private lab is approximately \$1,100. The Ohio EPA recently mentioned that they would conduct the test, at their cost, which is estimated to be \$300 – \$400. A May 20 *Dayton Daily News* article mentioned Oakwood’s plan to test for PFAS chemicals. This article was written as a result of an Oakwood resident commenting on the chemicals at the May 6 council meeting. While Oakwood has no expectation that these chemicals will be found in the City water, the testing is planned as a precautionary measure.


- Annual Lead & Copper Water Testing: The 2019 testing must take place between June and September. The City is planning to complete the annual requirement in the month of June. Mr. Klopsch will report the results at the next Board of Health meeting.

Old Business: NONE


New Business:

- Quarantine Policy: Mr. Klopsch reported that staff is working on a policy regarding quarantine procedures. This is a requirement of the Ohio Revised Code. The policy will be available for Board review at the next meeting.
- ASIST Training: Dr. Wilson mentioned that she and Oakwood resident Leigh Ann Fulford will attend a five day training session entitled “Applied Suicide Intervention Skills Training” (ASIST). This training will prepare Dr. Wilson and Mrs. Fulford to conduct two-day workshops for school officials and first responders providing instruction in matters regarding suicide prevention. Over the course of the two-day workshop, ASIST participants learn to:
 - Understand the ways that personal and societal attitudes affect views on suicide and interventions.
 - Provide guidance and suicide first aid to a person at risk in ways that meet their individual safety needs.
 - Identify the key elements of an effective suicide safety plan and the actions required to implement it.
 - Appreciate the value of improving and integrating suicide prevention resources in the community at large.
 - Recognize other important aspects of suicide prevention including life-promotion and self-care.

There being no other business, at 6:12 p.m. Dr. Denka adjourned the meeting.

**OAKWOOD BOARD OF HEALTH
RESOLUTION**

NO. 19-2

TO ADOPT AN ISOLATION AND QUARANTINE POLICY FOR INFECTIOUS DISEASES
AND OTHER PUBLIC HEALTH EMERGENCIES

WHEREAS, the Oakwood Board of Health has primary authority to enforce the provisions of Ohio Revised Code (“ORC”), Sections 3707.04 to 3707.34 regarding quarantine and isolation; and

WHEREAS, ORC Section 3707.04 authorizes the Health Commissioner to act on behalf of the Board of Health in administering the provisions of ORC Sections 3707.04 to 3707.34 regarding quarantine and isolation, if the Health Commissioner acts pursuant to a policy adopted by the Board and approved by Oakwood City Council; and

WHEREAS, by enacting this Resolution, it is the intent of the Board to enact such a policy; and

WHEREAS, the Board specifically finds that this Resolution is necessary for the protection of the public health, safety, and welfare in the event of an outbreak of infectious disease or other public health emergency;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF HEALTH OF THE CITY OF OAKWOOD, MONTGOMERY COUNTY, OHIO, THAT:

Section I.

The foregoing recitals are hereby incorporated by this reference.

Section II.

The Oakwood Board of Health hereby adopts the “Isolation and Quarantine Policy for Infectious Diseases and Other Public Health Emergencies” set forth on the attached Exhibit A, which is incorporated by this reference, provided however that the Health Commissioner shall have no authority to act thereunder unless and until the same shall be approved by Oakwood City Council.

Section III.

The Board Secretary is hereby authorized and directed to transmit a copy of Exhibit A to the Oakwood City Council for its review and approval, as required by ORC Section 3707.34(B), and to attach a certified copy of such approval to this policy upon receipt.

Section IV.

This resolution shall take effect as of the earliest date permitted by law.
