## MINUTES OAKWOOD CITY COUNCIL WORK SESSION MARCH 2, 2020

The Council of the city of Oakwood, Ohio, met in a work session on Monday, March 2, 2020 in the conference room of the Oakwood Municipal Building, 30 Park Avenue. The Mayor of the city, William Duncan, presided.

Council members in attendance were Mayor William Duncan, Vice Mayor Steve Byington, Councilmember Rob Stephens, Councilmember Anne Hilton and Councilmember Chris Epley.
