2020 Sidewalk, Curb and Driveway Apron Project

On the same five Saturdays, residents may obtain free mulch from the Foell Public Works Center at 210 Shafor Blvd. between the hours of 8:00 a.m. and 2:00 p.m., but must haul the material themselves and must provide proof of residency. The free mulch is for Oakwood residents only and no commercial vehicles are permitted.

Picking up after your Pets

Dogipot stations are available throughout the City to help pet owners with an easy and safe clean-up. There are few things that aggravate neighbors more than a pet owner who does not clean up after their pet. Besides being an unsightly mess, a number of common diseases can be transmitted to pets and people through feces. Failing to clean up after your pet is fineable under the Oakwood General Offenses Code. Please be a responsible pet owner and help keep our Oakwood community clean.

Leash Law

Dogs are required to be securely leashed and under the reasonable control of the owner, keeper or agent thereof whenever they are on public sidewalks, streets or any other public rights-of-way. This applies to all dogs in Oakwood, but there are certain exceptions for service animals and for dogs using the Creager Field Dog Park. Oakwood is densely populated and we have a very large number of dogs... around 1,000 registered in Oakwood, where we have around 3,800 homes. The leash law is designed to mitigate the unpredictability of dogs and to protect both citizens and other animals from unexpected and unwanted encounters. Even the most well-trained dogs, under the right set of circumstances, can be unpredictable. Citizens should be able to move about the public sidewalks and rights-of-way freely and without concern or fear from unleashed dogs. In the five year period from January 2014 to December 2019, our Oakwood Safety Department responded to 127 dog related calls for service of which 39 included report of a dog bite.

Summer Employment Opportunities

The city of Oakwood is currently accepting applications for summer employment in the following areas: Boulevard Maintenance; Smith Gardens Maintenance; General Maintenance (including roadways, water system and refuse collection); Day Camp Counselors; Pool Concessions and Lifeguarding. Applicants must be at least 18 years of age at the time of employment in order to be eligible for the Boulevard, Smith Gardens, General Maintenance and Day Camp Counselor positions. The minimum age for all other positions is 16. Employment applications are available at the City Building, the Community Center and the City website. Equal Opportunity Employer.

April/May City Council Meetings

City Council will meet in regular sessions at **7:30 p.m. on Monday, April 6 and Monday, May 4**. Both meetings will take place at the city building, 30 Park Avenue. The regular sessions are preceded by an open work session beginning at 6:30 p.m. Citizens are invited to attend any of these meetings. The regular sessions are televised live on cable TV (Spectrum Ch. 6, TV Tuner Ch. 5.03 and AT&T U-verse Ch. 99). Meeting videos will be rebroadcast for a week or so afterwards. 2019 Oakwood Income Tax Returns Due April 15

The city of Oakwood has a mandatory filing requirement for all residents. Every individual, 18 years of age or older, who resides in Oakwood, must file an Oakwood City income tax return, whether or not there is any taxable income to report. Retired residents who have income derived exclusively from non-taxable sources (interest, dividend, social security and/or pension income, etc.) must first file a final return in order to be exempt from the filing requirement.

If you have filed for an extension of time to file your federal return, you will automatically receive an Oakwood extension. You should attach a copy of your federal extension to your return when filing so that you will not be charged a late filing penalty. Your extended return is due the same date as your extended federal return – October 15, 2020. If you do not have a federal extension, you may still obtain an Oakwood extension. Simply complete an extension request form, located on the City's website, and submit your request by April 15, 2020. As always, an extension of time to file your returns does not extend the time to pay your taxes. All taxes paid after April 15, 2020 will be subject to a 15% underpayment penalty as mandated by the State of Ohio.

The 2019 Oakwood income tax return is available on the City's website at www.oakwoodohio.gov. If you do not have internet access, forms will be made available at the City administrative offices, Wright Memorial Public Library and the Oakwood Community Center.

If you need assistance with the preparation of your Oakwood income tax return, please visit the Tax Department before March 31, 2020. Normal business hours for the tax office are from 8:00 a.m. to 5:00 p.m., Monday through Friday. Extended hours will be provided on Monday – Wednesday, April 13 - 15, when the office will be open until 6:00 p.m.

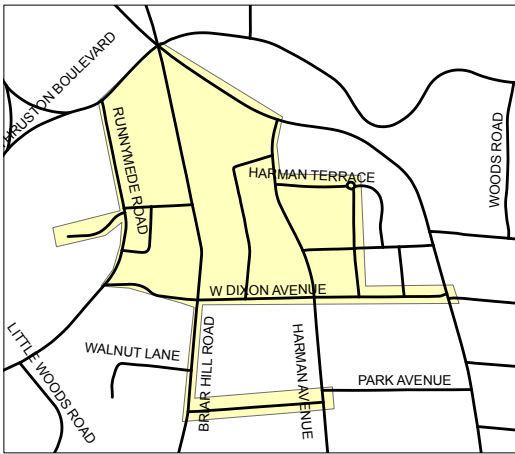

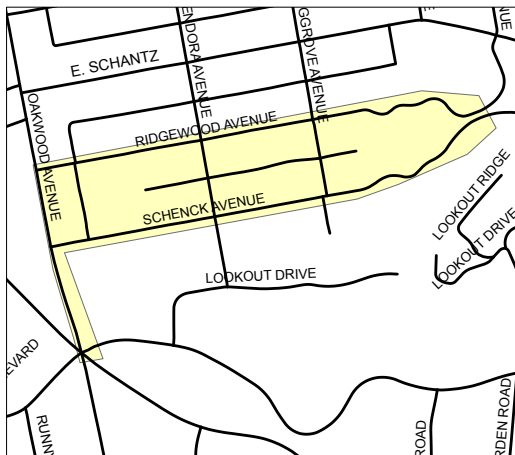
2020 Vectren Gas Line Improvements

Between April and October this year, Vectren will replace underground gas distribution pipes and home service lines in the Oakwood neighborhoods identified in yellow on the maps below. Vectren is installing new polyethylene pipes in place of old steel and cast iron pipes and is moving indoor gas meters to outside wall locations. This is the continuation of a multi-year Vectren infrastructure replacement project in Oakwood. Residents personally affected by the work will receive detailed information from Vectren. 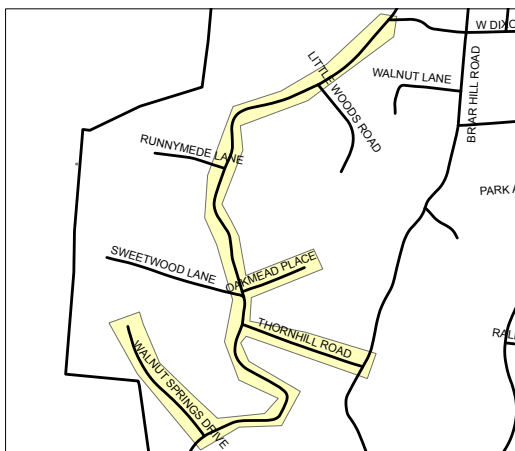
**2020 VECTREN GAS LINE REPLACEMENT

Online Portal for Bill Payment Options

The online billing and payment portal offers more ways to view and pay your utility bill, plus the addition of 24/7 phone payments and pay by text. Residents can receive and view bills electronically, make a payment with credit/debit card or e-check, and choose to go paperless. A quick, one-time payment can be made without registering or you can create an account to enjoy more features like setting up automatic payments, saving payment information for later use, and viewing history. **Visit the City's website for more information.**

Is Your Garage Sale Sign in the Right Spot?

With spring approaching, it is time for garage sale signs to start appearing, so here are a few reminders.

- Signs advertising for a garage sale are permitted at the garage sale location only.
- No directional or lead-in garage sale signs are permitted in the City's right-of-way or on any property that is not the premises of the garage sale.
- Signs in violation of this regulation will be removed.

Garage sales are permitted in residential zoning districts from 8:00 a.m. to sundown on weekdays and Saturdays, and from 9:00 a.m. to sundown on Sundays and holidays. Garage sales do not require a permit, but may only be held for three (3) consecutive days, with a limit of two garage sales in a calendar year.

Spring Crime Prevention Tips

With the warmer weather approaching, the Oakwood Public Safety Department offers a few tips to keep yourself and your home safe during the spring and summer months.

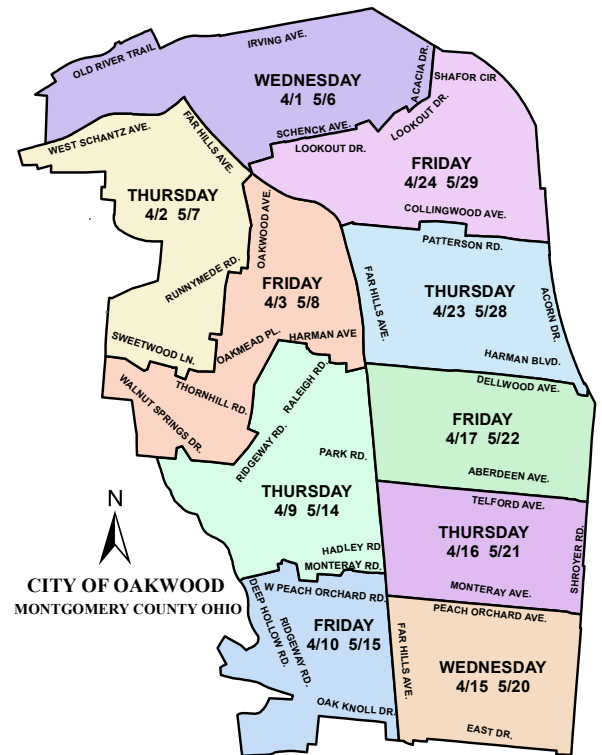
- With the arrival of warm temperatures, many people open windows or sliding glass doors while they are at home. Always remember to close and lock your windows and doors before going to bed or leaving the house.
- Remember to lock any shed, storage unit, or garage you have on your property.
- Be aware of home improvement scams. If you did not solicit the contractor or sales person investigate the company before making the decision to do business with them.
- If a utility representative comes to your house, request identification. True representatives will carry their identification and they will gladly show it to you. *If necessary, contact the company or Oakwood Public Safety Department for verification.*
- Personal property crimes increase during the warmer weather months. Residents have a tendency to leave items such as bicycles, gardening tools, lawnmowers, and other yard tools out in the open. Make sure you lock up your personal property when unattended. It does not take long for someone to quickly take property that has been left in the yard.
- Always remember to roll up your car windows and remove valuables, even if your vehicle is parked in your driveway.
- Being a good neighbor can be one of the best crime prevention tools. If you observe any unusual or suspicious activity, please contact the Oakwood Public Safety Department at (937) 298-2122.

Spring Yard and Garden Cleanup

The City collects yard debris from property frontages monthly from January through September, and bi-weekly from October through December. Refer to the adjacent map for your scheduled pickup days and please plan your work accordingly. Here are a few things to remember:

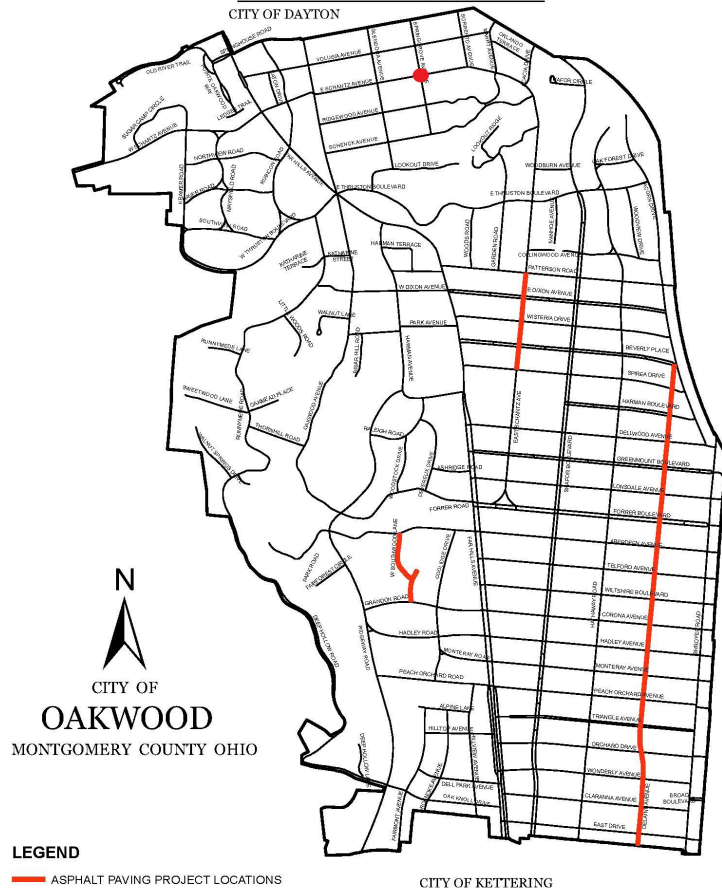
- Place larger piles of yard debris including brush and branches in the tree lawn area just behind the curb. Branches should be no longer than 6 feet and should be placed in manageable piles. Do not place these piles around trees, fire hydrants, cable TV boxes or posts/poles.
- Do not place any yard debris in the street or gutter line, except leaves during the fall leaf collection season.
- Under no circumstance should you place anything except yard debris for pick-up in the tree lawn area.
- The City will not pick up contractor generated yard debris.
- If you have a large amount of yard debris, please call for a free dumpster, but remember that this dumpster must only include yard debris.
- Do not stack loose yard debris around or on top of your garbage cans.
- Grass clippings are not accepted, either with regular trash or curbside yard debris collection, or at the Creager Field drop-off site. Please use a mulching mower or home composting.
- Please remember the 35 gallon and 60 pound limits on trash cans and that all cans must have detachable lids.

2020 Asphalt Repaving

The 2020 asphalt repaving project will take place on the three streets identified on the adjacent map, and also the intersection of Springgrove Avenue and East Schantz Avenue. The City Public Works Department will do some utility work and tree trimming on these streets in advance of the repaving. Property owners on these roadways will receive direct notification from the City regarding the repaving schedule. The repaving project typically takes about one week to complete.

Oakwood Rotary Hazardous Waste Pickup

There are two ways for residents to properly dispose of household hazardous material. Residents may: 1) drop off the material at the Montgomery County Refuse Transfer Station (see www.mcswd.org for more information); or 2) use the quarterly Oakwood Rotary Club Hazardous Waste Collection program. The 2020 collection dates are **Saturday, April 25, Saturday, July 25 and Saturday, October 24**. Call (937) 296-5155 to sign up for the service. It is provided free of charge, but the Oakwood Rotary Club accepts donations. Donations to the "Oakwood Rotary Club Foundation" can be placed in an envelope and left with the items being disposed, or may be mailed to: Oakwood Rotary Club Foundation, PO Box 512, Dayton, OH 45409. All donations support charitable projects and community events led by your Oakwood Rotary!

REFUSE PROGRAM

One of our primary city services is collection and disposal of refuse including household trash, recyclables, bulk items, and green waste. Given the enormous number of trees in Oakwood and the extensive landscaping throughout our city, we generate a very large amount of green waste (yard debris). Roughly 20-25% of the cost to operate our refuse program is related to the green waste collection and disposal. Below are some details about our comprehensive refuse program:

WEEKLY TRASH AND RECYCLABLES COLLECTION

The primary component of our refuse program is the weekly collection and disposal of household trash and co-mingled recyclables. We provide this service via back door collection with a fleet of refuse scooters. These scooters are equipped with two hoppers... one for trash and one for co-mingled recyclables. The materials are then dumped into split-bed refuse trucks. The trash is taken to the Montgomery County Refuse Transfer Station in Moraine. We pay \$38.25 per ton to have the trash transloaded into large refuse haulers and taken to a landfill. The co-mingled recyclables are taken to the Rumpke recycling facility in Dayton. We pay \$30 per ton to drop the recyclables at Rumpke.

CO-MINGLED RECYCLABLES

Plastics, glass, paper, metal cans, and cardboard are to be co-mingled in one or more containers marked as recyclables. All items should be clean and free of food and grease. Please make sure that co-mingled recyclable products are placed loosely in the properly marked container. The items should not be placed in plastic bags. Free "Recyclables" stickers to mark containers are available at City Hall or at the Foell Public Works Center.

It is increasingly important that our co-mingled recycling stream contains only recyclable materials. In years past, the guidance was "when in doubt, throw it in the recycling container". The guidance now is "learn what is recyclable and what is not, but when in doubt, throw it in the regular trash". The success of recycling and the recycling markets is largely dependent on the quality of the recycling stream. There is an industry initiative to "Recycle Right". Please review the guidelines on the City website for details.

CREAGER FIELD GREEN WASTE AND RECYCLING DROP-OFF

We have several drop-off dumpsters at the Creager Field parking lot adjacent to Shafor and Irving (by the Oakwood Dog Park). There are separate containers for cardboard, for co-mingled recyclables (glass, plastics, metal, etc.) and for yard debris. These containers are accessible 24-7. The more green waste and recyclables that we remove from the landfill stream, the cheaper it is to operate our city refuse program.

CARDBOARD RECYCLING

The cardboard from our dumpster containers at Creager Field is taken to a local recycler. Depending on market conditions, we have received up to \$10 per ton for this cardboard. Unfortunately, the current recycling market is poor, and we do not receive any money for the cardboard, nor do we pay anything when we deliver it to the recycler. We encourage our citizens to use the Creager Field cardboard disposal containers as much as possible.

SPECIAL PICKUPS

All Oakwood property owners are entitled to two special pickups per calendar year at no cost. Additional pickups are charged at \$100 each. Special pickups are for large items only (e.g., furniture, appliances, etc.) and can be scheduled by calling (937) 298-0777. If you are a tenant, you must coordinate your special pickups with the property owner. All items must be placed in an open area where the city bucket loader can safely access them, such as driveways away from structures and fences.

REFUSE DUMPSTERS

The City has refuse dumpsters available for use by Oakwood residents on do-it-yourself projects. These dumpsters can be used in two ways:

- For a mixture of items, including such things as home remodeling debris, general household items, and natural materials like dirt, sod and concrete.
- For natural materials only, such as dirt, sod, logs, asphalt and concrete.

Dumpster fees include a base charge of \$100 per dumpster, plus disposal fees, which vary by content material:

- Mixture of items dumpsters incur standard disposal tonnage fees charged by the Montgomery County Refuse Transfer Station. Public Works personnel can provide a general estimate of this cost based on a description of the items to be disposed.
- Natural material dumpsters incur a flat disposal fee of \$53.

FREE DUMPSTERS FOR YARD DEBRIS

If you have a large amount of yard debris (green waste) and would like to use a dumpster for disposing of the material, rather than waiting for the regularly scheduled monthly pickup, please call (937) 298-0777 to request a container drop-off. There is no charge when using dumpsters exclusively for yard debris disposal. Please consider coordinating the dumpster use with your neighbors.

MONTHLY YARD DEBRIS AND REFUSE DROP-OFF

The Foell Public Works Center at 210 Shafor Boulevard is open the first Saturday of every month from 8 a.m. to noon for residents to drop off yard debris and other household waste and recyclables, including large items such as furniture and appliances. If dropping off a refrigerator, freezer, or air conditioner, the Freon must be removed. For large amounts of construction debris, please use the dumpster program. Proof of residency is required, and contractors are not allowed.

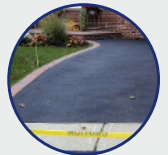
YARD

- Are all weeds and grass less than 8 inches in height?
- Is the yard free from overgrown, uncontrolled vegetation and from tree branches?
- Is the yard free from refuse?
- Are sidewalks clear of plant overgrowth?
- Are all vehicles licensed, operable, and parked on a paved surface?



DRIVEWAY & WALKWAYS

- Are they free of potholes and raveling?
- Are they free from refuse?



PORCHES

- Do the steps, railings, or floorboards need to be repaired or replaced?
- Is it free from refuse?



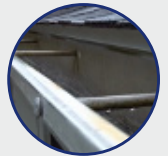
EXTERIOR WALLS & GARAGES

- Do they have any holes or cracks or are they in need of paint?
- Is siding in need of cleaning from algae, mildew, or mold?



GUTTERS & DOWNSPOUTS

- Do they need to be painted or repaired?
- Do they direct water away from the primary building?



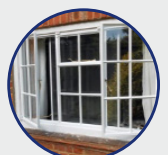
ACCESSORY BUILDINGS (SHEDS, FENCES, ETC.)

- Are fences and shed walls, doors, and roofs in good repair?
- Do sheds or fences need to be painted?



WINDOWS & DOORS

- Are they weather tight and operable?
- Is any glass broken or missing?
- Do the screens need to be repaired or replaced?
- Do the sashes and/or trim need to be repaired or repainted?



OSF Awards Nearly \$11,000 to District in Winter Grants

Oakwood Schools students will have new opportunities and experiences thanks to Oakwood Schools Foundation and its Winter Grant program. The Foundation recently awarded nearly \$11,000 to the schools to provide for programs and equipment that supplements funding by the school district.

“During the Winter Grant cycle, we were able to fund a number of programs that enhance the learning environment for all Oakwood students,” said Jennifer Speed, OSF Grants and Programs Chair. “We are grateful for the opportunity to partner with the community, teachers and school leaders in supporting Oakwood Schools.”

One grant approved this round will provide funding for a workshop for junior and senior high students with acclaimed and award-winning young adult author Chris Crutcher. The workshop will enable students to learn about the writing process and also encourage students to read literature for pleasure.

Another grant will provide an inventory of sensory equipment at Smith Elementary to help increase student learning and focus. By providing differentiated materials, a wide variety of learning styles can be supported, meeting the educational needs of all students.

Also awarded this term is a grant benefiting Oakwood’s youngest learners at Lange School. Through this special education sensory program, students will be empowered to manage bird feeders. All students will benefit from having more interaction with nature, as birds visit the feeders, which will be a focal point of the OakWoods.

Thanks to a grant to purchase solar panels for Oakwood Junior High/



In the fall, OSF provided nearly \$9,000 in grants for projects in the District, including the purchase of a saltwater tank. With the addition of the tank, OHS science students will be able to witness abstract concepts come to life in the classroom.

Oakwood High School, students will see solar energy in action. The solar grid will be installed to power the lighting in the science hallways of the building.

“This installation project will allow us to create a story that can unfold and enrich the STEM experience in junior and senior high school. From energy forms to energy conversions, from wiring to output loads, from the design and construction aspects of the array to careers that take us from sunlight to power, our students will have the opportunity to experience it all,” OHS science teacher Heidi Edwards said.

The Foundation will award a second round of grant money in the fall. Thanks to the generosity of parents, alumni, students, teachers and the community, OSF has awarded more than \$890,000 since 1991.

Pursuing its mission, “Enhancing Excellence in Education,” the Oakwood Schools Foundation provides significant annual support for the quality initiatives, including teacher and administrative grants, scholarships and special wish list items. Foundation Board President Elaine Gounaris said there is avid interest among donors in the myriad programs and resources the library provides.

“There is such a great value in having the library as an anchor in our community,” she said.

Most recently, the Foundation funded a replacement for the deteriorating book drop on Telford Avenue; ongoing small-group technology classes and laptop lab; and the Write@Wright series. In the past, the Foundation has provided grants to purchase the Library’s Book Peddler, a bicycle that allows a librarian to take books into the community; staff continuing education; audio book sets called PlayAways for kids and adults; and a stained glass window by a local artist installed in the north reading room as part of the 2018 historic reading room restoration.

The Foundation is led by a volunteer board. In 2020, the board expanded to 12 members.

“This is partly due to the fact there is a need to include library lovers who have a professional background in outreach, donor sustainability, and community involvement,” Gounaris said.

The new members are Mike Armstrong, Parker Bedsole, Juliet Glaser, and Sarah Kallile. They join returning board members Gounaris, Mark Harman, Kirk Johnsen, Steve Turek, Patty Caruso, Susan Elliott, Julie Teeters, and Elysse Wagner.

The Foundation runs an annual campaign from early summer through December, although donations can be made anytime. Anyone wishing to donate can do so by mail to 1776 Far Hills Avenue Oakwood, OH 45419, in person at the library, or online by visiting wrightlibrary.org/foundation.
