TO AMEND SECTION I, 2022 ORIGINAL APPROPRIATION ORDINANCE NO. 4947 TO PROVIDE FOR THE APPROPRIATION OF:

1. AN ADDITIONAL AMOUNT OF \$150,000 TO BE EXPENDED FROM THE CAPITAL IMPROVEMENT FUND FOR ENGINEERING COSTS RELATED TO THE FAR HILLS STORM SEWER RECONSTRUCTION PROJECT.

FOR THE CITY OF OAKWOOD, STATE OF OHIO, DURING THE FISCAL YEAR ENDING DECEMBER 31, 2022.

WHEREAS, the city's stormwater sewer system is in need of significant improvements in the vicinity of Far Hills Avenue between Dellwood Avenue and Forrer Boulevard; and

WHEREAS, American Rescue Plan Act grant funding is available to assist with construction costs on this capital improvement project, but engineering design work will be paid using local funds; and

WHEREAS, this supplemental appropriation will authorize an additional amount of \$150,000 to be expended from the Capital Improvement Fund for engineering services relating to this capital improvement project;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OAKWOOD, STATE OF OHIO, THAT:

## SECTION I.

To provide for the current expenses and other expenditures of the said city of Oakwood during the period commencing January 1, 2022 and ending December 31, 2022, the following revised sums shall be and they are hereby set aside and appropriated as follows, with added material in **bold** type and deleted material in strike-through type:

Fund Appropriation

309 Capital Improvement Fund \$1,041,250 \$1,191,250

# SECTION II.

The Director of Finance is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by this ordinance of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance.

#### SECTION III.

This ordinance, as an appropriation to meet current expenses of the City, takes effect immediately upon its passage as provided by Section 3.04 of the City Charter.

TO AMEND THE NUMBER OF CITIZEN MEMBERS TO BE APPOINTED TO THE BUDGET REVIEW COMMITTEE FROM EACH OF THE CITY'S VOTING PRECINCTS.				
WHEREAS, on December 30, 2021, the Montgomery County Board of Elections reapportioned voting precincts throughout Montgomery County; and				
WHEREAS, as a result of the reapportionment, Oakwood now consists of eight (8) voting precincts instead of seven (7); and				
WHEREAS, Resolution No. 1333, adopted by this Council on February 3, 1992, established that "(t)he members of the (Budget Review) committee shall be appointed by the City Council with there to be two members from each voting precinct plus such additional members as Council may determine;" and				
WHEREAS, since the adoption of Resolution No. 1715 on February 1, 2010, the Budget Review Committee has been comprised of five (5) members from each voting precinct for a total committee membership of 35; and				
WHEREAS, Council wishes to adjust the composition of the Budget Review Committee consistent with changes to the number of approved Oakwood voting precincts;				
NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF OAKWOOD, MONTGOMERY COUNTY, OHIO, THAT:				
SECTION I. City Council desires that the Budget Review Committee membership be maintained at a minimum of 32 citizens.				
SECTION II.  There shall be a minimum of four (4) citizen committee members appointed from each of the city's eight (8) voting precincts.				
SECTION III. This resolution shall take effect immediately upon its passage.
