# **BUSINESS UPDATE:**

- <u>Backflow Testing</u>: This week, we issued citations to owners of nine residential properties for failing to comply with the EPA mandated annual backflow device testing.
- Blanket Concert: The third and final Smith Gardens summer blanket concert is at 7 p.m. on Sunday. Enclosed is a *Register* article.
- School Crossing Guards: Under our written agreement, the Oakwood Schools have the responsibility for finding adults to serve as crossing guards. So far, the school district has been unable to find anyone to staff the Park Avenue and Far Hills crossing. Enclosed is a DDN article advertising for the open position. Nancy Gill, a former guard who resigned in 2019, has agreed to cover the vacant post through Labor Day.

# Suburban group addressing aggregation amid rising energy rates

#### By Nick Blizzard Staff Writer

Dayton-area south suburbs are set to consider an issue aimed at getting more competitive utility rates for residents and businesses.

Members of the Miami Valley Communications Council plan to address a measure Wednesday that would allow the organization to create electric and natural gas aggregation programs.

The resolution cites "a substantial increase in electric rates paid by residents and small businesses." It also states approval "will increase the effectiveness and ensure competitive, but not necessarily the lowest, market pricing" for participants.

"The more rooftops you can get into a program, the more

competitive pricing you're going to receive," MVCC Executive Director Jay Weiskircher said. "So, we're looking at getting as many rooftops in our program as we can."

If approved by the MVCC, the issue must be voted on by member city councils for municipalities to join, officials said. They include Centerville, Germantown, Kettering, Miamisburg, Moraine, Oakwood, Springboro and West Carrollton.

Kettering is in favor of the MVCC creating aggregation programs for electric and natural gas rates, according to City Manager Mark Schwieterman.

"We have been working with other communities to develop the best plan for our residents while protecting their ability to opt out of the program as they choose," he said in an email.

Aggregation for utility rates has been an issue several area communities have been exploring amid increasing energy rates. Officials in Riverside, Trotwood, Vandalia and West Carrollton have all approved having issues on the November ballot asking voters give those cities authority to create aggregation programs for electricity and/or natural gas, Montgomery County records show.

Aside from West Carrollton, all other MVCC member cities have approved similar ballot issues, Weiskircher said.

Oakwood City Manager Norbert Klopsch said in an email he thinks "there is broad support for MVCC being in the leadership role."

Likewise, Miamisburg City Manager Keith Johnson said he does not "see a problem" with the proposal, but he hasn't discussed the issue with the city's representative on the MVCC board.

Weiskircher said he has had preliminary talks with officials in several northern Dayton suburbs about the MVCC proposal. If approved, those discussions would continue, he said.

July 21-22, Officer Steve Norris attended the ALICE Instructor certification class in Sandusky, Ohio.


Lastly, July 25-29, Officers Rob Wilson and Matt Staley attended the 40 hour CIT course.



# Dorothy Lane Market buys former PNC Bank on Far Hills Ave. for \$1.1M

Dorothy Lane Market recently purchased the former PNC Bank building at 2720 Far Hills Ave. in Oakwood, a real estate broker confirmed.

The grocery bought the former bank branch for \$1.1 million, said Robert Zavakos, senior vice president for commercial real estate firm NAI Global. He declined to comment beyond confirming the sale. Zavakos represented PNC in the sale. The popular grocery store has not said what its plans are for the property.

The building is adjacent to the Dorothy Lane Market store at 2710 Far Hills Ave.

A representative of Montgomery County Auditor Karl Keith said his office had no record of the transaction just yet.

Representatives of Dorothy Lane Market did not respond to messages seeking comment Tuesday.

# DLM purchases Oakwood building for \$1M

One of the most iconic Dayton-area companies may be expanding. Dorothy Lane Market has reportedly purchased the former PNC Bank next to its Oakwood store.

However, the gourmet grocery chain's plans for the property are not immediately known. The 4,000-square-foot building at 2720 Far Hills Avenue sold for \$1.1 million Aug. 2. The bank closed its doors for business Feb. 25 this year and was listed for sale three days later.

Robert Zavakos and Russ Maas from NAI Bergman represented PNC in the disposition, according to Zavakos.

Kent Dimbath, chief financial officer for DLM, declined to comment on the sale at this time.

DLM — known for its deli, soups and Killer Brownies, among other items, — operates three grocery stores in the region: its flagship store in Oakwood, as well as location in Washington Township and Springboro. Most recently, the grocer is embarking on a fourth location south of Dayton in the Warren County community of Mason.

In addition to the stores, DLM operates a culinary center on Far Hills Avenue in Oakwood. Dorothy Lane Market Love Cakes shop resides in Washington Square shopping center, alongside that store.

The company was founded in 1948 by Calvin Mayne and Frank Sakada at the corner of Far Hills Avenue and Dorothy Lane in Oakwood, selling mostly fruits and vegetables and some meat and groceries. The first store opened in 1953, a block from its current location at 2710 Far Hills Ave.




