INSTRUCTIONS

Business entities (corporations, s corporations, partnerships, estates, trusts, etc.) conducting activities or producing income within the City of Oakwood may be required to make estimated tax payments when their tax liability is at least \$200.00. Taxpayers must have 90% of their current year's tax liability or 100% of their previous year's tax liability paid through timely estimated taxes and carryover credits by January 16, 2024 in order to avoid penalty and interest charges.

Due Dates

- Voucher 1, due April 18, 2023
Voucher 2, due June 15, 2023
Voucher 3, due September 15, 2023
Voucher 4, due January 16, 2024

Fiscal year filers should substitute corresponding dates.

Calculation of Estimate

Table with 2 columns: Description and Amount. Rows include Estimated Oakwood taxable income, Oakwood income tax rate (X 2.5%), Estimated Oakwood income tax, Less prior year carryover credits, and Estimated Oakwood tax liability.

Each voucher payment should be 25% of the estimated tax liability.
