- (1) a summary of the unavoidable increases in maintenance and operating expenses;
- (2) a statement of the cost, nature, amortization, and allocation among mobile home spaces of any substantial rehabilitation or capital improvement;
- (3) a summary of the increased cost of the owner's debt service and the date and nature of the sale or refinancing transaction;
- (4) a summary of the owner's net operating income of the preceding twenty-four months and other relevant information that supports the level of rent increase desired.

These documents will be available for inspection at the offices of the City's Housing Manager.

ARBITRATION OF THE PROPOSED INCREASE IS AUTOMATICALLY REQUIRED IN THIS MATTER BY OPERATION OF LAW.

This Arbitration is pursuant to Chapter 6.50 of the Petaluma Municipal Code. https://petaluma.municipal.codes/Code/6.50

A tenant may refuse to pay the proposed increase in rent until a final decision has been reached by an arbitrator. Such refusal to pay shall be a defense in any action brought to recover possession of a Mobile Home space or to collect the rent increase.
