

## SEWER LATERAL REPLACEMENT GRANT

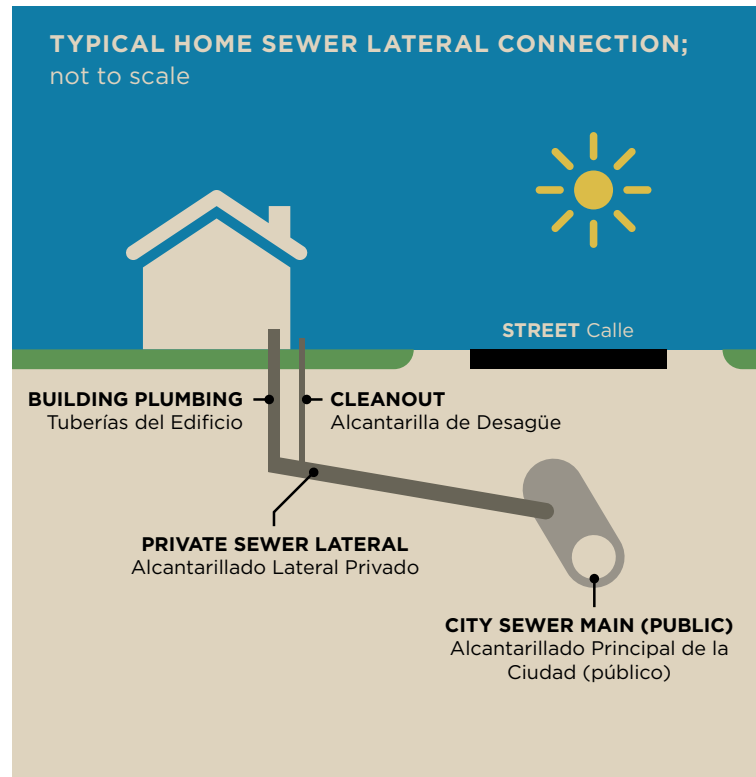
### PROGRAM APPLICATION

Thank you for your interest in the City of Petaluma's Sewer Lateral Replacement Grant (SLRG) program.

As sewer laterals wear down, they allow inflow and infiltration (I&I) to enter the City's sewer collection system. I&I is stormwater that enters the pipe network through deficiencies in the pipeline or illicit connections. Higher I&I eventually overwhelms the wastewater collection system, leading to backups, sewer overflows, and higher pumping costs.

Property owners in Petaluma are responsible for their sewer laterals all the way up to the City's main line, including where the two connect (Ord. 2282 NCS §3 (part), 2007). With this grant, the City aims to partner with qualified residents to help defray costs and encourage timely and needed replacement of aging and worn-down sewer laterals.

The City of Petaluma is currently reviewing SLRG applications for the current fiscal year. These grants are awarded on a first-come, first-served basis, and qualified applicants will be awarded a maximum of \$2,000. The program for the current fiscal year will end on June 30 or when all grant funding has been exhausted—whichever comes first. **Please see application on the following page.**



#### PLEASE BE ADVISED OF THE FOLLOWING:

1. Grant funding will only be allocated to the replacement of both upper (from the home to the sidewalk) and lower (from the sidewalk to the connection to the main) sewer laterals.
2. All sewer lateral replacement work must be completed within the same fiscal year that the application is submitted (some exceptions may be considered).
