- -Physical <u>commercial</u> addresses for new and relocating businesses need to schedule and complete safety inspections with the Building department and the Fire Marshal division. To schedule an appointment, email request to <u>bizcheck@cityofpetaluma.org</u>.
- -Manufacturing and business that have storm water discharge may need a National Pollutant Discharge Elimination System (NPDES) storm water permit (Senate Bill 2015). If your business requires this permit, Ellis Creek staff will contact you if your business requires this permit.

## \* Your Business is a home-based business located within Petaluma city limits

- 1. Obtain a Home Occupation Permit from the Planning department by downloading the form at <a href="https://cityofpetaluma.org/documents/home-occupation-permit-application-form/">https://cityofpetaluma.org/documents/home-occupation-permit-application-form/</a>.
- 2. Once completed email the form to <a href="mailto:petalumaplanning@cityofpetaluma.org">petalumaplanning@cityofpetaluma.org</a>
- 3. After the permit has been approved by planning, follow the New Business Application Process above.

Note: To get a Home Occupation Permit, the location and type of business needs to be approved by the Planning Division and the appropriate fee paid. See permit application for correct price. Fee is also on the Planning Fee Schedule at https://cityofpetaluma.org/documents/planning-fee-schedule/

#### \* Your Business is a short-term vacation rental

This applies to rentals of all or a portion of a dwelling unit for stays less than 30 days.

# **Petaluma Business Certificate Application Instructions and Fees**

Please follow the instructions below to be sure you complete your application fully and correctly. An incomplete or incorrect application could delay your Certificate.

#### **BUSINESS INFORMATION**

#### **BUSINESS PHYSICAL LOCATION**

Your business location is the actual physical business location address. **P.O. Box / mailbox** locations are suitable for a **mailing** address but are **NOT** acceptable as a business location.

## **BUSINESS DESCRIPTION**

A brief description of your business is necessary to classify your business correctly.

## **Ownership Information**

Please indicate your entity type: Sole proprietorship, Partnership, Corporation or Limited Liability Company (LLC). Furnish the name and address of at least one of the owner(s) or corporate officer(s).

## Other Required Information

<u>Tax ID</u> - Every business **must** supply a federal tax ID. This can be your social security number **if** you are the sole owner or husband and wife partnership. If you are incorporated or have employees, you will need a tax ID number from the IRS.

<u>Tax Permit / Resale #</u> - If you are a **wholesale or retail business**, provide your sales tax permit/resale number from the State Board of Equalization in the "CA Dept of Tax and fee admin. Resale Number" field <u>Contractor's License</u> - If you are a **contractor**, enter your required contractor's license number in the "CSLB Number along with the expiration date:

## **FEES**

The business tax is calculated on a percentage of the business' gross receipts within the City of Petaluma for the *previous year*. Calculation is as follows:

Group 1, Retailers, Wholesaler, Administrative Headquarters, Misc. businesses: 0.016% of total Gross Receipts OR \$49.00 whichever is highest Group 2, Contractors, Service Businesses, Rental of Property, Amusement: 0.032% of total Gross Receipts OR \$49.00 whichever is highest Group 3, Professionals: 0.048% of total Gross Receipts OR \$49.00 whichever is highest

- Production Film making \$254.00 per day
- Seasonal Sales \$129 per event
