Meeting Subject: David Best Community Meeting

Summary: On Friday January 25 and Saturday January 26, 2019 the PPAC held 2 community meetings as an opportunity for commissioned artist David Best to share his three Draft Concepts for a site specific art piece on the Lynch Creek Trail at Lakeville Street/Petaluma River. Over the two day event approximately 40 people attended. Mr. Best created 3 concept drawings and posted them on stakes along the Lynch Creek Trail facing Lakeville Street. Further detailed images were hung on a nearby fence. Members of the PPAC provided a table for comment cards; tea and cookies were served. Comments received during the event are included below.
