

NOTICE OF PUBLIC HEARING TO CONSIDER ENERGY SERVICE CONTRACTS WITH FOREFRONT POWER

NOTICE IS HEREBY GIVEN that on June 15, 2020, or as soon thereafter as practicable, at a regularly scheduled public meeting of the City Council of the City of Petaluma, which will be conducted through teleconference, the Council will consider entering into energy service contracts with ForeFront Power, for the installation of certain energy savings measures on the property of the City. At said meeting, the Council will hold a public hearing on and consider a resolution to adopt findings required by Government Code section 4217.12 regarding anticipated energy cost savings and other benefits the City may receive if the Council decides to enter into the energy service contracts. The resolution, agreement and supporting documents will be included with the Council's regular public agenda for the June 15, 2020 meeting.

PROJECT DESCRIPTION: The project may include installation of photovoltaic energy systems at the following locations:

- 1) Petaluma Airport, 601 Sky Ranch Drive
- 2) Petaluma Community Center, 320 North McDowell Boulevard
- 3) Petaluma Police Department, 969 Petaluma Boulevard North
- 4) Petaluma Swim Center, 900 East Washington Street

WHAT WILL HAPPEN: The City Council will consider all public testimony and decide whether to enter into energy service contracts with Forefront Power to purchase electricity generated from the four installations, at specified rates, for twenty years.

HOW TO OBSERVE AND PARTICIPATE: Members of the Public may participate and provide public comments to teleconference meetings as follows:

- Written public comments may be submitted to cityclerk@cityofpetaluma.org up to 2 hours prior to the meeting start (June 15, 2020 at 6:45 pm). These public comments will be provided to the City Council and uploaded onto the City's website in advance of the meeting.
- Oral public comments will be accepted through the teleconference meeting only. To address the City Council during the live meeting, please find the meeting-specific link to the Zoom meeting included on the agenda for the June 15, 2020 City Council meeting that will be posted on the City's website.
- All City Council meetings are televised via Petaluma Community Access broadcasts on Comcast and Petaluma's local channels 26, 27, and 28. With AT&T U-Verse, PCA's channels are accessible through channel 099. Local channels are not currently available on Satellite/DISH Networks.
