## CALGREEN BUILDING DESIGN AND CONSTRUCTION VERIFICATION

The City of Petaluma has adopted California Green Building Standards Code (CalGreen) at the Tier 1 level for all wholly new buildings. This includes all occupancy classifications, conditioned or not. The Tier 1 Energy provisions (A4.2 and A5.2) are NOT adopted. Energy Efficiency is required at the mandatory level only.

[Petaluma Municipal Code 17.04.010]

CalGreen is applicable to all new buildings and first tenants in a core and shell project, at the Tier 1 level. Nonresidential additions of 1000 square feet or greater and alterations of \$200,000 valuation or greater require compliance at the mandatory level. [CalGreen 301.3]

CalGreen mandatory provisions are applicable to residential projects where the addition or alteration increases the buildings conditioned area.

The City has no checklist and recommends using those in the California Green Building Code or on the state websites. The plans must be consistent with the checklist requirements. Please do not use other jurisdiction checklists that may have different requirements. CalGreen compliance and energy compliance must be incorporated into the plans. A convenient checklist can be found in the most recent edition of the code book.

The Building Standards Commission and the Housing and Community Development websites contain checklists as part of the code that can be utilized in the plan sets for scoping compliance.
