

Response #4: Yes. The "weakened plane" may be established with soff-cut / saw-cutting provided depth, width and frequency, etc. requirements are upheld.

SPECIAL PROVISIONS - ADDITION:

3.6a <u>PROJECT AND CONSTRUCTION AREA SIGNS</u> – Project sign and construction area signs shall be furnished, installed, maintained, and removed when no longer required in accordance with the provisions in Section 12, "Construction Area Traffic Control Devices", of the Standard Specifications.

Three (3) project signs with a minimum dimension of 24" X 36", scaled appropriately and secured to an A-frame barricade or appropriate mount shall be furnished, installed and moved from site to site by the Contractor, at locations approved by the ENGINEER. Letters and numbers shall be black on a white background. The sign information shall be as shown below:



The signs shall be approved prior to fabrication and posted as directed by the Engineer.

Construction area signs will be installed prior to start of construction and maintained in place for the duration of the project by the CONTRACTOR. Signs shall be repaired or replaced at no cost to the City of Petaluma, if damaged or stolen. The CONTRACTOR shall remove the signs and posts at the completion of the project and with prior approval of the ENGINEER.

All costs involved in purchasing and installing construction area and project signs shall be considered as included in the Lump Sum price paid for **Mobilization**.

All other items of the documents shall remain unchanged. A signed copy of this Addendum and the attached acknowledgement form shall be attached to the bid proposal. Failure to do so may cause rejection of your bid as being non-responsive.

Bids will be emailed into the City Clerk, and original copies of the sealed bids will be mailed in.
