PROJECT DESCRIPTION: A joint application has been submitted by Steve Abbs of Davidon Homes and Greg Colvin with Kelly Creek Protection Project for the Scott Ranch Project, including a residential subdivision of 28 single family residential parcels and associated private open space on approximately 11.4 acres adjacent to Windsor Drive and a public park component to create an approximately 47 acre extension of Helen Putnam Regional Park. The requested entitlements include a General Plan Amendment, Zoning Map Amendment, Zoning Text Amendment, and a Vesting Tentative Subdivision Map. An Environmental Impact Report has been prepared for the Project in accordance with the California Environmental Quality Act. The City Council will consider and take final action on the project entitlements and certification of the Final EIR and including consideration of the recommendations from the Planning Commission. Subsequent entitlements anticipated for the project include Site Plan and Architectural Review for both the residential component and Phase 1 park improvements, Local Landmark Designation for the red barn complex, Historic Site Plan and Architectural Review for the renovation of the barn complex, and a Tentative Parcel Map for purposes of transferring Parcel B to Kelly Creek Protection Project prior to final map.

CALIFORNIA ENVIRONMENTAL QUALITY ACT: An Environmental Impact Report has been prepared for the Project consistent with the California Environmental Quality Act (CEQA). City Council will consider the Final EIR (FEIR) for certification. The FEIR is available online with project information at www.cityofpetaluma.org/scott-ranch/
